FIRE AT SCHOOL BUILDING

Students panic, fall sick

A fire broke out at a room on the 9th floor of a 12-storey building of a school in the capital's Malibagh yesterday, creating panic among students, teachers and guard-

At least 10 students of South Point School and College fell sick while rushing downstairs from the different floors after the school authorities switched off the power supply following the fire around 8:50am.

Black fumes were seen billowing out of a room on the

9th floor, said witnesses.

"While sitting for an examination at the top floor of the building, we heard fire screams and saw black fumes emitting from the 9th floor," said a student.

"As we started coming out of the room, within a few minutes the power went off and we started climbing down through the stairs amid darkness," she told The Daily Star.

Fire service and civil defence officials said the school authorities put off the blaze before they reached the spot. The reason behind the fire could not be ascertained.

Visiting the spot, Rampura Police Station Officer-in-Charge Delwar Hossain said the fire damaged a drape of window and two electric bulbs.

A number of students fell sick while climbing downstairs amid panic, he told The Daily Star. Guardians of the students staged a demonstration in front of the school.



Muggers hack worker to death

The police said they found a cellphone and Tk 2,600 in the victim's pocket.

DANDY DYEING CASE Tarique, Koko to face court by Feb 26

A Dhaka court yesterday again summoned BNP Senior Vice Chairman Tarique Rahman and eight other directors of Dandy Dyeing Ltd, and two others to it by February 26 in a case filed for defaulting on a loan payment of Tk 45.49 crore.

The court also asked the court authorities to publish an advertisement in the daily Prothom Alo and the daily Inqilab asking them to appear before it.

Judge Md Rabiuzzamar of the Artharin Adalat-1 passed the order after all the earlier notices upon the defendants could not be served as none at their respective addresses received those. Earlier on October 23 last year, the same court issued the

summons. The ten other defendants are Arafat Rahman Koko; Giasuddin Al-Mamun and his wife Shahina Yasmine; Nasrin Iskander, wife of late Sayeed Iskander; Shams Iskander; Shafin Iskander; Sumaiya Iskander; Kazi Galib Abdus Sattar; Shamsunnahar, wife of another director late Mozaffar Ahmed; and

their son Masud Hassan. On October 2 last year, Sonali Bank Ltd filed the case against the eleven, including Tarique, Koko, after their company failed to pay off the principal loan plus interest, accumulated over the last 11 years, totalling Tk 45.49

The company had borrowed Tk 12.16 crore from the bank's principal office in the capital on October 16, 2001, said the case statement.

Six Adivasi children for arson attempt rescued

A group of indigenous students of Dhaka University on Sunday rescued six Adivasi children, thought to be sent to different madrasas in Dhaka city and its outskirts, from a residential hotel of the capital's Fakirapool area. The rescuers captured one Binoy

Tripura, who brought the kids of Tripura community aged 5-12 from Chimbuk Hills in Bandarban. Binoy took 19 children from Bandarban

promising their parents that they would be sent to Christian Missionaries for education. He started for Dhaka on Saturday, left 13 kids at Chakaria en route, and reached Dhaka with the six, said Mukul Tripura, a rescuer. "Binoy has confessed to us that he was

about to send the children to different

madrasas in Dhaka and its outskirts." He did it for money, Mukul told The Daily Star. The rescued children have been sent to

a Christian Missionary in Bandarban.

They will be handed over to their parents. The 13 other children have also been taken to Bandarban from Chakaria, said "We have kept Binoy in our supervision

in Dhaka...his parents will come to Dhaka tomorrow (today). Then we will decide further action against him," he said.

Earlier police rescued 16 indigenous children from a madrasa, mosque and non-government Islamic organisation on January 2 and 11 others from different madrasas in Dhaka in August last year. They were allegedly converted to Muslims and given Islamic education.

RMG worker held

Police arrested a worker of an export-oriented garment factory for allegedly trying to set fire to his workplace at sadar upazila of Narayanganj district yesterday.

The arrestee, Habibur Rahman, 22, was employed at the factory, Navy Hosiery Pvt Ltd, in Panchabati BISIC Industrial Area only two days ago. He is a resident of Muslim Nagar area under Fatullah and hails from Patuakhali district.

The factory's Manager Malek Hazi Mohammad said Habibur set fire to clothes on the seveth floor of the factory after the afternoon lunch break.

However, other workers saw the fire and quickly doused it with fire extinguishers while Habibur made a quick getaway, he said.

Later, the factory authority, with assistance from other

workers, caught Habibur from a Patuakhali-bound launch at Fatullah Launch terminal and handed him over to police. Acting Officer-in-Charge Akther Hossain of Fatullah Model Police Station said, "We are investigating the

The factory's owner is the elder brother of Bangladesh Knitwear Manufacturers & Exporters Association Vice-President Mohammad Hatem.

ARMED AL CADRES BEFORE LAWMAKER

Police yet to take action Wadud denies involvement of his men

Police is yet to take legal action against alleged Awami League cadres who brandished lethal weapons in Rajshahi's Puthia upazila on Sunday while escorting the local lawmaker following an intra-party clash.

"Police were not there so the men could not be identified. Whether they were Awami League cadres can not be said for sure but they were not locals," said Officer-in-Charge Abdus Salam of Puthia Police Station.

No complaint was filed after the clash, he added.

Photographs published in Prothom Alo yesterday showed the men escorting the vehicle of lawmaker Quazi Abdul Wadud Dara of Rajshahi-5 (Puthia-Durgapur) constituency in Puthia Bazar.

Earlier that day, 10 people were injured in an "attack" by the men on a group led by a former president of Rajshahi unit

Bangladesh Chhatra League, GM Hira Bachchu.

Hira said a council at Biraldaha College in the morning to form two AL committees of Puthia municipality and union units was postponed at noon following a dispute.

However, Wadud unilaterally announced the committees, leading to protests and the attack, he said.

"Filing a case over the attack requires for me to accuse the lawmaker. Why will I do so when we are from the same party," said Hira, adding that he did not recognise the armed men.

Wadud said, "Nothing big occurred. It was just a misunderstanding among us...none of my party men showed arms before me. If I had seen so, I would have expelled him."

Hira and Wadud's groups sat together at the college yesterday but the former's group left soon protesting Wadud's unilateral decisions, said party insiders.

National Human Rights Commission Chairman Prof Mizanur Rahman yesterday said no person will be discriminated on the basis of their sexual orientation.


