Baby dies while father beats up mother

A four-month-old infant, who was in his mother's lap, died as he was allegedly hit on the head while his father was beating his mother with a stick.

The incident occurred at West Rajapur village of Sarankhola upazila in

Bagerhat yesterday morning. The injured boy, Sumon Faquir, was declared dead at Bagerhat Sadar Hospital.

Police arrested Sumon's father Rubel Faquir of the village from Bagerhat Bus Terminal around noon.

Rubel was fleeing with the body wrapped in a jacket after abandoning his wife Masuma Akter at the hospital where she was also admitted with a leg fracture allegedly from the beating, said police.

DHAKA PUBLIC COLLEGE CAMPUS Students riot

protesting relocation

Several hundred students of Dhaka Public College took to the streets yesterday vandalising cars and shops in Panthapath of the capital protesting its authorities' decision of relocating the campus.

Witnesses said police charged baton and fired eight rounds of rubber bullets and six tear gas canisters to disperse the agitators. A student was injured in the clash.

Injured Golam Kibria Asif, 17, was shifted to Dhaka Medical College Hospital (DMCH) from a private hospital with bullet wounds in his leg.

The students also blockaded the road in Panthapath for about an hour.

Enamul Haque, officer-in-charge of Kolabagan Police Station, said some teachers of the college were in favour of the college relocation while others have been opposing it. He said a number of students were agitating yesterday

protesting the decision for campus relocation. "They [students] took to the streets at 11:00am and vandalised about ten cars," said Enamul Haque.

Asif, however, told reporters at DMCH that they were trying to form a human chain in front of Bashundhara City shopping complex when policemen swooped upon them.

6 rapists get life

The convicts are Abul Kalam, Akteruzzaman, Ayub Ali, Belayet Hossain, Salahuddin and Mujibur Rahman. All of them, except Mujibur, remained absconding. Judge Md Rezaul Karim of Women and Children

Repression Prevention Tribunal-1 gave the verdict yesterday. According to the prosecution, the six convicts kidnapped the female garment worker while she was going

to visit a friend in Burma Colony of Chittagong city on April 8, 1998. They took the girl to a nearby hill and gang-raped her.

Later, they left her in the colony area. The victim lodged a case with Panchlaish Police

Station in this regard the next day. Police submitted charge-sheet against the six on

August 28, 1998 and a Chittagong court framed charges against them on June 16, 1999.

staff, logistics crisis TAREK MAHMUD, Ctg The Department of Narcotics Control (DNC) conducted 1,659 drives in Superintendent Chowdhury Imrul Chittagong city in 2011. The number of raids was 1,468 last year. The slump in the intensity of the anti-drug agency's operations is largely blamed for understaffing and lack of logistics.

There are only 23 officials to check drug smuggling and abuse in a city of 50 lakh people when most of them have to attend courts in drug-related cases in other parts of the country. Shidweshar Teli, a superintendent of

DNC, Chittagong city, said he was a plaintiff as well as investigation officer of around 500 cases pending with different courts across the country. "Before coming in Chittagong,

worked in Khulna and Jessore. So I have to spend most of the time there to attend courts, disrupting my regular job here," he told The Daily Star. Sources said two of the three superin-

tendents overseeing the department's activities under a deputy director in the city had to spend most of a month attending courts. The understaffed DNC Chittagong city

office now depends on other law enforcement agencies to conduct drives. On their unavailability, it has to suspend operations.

DNC (Chittagong city) is split into six circles where at least a hundred officials are required to ensure smooth functioning. But it has got only 41 sanctioned posts and worse yet, 18 of the posts are remaining vacant.

The vacant posts also include those of three sub-inspectors, six sepoys, two assistant sub-inspectors, one prosecutor, two office assistants, one stenographer and one MLSS.

The department has other challenges

to face--it has just one vehicle and that too is rundown. The officials said they were unarmed and not given risk allowance.

Hasan said the officials did not get risk allowance even if they were doing the job of law enforcing. "Without arms and other security facilities, we have to work against desperate drug smugglers who use modern firearms."

The officials raised the issue of food rationing, which other forces enjoy but they do not, and that of the poor state of the Chittagong office's infrastructure.

Deputy Director of DNC (Chittagong city) Mukul Jyoti Chakma said, "The DNC was founded in 1990. After that, many forces like Rapid Action Battalion (Rab), Coast Guard were created and they are enjoying better facilities than us."

Anwar Hossain, inspector of Pahartali circle of the DNC, said, "We not only work to arrest drug smugglers and peddlers but do other narcotics related duties of the state."

According to its website, the department, apart from controlling smuggling, sale and abuse of narcotics, treats and rehabilitates drug abusers, co-ordinates activities of different government agencies and NGOs offering treatment and rehabilitation for addicts, and maintains liaison with similar agencies in other countries.

DD Mukul said a proposal for boosting the capacity of the Chittagong city office was submitted in the DNC head office some three years ago, but it was pending to date.

Additional Director of DNC (Chittagong Division) Khushi Mohan Bishwash said the scenario was same in other parts of the country. "The recruitment process for the vacant posts is under way and the upgradation proposal is under consideration."

CASE AGAINST HUSBAND

Woman's body exhumed over murder suspicion

Four months past the burial, a housewife's body was exhumed from the capital's Azimpur Graveyard yesterday over a Dhaka court order on a case accusing the

husband of murder. Nurul Amin, brother of the deceased Rehana Begum, 28, alleged that the absconding husband, Sayed Ahmad, killed Rehana for failing to grab an around Tk one crore-worth one-story building on

a three katha plot at Kamrangir Char. Rehana's family gave her the property during her marriage in 2010. The couple used to depend on the building's rent as Syed, who claimed to be a garment factory supervisor during the marriage, was

unemployed, he said. Some one and a half months before the murder, Sayed tried to convince Rehana into selling the property, saying

that they would be able to start a business

and live in a very good flat.

bed, he said.

Sayed even brought buyers willing to pay Tk 90 lakh for the property but with her family not consenting to it, the couple started having rows, said Nurul.

After a quarrel on September 28 last year, Rehana told her mother Rezia Begum to come over to her house. Rezia did so and assured to take her away to her

parent's house the next day, he said. The following day, after knocking for a long time, Sayed opened the door. Inside, Rezia found Rehana unconscious on a

Sayed and a neighbour, Maleka Begum, took Rehana to Dhaka Medical College Hospital where doctors declared her dead. Within a few hours, they buried the body without any autopsy or informing police, added Nurul.

On October 10, Rezia filed the case with a Dhaka court seeking permission to exhume the body. in January last year and is currently in jail.

2 held with stolen luggage at airport

Airport Armed Police Battalion (AAPBn) yesterday arrested two members of a gang which carries out organised theft of passengers' luggage at Shahjalal International Airport in the capital.

Police also recovered three pieces of stolen luggage from the two arrestees -- Shah Alam, 37, and Md Abdul Hannan alias Mannan, 40.

Quoting the arrestees, police said Shah Alam, using passport of one Nazrul Islam, entered the area where luggage is collected. He then used a security-check pass from the lost and found department to go near conveyor belt no. 3, where passengers of Turkish Airways were collecting their luggage.

Shah Alam collected three pieces of luggage and left the airport, they added.

On information, AAPBn personnel followed him and made the arrest in Airport Golchattar, where Shah Alam was handing over the luggage to Hannan. Both arrestees admitted that they take the stolen bags

to a residential hotel in the capital where members of the gang meet with their "collections", said police. Shah Alam is brother-in-law of the gang's leader Zoynal Abedin. Zoynal was arrested with stolen luggage Money back Guarantee within 7-8 years.
