Kamol was summoned as Hall Mark Managing Director Tanvir Mahmud in his confessional statement admitted that Kamol received Tk 3 crore as bribe to facilitate him (Tanvir) in availing the loan, said an ACC high official.

## Rohingyas still using Schoolgirl raped by Bangladeshi passport

Eight arrested at Shahjalal airport

Rohingyas have continued their frantic efforts to travel abroad with fake or genuine Bangladeshi passports and documents.

Armed Police Battalion (APBn) and immigration police on Monday night arrested eight such Rohingyas, including two females, at Shahjalal International Airport in Dhaka.

They were trying to go to Kuwait and Malaysia, pasting their photographs on valid passports.

ABM Atiqur Rahman, senior assistant superintendent of the APBn, said the force arrested 50 Rohingyas at the airport last year. The number of arrests was six last month, he added.

Once abroad, a number of Rohingyas

commit different kinds of crime, tarnishing the image of Bangladesh. The problem has remained unaddressed for a long

Police sources said they caught six of the Rohingyas in the transit point of the immigration terminal area around 5:00pm. They were to go to Kuwait.

The six arrested men are Noor Alam, 26, Zaber, 32, Ilias, 20, Md Rafique, 32, Shahidul Amin, 20, and Faruque, 22. ASP Atiqur said they admitted that they gave a broker handsome amounts of money for arranging the passports with fake photographs.

The two Rohingya women--Saleha Khatun, 23, and Yasmin Begum, 19--were arrested at a check-in row. They tried to travel to Malaysia.

### trucker, 3 cohorts Victim rescued from resort

Police rescued a 15-year-old rape victim from Emang Resort and Restaurant in Alutila tourist area in Sadar upazila of Khagrachhari yesterday.

She was taken to Chittagong Medical College Hospital after receiving first aid from Khagrachhari Adhunik Sadar Hospital, said hospital sources.

The victim's family said on Monday, a truck driver and his three associates picked up the schoolgirl from College Gate area in Ramgarh upazila of the district where she was waiting for a bus to go to her relative's house. They then took her to the resort and with assistance from the hotel's manager raped her.

The girl tried to escape by jumping from the second floor balcony and injured herself yesterday morning.

However, the perpetrators caught her and locked her up in one of the rooms. Hearing her shouts, locals informed police who rescued her at about 12:30pm. The criminals managed to flee the scene, said police.

Mostafizur Rahman, OC of Khagrachhari Police Station, said they arrested the night guard of the resort, Rahul Tripura, 30. A case was filed in this connection.

#### ICT asks for progress report on charges against Azharul

**International Crimes** Tribunal-1 yesterday asked the prosecution to submit a progress report to it on March 13 on the ongoing investigation or formal charges against the war crimes suspect, ATM Azharul Islam.

The three-member tribunal led by Justice ATM Fazle Kabir gave the order following prosecution's prayer for time extension. Tribunal-1 also allowed prosecution's another petition on quizzing Azhar at safe home.

Justice Kabir said the investigation agency would have to quiz him at safe home on a day among the next ten days beginning from yesterday.

A defence counsel is allowed to be present during the interrogation. The tribunal asked the investigation agency to inform the defence in advance. Defence counsel for the

war crimes suspects, Ghulam Azam and Motiur Rahman Nizami, yesterday prayed to the tribunal for adjourning the day's proceedings, as the conducting lawyer and the defence witness could not attend the tribunal due to hartal.

The tribunal granted their prayers and adjourned Ghulam Azam's case until today and Nizami's case until February 7.

The three Jamaat-e-Islami leaders are facing trial on charges of crimes against humanity during the country's Liberation War in 1971.

### PADMA GRAFT CONSPIRACY 2 officials get bail

A Dhaka court yesterday granted bail to former secretary of Bridges Division Mosharraf Hossain Bhuiyan and Superintendent Engineer of Bangladesh Bridge Authority Kazi Mohammad Ferdous in the Padma bridge graft case.

Judge Md Zohurul Haque of Senior Special Judge's Court passed the order after the duo's lawyer submitted a petition seeking bail against the rejection order of a lower court.

The Chief Metropolitan Magistrate's Court of Dhaka on January 15 had rejected their bail petition.

In the order, the judge said Mosharraf is an exsecretary while Ferdous is a superintendent engineer and they have high social status. They will not flee if granted bail in the case. Therefore, the two arrestees are granted bail on a bond of Tk 10,000 with two guarantors.

On December 17 last year, the Anti-Corruption Commission filed the case with Banani Police Station against seven people, including the two, for conspiring to commit bribery in the Padma bridge project.

An ACC team led by its Director Mohammad Tahidul Islam arrested the duo in front of the National Museum at Shahbagh on December 26.

The two were placed on seven days' remand the following day.

#### DoE fines 5 factories for pollution

The Department of Environment (DoE) on Monday fined five factories around Tk 77 lakh at Ashulia and Savar on the outskirts of the capital for polluting environment.

The factories are Al-Muslim Washing Ltd, Anlima Textile Mills Ltd, Surma Garments Ltd (Dyeing and Knitting), Pearls and Pouch Ltd and Laundry Industries Ltd, said a DoE statement.

A DoE team found that the factories were polluting the Bongshi river and the Turag river by discharging waste.

Md Alamgir, DoE director (enforcement), summoned the representatives of the industries to its Dhaka office and fined them.

### ABU DHABI ROAD ACCIDENT

### 18 Bangladeshis identified

The Bangladesh Mission in Abu Dhabi in UAE has identified 18 Bangladeshis among the 22 workers who died in a tragic road accident on Sunday in the middle-eastern country.

The foreign ministry has published a list of the deceased Bangladeshis. Dr Zafar Ahmed Khan, secretary at

the Ministry of Expatriates' Welfare and Overseas Employment, told The Daily Star that they were working with local authorities and the Bangladeshi embassy there to ensure that the deceased workers' family receive proper compensation. "If they were working legally there,

the families are entitled to compensation," he confirmed.

He added that the government would give Tk 2 lakh to each victim's family along with money for burial purposes.
