8 devices used for detonating explosives stolen from store

At least eight electronic devices meant for detonating explosives have been stolen from the highly secured storehouse of Madhyapara Granite Mining Company Ltd (MGMCL) in Phulbari upazila under the district.

At around 11:30am yesterday, the officials and staff who went to the storehouse called 'Permanent Magazine House' found its locks broken and they informed Md Abdul Latif, security in charge of the mine.

Sources said that the warehouse Located around two kilometres from the administrative building of MGMCL, the storehouse has three rooms to contain the highly power-

ful explosives that are used to break MGMCL. underground rocks for extraction.

There were 72,510 pieces of electric detonable copper cable, 5,287 pieces of non-electric detonators (8 to 17 metre in length), 9,835kg 25MM diameter explosives, 12,375kg of 50MM diameter explosives, 1,58,565 metres of detonator cord and 66,200kg of ammonium nitrate in the stock till Monday, said Rafiqul Islam, manager (Store) of MGMCL.

Shortly after the incident, MGMCL Managing Director Md Moinul Islam formed a threemember probe committee led by Mir Mohammad Abdul Hannan, general manager (Marketing) of

The committee, also comprising deputy general managers Md Asaduzzaman and Said Rafiqul Islam, was asked to count the items in the store and submit their report by 4:00pm yesterday.

By evening, they detected that at least eight electronic devices went missing from the store.

However, counting of the large amount of items, including explosives, was taking much longer time, Md Asaduzzaman told this correspondent yesterday evening.

The committee has also been asked to file a report on security arrangement of the mine area within two days.

Around 80 Ansar members per-

form duty under Md Abdul Latif, the security in charge, to ensure the safety of the mine and the surrounding area.

Md Moinul Islam, superintendent of police of Dinajpur, who visited the warehouse area yesterday afternoon, told this correspondent, "The warehouse is surrounded by a barbed wire and a mud wall. As the two-layer security measure has remained intact, it is clear that the incident took place with help of a section of mine officials and staff."

When contacted, Md Abdul Latif confirmed the incident of breaking of locks of the warehouse but he did not elaborate on the matter.

Mother's death follows rape of college girl

Teachers and students accompanied by locals formed a human chain on Lalmonirhat-Mogholhat road at Durakuti village in Lalmonirhat Sadar upazila yesterday, demanding punishment to the criminals responsible for rape of a college girl on Saturday and death of her mother on Monday.

The girl, an HSC first year student of a local college, was raped at a house of Durakuti village in Sadar upazila on Saturday, and police arrested the alleged rapist Abdus Sattar, 38, a truck driver, and his alleged abettor Nazma Begum, 28, both residents of the village, on Sunday.

The victims' mother died of a heart attack at her home on Monday noon as the woman, already afflicted with the brutality on her daughter, received continued threat by rapist's relatives, Amirul Hayat Mukul, principal of the college, said at the human chain yesterday.

"The victim college girl and her younger brother, a class seven student, got fainted several times after the death of their mother," said Habibur Rahman Habib, chairman of Mogholhat union parishad.

The victim girl's father, a day labourer, who took part in the human chain, showed all signs of despair. "My late wife, also working as a day

labourer, faced all the hardship with a smiling face as she hoped to see our daughter and son educated. But tragedy has befallen our family, making me utterly frustrated," he

Lalmonirhat Sadar police station OC Jamir Uddin said, after post mortem police handed over the deceased woman's body to her relatives and it was cremated at the local shwashan (crematory) in the village yesterday noon.

"Police have already identified all the criminals whose threat led to the death of the raped girl's mother. We hope to arrest them soon," he added.

Dredgers continue sand extraction from the Jamuna River near the Bangbandhu Bridge, posing threat to the country's

Sand lifting from Jamuna riverbed close to the Bangabandhu Bridge is posing a threat to the country's largest bridge.

Several villages have been facing serious erosion while large shoals emerged in the river due to the mindless act.

Powerful dredgers have been engaged to lift sand allegedly on verbal permission from the bridge authorities, sources said.

The unplanned sand lifting by some influential people goes on unabated due to their links with political parties as well as public representatives, they said.

During a visit to the area recently, this correspondent saw at least eight powerful dredgers engaged in lifting sand randomly from a very close point of the east side of guide embankment.

Sand lifting was also seen at Gabsara, Khanurbari, Baintain, Madhur Bari, Kornogati areas of the river between Bhuapur upazila in Tangail and Sadar upazila in Sirajganj.

Rafiq Talukder, one of the dredger owners, told this correspondent that they started lifting sand from the area after taking permission from the Bangabandhu Bridge approach road. bridge authorities.

The villages on the east side of the bridge were facing serious erosion while large shoals emerged on the west side, threatening to change the river course to the east, victims said.

Anwar Hossain of the erosion affected Kukadair village in Bhuapur said that the dredgers enter the ablindeyetoit, Anwarsaid. restricted area at night and leave locations before day break.

He alleged that a large portion of his house was devoured by the river a few days ago as erosion was continuing at villages on the north eastern side of the bridge due the unplanned sand lifting.

Most of the lifted sand is transported by giant cargos and engine boats to eight sand selling points only five kilometers away from the Bangabandhu bridge.

Later hundreds of trucks take the

sand to different areas of the country through Jokarchar-Tarakandi flood control embankment-cum-road and

Movement of the hundreds of sandladen boats and trucks creates problem for the waterways while damages the embankment and road.

Although the sand traders have been doing a brisk business in these vital areas of the bridge for last several years, the authorities concerned seem to turn

Contacted, Abul Kalam Azad, an assistant engineer of Bangladesh Bridge Authorities (BBA) at Bangabandhu Bridge site, refuted the allegation of giving verbal permission to anybody to lift sand from near the bridge.

"We do not allow this within 1.2 kilometer of the bridge," he said.

There is no chance of change in river course as a big shoal has already emerged near the east side of guide embankment, he observed.

Russel had been suffering from severe headache for a few months and that day he along with his father visited a doctor.

On the way back, they boarded a bus and sat together on the rear seats.

"When the bus was se ablaze, both of us kept our hands tied and tried to get down. At one stage, other passengers pushed us so hard that we got separated, said Saiful, who also suf fered burns in the arson.

"I could not see anything due to huge smoke. My body caught fire. I broke a window glass and jumped out."

Saiful then screamed for help to save his son. By the time fire service personnel came and put out the fire, Russel's fate was decided.

"Firemen pulled out a charred body and that was my son," Saiful said, bursting into tears. He had identified his son

by the belt. The family members had

been suspecting that Russel had brain tumour, said his wife Farzana Mahmud Tonni. "The medical report was

supposed to come today [yesterday] but now it is no longer needed," Tonni sighed. The couple has a

baby aged about two months.

Russel was buried at a graveyard in Nadda Para of Dhakkhin Khan yesterday afternoon.

Post and Telecommunications Minister Sahara Khatun, State Minister for Home Shamsul Haque Tuku and LGRD State Minister Jahangir Kabir Nanok, among others, visited the victim's house at Nadda Para.

Tuku assured the family that the government would punish the criminals immediately.

Uttara police filed a murder case against 94 Jamaat-Shibir and BNP men, naming former Jatiyatabadi Chhatra Da president Azizul Bari Helal as the prime accused.

None was arrested until filing of this report around 7:30pm yesterday.

In Bahaddarhat intersection, over 2,000 Jamaat-Shibir men wielding guns brought out a militant procession around 1:00pm. They went on the rampage smashing shops and torching at least 20 vehicles.
