#### Wood trader murdered

A wood trader was hacked to death by criminals at Durgum Uttar Gabchhari in Dighinala upazila early Tuesday. The deceased was identified as Amar Bikash Chakma alias Kalaia, 35, son of late Bimal Chandra Karbari of the area. Victim's mother Nanabi Chakma said, a gang, equipped with firearms, opened fire and entered his (Kalaia's) room in the dead of night on Monday. They killed him by slitting his throat with sharp weapons and took away the body, said Nanabi Chakma. On information, police recovered the body from a jungle in the area on Tuesday afternoon and sent it to hospital morgue for autopsy.

## Betel leaf garden, sugarcane field gutted

Betel leaves on six bighas of land and sugarcane on two bighas of land were gutted in a devastating fire in Kaliganj upazila yesterday afternoon.

The affected owners claimed that the loss caused by the fire could go up to Tk 10 lakh.

Locals said, Hamid Ali, Israil Hossain, Adhir Das and Anil Das, of Kullapara village, lost betel leaves on 30, 18, 60 and 70 decimals respectively.

They said that sugarcane field owner Daud collected waste from his plantation

and torched to destroy it. But, it spread and soon engulfed the adjacent betel leaf gardens at around 5:00pm.

On information, firelighters rushed to the spot and doused the blaze with the help of locals.

Kaliganj fire fighting unit officer Bimol Kumar also said that the fire originated from the sugarcane planta-

Adhir Das said he borrowed Tk 50,000 from a local NGO and bank for the cultivation of betel leaves. "How I will repay the loan how", he posed.

### Murder for dowry triggers protest

Thousands of People of Modhya Phulbari area in the town brought out a procession and submitted a memo to the Deputy Commissioner, Bogra, demanding arrest of the culprits who killed Lima for dowry.

Lima Aktar, 20, daughter of Taslim Uddin Sheikh of Maddha Phulbari area in the town was killed at her in-law's house on Monday last.

Victim's family told this correspondent that Lima was married off with Shamim Mia, 30, son of Surjaya Mia of the same area about eight months ago.

They gave Shamim Tk. 6 lakh as dowry for getting a job in Talora municipality and later arranged another Tk. 2 lakh for his transfer from Talora to Bogra.

But Shamim was torturing his wife now and then for more dowry money and on Monday last strangled Lima at her in-law's house.

Lima's brother Nurul Islam Tuton said, her father lodged a case with Bogra PS, accusing 5, including Shamim.

The killers will be brought took, assured OC Shahid Alam of Sadar PS, who said that primarily it was found that Lima was strangled.

# Villagers suffer as a road in awful condition for years

AMANUR AMAN, back to Kushtia from Meherpur

"They turned down my daughter's marriage proposal a few months ago, saying how they will travel to the village during the rainy season," said Amej Ali, a resident of Baribaka village in Meherpur Sadar upazila.

Around 20 thousand people living in Baribaka and adjoining Shalika, Buripota and Nabinagar villages in Sadar upazila are suffering for years due to awful condition of the three-kilometre road linking Meherpur-Kushtia-Chuadanga Highway as well as district and upazilaheadquarters.

People of the agriculturedependent villages, some 20 kilometres off the Meherpur district headquarters, face untold problems while bringing harvested crops from their fields, sending children to school, bringing things to and from the markets, taking patients to hospitals, etc.

In the rainy season, the villages becomes virtually isolated. The villages are rich in

agriculture products, especially rice and fish, but they have remained very back-

ward due to lack of communication facilities, locals said.

Due to communication problem, the villages were not brought under electrification programme and so, local farmers use around 500 diesel-run shallow and deep tube-wells to irrigate their paddy fields, adding to the production cost.

"The kids have to face untold sufferings to go to schools during the rainy sea-

son," said Firoz Kamal, teacher of a local primary school.

Nazrul Islam, a farmer of Nabinagar village, said nobody took initiative to repair the road although aspirants in the elections promised to construct the road before the polls during the last several years.

As this correspondent talked to Abdur Rouf Mukul, chairman of Buripota Union Parishad, he said, "On several occasions I went to the officials of Local Government Engineering Department (LGED) and requested them to take initiative to repair the road but they gave only promise."

Jan-e-Alam, Meherpur Sadar upazila engineer of LGED, said his department wrote to the higher authorities in this regard and steps will be taken after allocation of money.
