Poultry farming in Chalan Beel shrinks

Price hike of feed, medicines, chicks responsible

Poultry industry in Chalan Beel area in the district now passing through a tough time as increased prices of inputs, including feeds, medicines and one-day chicks, have appeared to be a stumbling block for its survival.

Frequent diseases have added to the situation. Sources said, forced by the costly expenditure, owners shut down more than 200 poultry farms in the area in the last two years, rendering several thousand people jobless.

Besides, a few more farms which are still in operation, are also facing closure for other problems.

Several hundred men and women set up more than 1,000 big, medium and small scale poultry farms at their own initiative in Chatmohor, Bhangura, Faridpur, Tarash, Raiganj, Ullapara, Shazadpur, Gurudaspur, Singra and Atrai upazilas of the district in early 90s to get out of unemployment and poverty.

But business in the poultry farms nosedived in recession since they were attacked by various diseases, including avian influenza, and affected by price hike of feeds and other inputs in the last two years.

Poultry farmer Abdur Rashid of Chhaikhola village said a baby layer which

was priced at Tk 15 four years ago, is now Tk 80.

Similarly, a baby broiler was available at Tk 20, which is now selling for Tk 75.

Another poultry farmer Rafiz Uddin of Danthia village in Chatmohor upazila said, people involved in the industry have to count huge losses due to exorbitant prices of feeds and vaccines, apart from attack of various diseases.

Price of poultry feed was Tk 15 per kilogram four years ago, but it is now Tk 38-40.

Per kg maize is selling for Tk 13-27 and soybean at Tk 55, sources said.

Price of meat-bone meal has also increased to Tk 65 from Tk 32.

Small and medium level poultry farmers said, since there is no government policy for the poultry industry, Indian eggs, chicks and medicines have flooded the local markets.

As a result, small and medium scale farms were shunt after failing in the competition.

Farm owner Moinuddin Pramanik of Gurudaspur said, a good number of unemployed youths took bank loan and established poultry farms to become self-reliant.

But due to continuous losses, 50-55 per cent farms had to be closed down.

Admitting the increased prices of feeds, Tarash upazila livestock officer Amin Faruqi said that due to various reasons, poultry business in the area is facing a downturn.

Two held with arms

Schoolboy found dead

A schoolboy was found dead in Madhupur upazila yesterday. The deceased was identified as Abdul Mannan, 16, son of Minhaj Uddin Khan of Boali village. He was a class six student of Rani Bhabani Model High School. Victim's uncle Helal Khan said Mannan went to his father's restaurant near Madhupur Bus Stand on Saturday night for taking a sleep. The following morning, his body, which bore several stab injuries, was found on a chair in the restaurant, he said. Mozibur Rahman, officer in-charge of Madhupur Police Station, a case was filed in this connection.

50 shops gutted

At least 50 shops were gutted in a devastating fire at Nagerpara Bazar in Gosairhat upazila early yesterday. Fire Service and Civil Defence and local sources said the fire originated from a shop of Nagerpara Market at about 12:05am and soon engulfed other adjoining shops. On information, a fire fighting unit from Gosairhat rushed in and doused the blaze after four hours of frantic efforts with the help of locals at about 3:00am. District and upazila administration officials visited the spot. The reason behind the blaze could not be known immediately. The loss caused by the fire could not be ascertained yet.

20 injured in clash

At least 20 people, including two women, were injured in a clash over a piece of disputed land at Kalitala village in Mirpur upazila yesterday. Police said Karim Sana Malitha and his cousin Don Malitha was a longstanding conflict over the land. As a sequel to the conflict, their supporters engaged in a clash in the morning. A chase and counter chase took place during the melee, leaving at least 20 from both sides injured. The injured were admitted to the upazila health complex. Separate complaints were lodged with Mirpur Police Station in this connection.

Man found dead

UNB, Satkhira

Police recovered the body of an unidentified man at Jhurijhara village in Tala upazila on on Friday morning. The deceased, aged around 30, was wearing jeans pants and a black jacket. Rabiul Islam, officer in-charge of Tala Police Station, said locals found his body in a ditch at the village at about 7:30am and informed them. Later, police recovered the body that bore several injury marks at about 8:00am and sent it to the hospital morgue for autopsy. The reason behind the killing could not be known immediately. Police also recovered a machete from the spot.

Manikganj JCD demands dissolution of dist unit

Jatiyatatabadi Chhatra Dal (JCD) activists ransacked district BNP office and brought out a procession in the town yesterday, demanding dissolution of the newly formed Manikganj district committee of JCD.

The procession, which was brought out from Dashara area at around 12:45pm, paraded different streets in the town.

At this, the JCD men stormed into the office and damaged its furniture, urging the central committee leaders to dissolve the newly formed committee headed by Rafik Uddin Bhuyan Habu as president.

The new committee was formed with terrorists and apolitical person, alleged a

press release signed by JCD leader Rajib Hasan Khan.

The JCD central unit president and its secretary approved the seven-member Manikganj district committee on Saturday.

The new committee members are president-Masud Parvez, senior vice president-Awlad Hossain, vice president-Nazmul Haque Liton, general secretary-Mustafizur Rahman Prince, senior joint secretary-Asifur Rahman Khan Ramil, joint secretary-Khondaker Tuhin and organising secretary-Jinnah Khan.

The committee was formed five years after it was dissolved in 2008, said party sources.
