Man 'kills' wife, daughter in N'ganj

A woman and her infant daughter were strangulated allegedly by her husband for dowry in West Rosulpur area of Narayanganj sadar upazila yes-

The victims were Jharna Begum, 20, wife of truck helper Sadekur Rahman and her 40-day-old baby Sabiha.

Jharna's mother Kohinur Begum alleged that Sadekur killed her daughter and granddaughter after failing to realise Tk 60,000 as dowry.

Sadekur remains absconding after the incident. Police sent the bodies to Narayanganj General

JAIL KILLING CASE

Summon Moazzem, Khairuzzaman

Attorney General urges SC

Attorney General Mahbubey Alam yesterday urged the SC to summon BNP leader Shah Moazzem Hossain and Maj (retd) Khairuzzaman to hear about the conspiracy to kill the four national leaders in Dhaka Central Jail on November 3, 1975.

Both Moazzem, a state minister of the government led by president Khandakar Mushtaq Ahmed, and Khairuzzaman were acquitted by a lower court in 2004 from the killing charges, he said.

Mahbubey was placing arguments before the Supreme Court's Appellate Division during a government appeal hearing against a High Court verdict acquitting six former army personnel in the jail killing case.

The six are Marfat Ali Shah, Abdul Hashem Mridha, Lt Col (dismissed) Syed Farooq-ur Rahman, Lt Col (retd) Sultan Shahriar Rashid Khan, Maj (retd) Bazlul Huda and Maj (retd) AKM Mohiuddin

Ahmed.

Mahbubey also prayed to award capital punishment to the accused.

Citing the prosecution witnesses statements, he said Khandakar held three meetings with the accused on November 2, 1975 at Bangabhaban where the decision to kill the leaders was taken.

Next morning, Risaldar Muslemuddin and his associates killed the leaders --Syed Nazrul Islam, Tajuddin Ahmad, AHM Quamruzzaman and Captain Mansur Ali, said Mahbubey.

In 1976, Shamsher Mobin Chowdhury and Waliur Rahman, officers of the then foreign affairs ministry, gave appointment letters to some killers of Bangabandhu Sheikh Mujibur Rahman and the four leaders for jobs in Libya, he said.

Bangabandhu and his family's murderers were involved in the conspiracy to kill the leaders, he said adding that the lower court and the HC in their verdicts had ignored the conspiracy charges.



Journalist Abdul Matin passes away

Abdul Matin, an Independence Award winning journalist, writer and political activist, died due to old-age complications in a London hospital on Tuesday. He was 88.

He left behind his wife and a daughter, and a host of relatives to mourn his death.

Matin was born in Noakhali on April 13 in 1924, says a press release.

He actively participated in movements during 1971 in the United Kingdom to drum up support for the independence of Bangladesh. He was also involved with pro-liberation Bangla dailies published from the UK during the period.

In his journalistic career, he served United Press of India, Daily Azad, Daily Sangbad, United Press of Pakistan and Pakistan Observer, among other media outlets.

Matin wrote many books on Bangabandhu, the Liberation War and other topics. He received the Independence Award in 2009.

The Acid Crime Control Act states that acid throwers must be tried within 90 working days of committing the crime, but police could not even arrest the people who threw acid on Rekha Begum in Narail six years ago, said Monira Rahman, executive director of Acid Survivors Foundation.

It was reported that local representatives and politicians are trying to protect the attackers in this case, Monira said in a statement yesterday.

Moreover, there is a request to the National Committee on Withdrawal of Politically Motivated Cases to withdraw the case, she added, urging the committee to reject the request. Monira said 13 acid throwers were awarded death

sentence in the last 10 years but none of the sentences were executed so far. According to government statistics, there were 1,779 cases of acid violence in 2002-2012. Out of 4,569 people accused of such crimes, only 558 were arrested. Only 170

cases of acid violence ended in convictions.

ACID ATTACK ON REKHA BEGUM Attackers still not held lack of good governance

Discussion told

Speakers at a discussion yesterday blamed lack of good governance and lack of implementation of Right to Information (RTI) Act for corruption in the country.

If the RTI act did work effectively in Bangladesh, corruption would reduce by 50 percent, said Nagorik Oikya Convener Mahmudur Rahman Manna.

"The act could bring more successes if political leaders were more conscious about it," he told the discussion on "Alternative Path to Good Governance: Insights for Bangladesh" in the capital's Brac University.

Former adviser to a caretaker government M Hafizuddin Khan viewed that good governance was not ensured because there was no political will.

The Padma bridge project is not being implemented properly due to allegations of corruption, and that is because of lack of good governance, he said.

Hafizuddin said unlike India, the RTI act was very weak in Bangladesh.
