Irrigation pump users besiege PDB office

Demand correction of 'ghost' power bills

The irrigation pump owners besieged the Power Development Board (PDB) office in Kaliganj upazila under the district yesterday demanding immediate steps to correct the 'ghost' bills they received for the last boro season.

"Bills ranging from Tk bills for the last season." 20,000 to Tk 90,000 had been added to the actual bills for the last boro season. Irrigation pump owners got the bills in May last year. We made written complaint against the 'ghost bills' to the local PDB office in June, then again in August and October but to no effect," said Wahed Ali, president of Kaliganj upazila pump owners association.

"Lastly we have besieged the PDB office to get our logical demand met," he

Many irrigation pump owners are hesitant to run their machines during the current boro season in fear of getting 'ghost bills' again, much to the worry of farmers.

According to pump owners of the upazila, the Chamta feeder line at Kaliganj upazila covers areas under Kaliganj and Hatibandha upazilas and the number of pump users under the feeder line is 1500. Pump owner Mofizar

Rahman at Sree Khata village of Kaliganj upazila said he did not pay his power bills for the last boro season as he received an additional bill of Tk32,000.

"Now I am facing uncertainty about use of irrigation pump in the current boro season as I can't run my machine without paying

Monsur Ali, another pump owner at Dakkhin Ghonosham village of the upazila said, "I used power worth Tk 21,000 according to the unit charge in the last

boro season, but I received

boro cultivation on 70 acres of land in the village will face setback due to lack of irrigation. Like me, all the pump owners in this area have received ghost bills," he said. Seeking anonymity, an

official Kaliganj PDB office, said the additional power bills, termed as 'adjusted', had been imposed on the power pump users to cover their system loss.

adjustment of the bills is 'contrary to the law'.

December 25 last was fixed as the last date for payment of power bills for the last boro season but 90 percent of the consumers could not pay the bills as much higher than actual bills had been imposed, said Yakub Ali, general secretary of Kaliganj upazila power pump owners association.

Kaliganj upazila agriculture officer Shamsuddin Miah said, 50 percent of the targeted 12,390 hectares of land for boro farming in the upazila this season is yet to be cultivated due to lack of irrigation water.

Contacted, Probir Kumar Rudro, Kaliganj PDB resident engineer, said, "I have given permission to all the irrigation pump owners to run their machines and 80 percent of them have already started running their machines for irrigation in boro fields. Rest 20 percent will get power connection by a week to run their machines." "I am unaware about the

reason of additional bills as I joined the office only 20 days ago. I have been collecting all the ghost bills from the pump owners and sending them to Rangpur PDB office for correction. The pump owners will get result by a month," he said.

Locals protect them from hunters

A silk cotton tree at Keutan village under Ranishankoil upazila in the district has become a paradise for birds where hundreds of them twitter round the day.

The place is attracting a large number of visitors including bird watchers and bird lovers from far off places of the country.

As hunting of birds is completely forbidden there, the number of native and migratory birds are increasing every year, said a villager.

Locals said they are determined to protect the birds. They alert the newcomers and visitors, prohibiting them from hunting.

During a recent visit to the spot, over 50 kilometres off the district headquarters, this correspondent saw three to four hundred birds busking in sun the gaily while a few of them flying in and out without any fear.

"Initially we tried to drive the birds away as they used to excrete here and there and disturb workers on the crop fields. As the

Since then the number of birds increased every year. The migratory birds join the flock in the beginning of Bangla month of Kartik (mid-October) and leave the place in Falgoon (mid-March), he said.

"It is a matter of pride for us that people from far-flung areas come here to see the birds," he said.

The chirping of birds in evenings makes the surroundings fascinating. During the day time, the birds leave the tree in groups and again come back gradually. Around eight hundred to

one thousand birds of different varieties, including those locally known as pankouri, samkel, bok and other varieties live on the

"There is a tea stall near the tree. The owner of the stall raises alarm about the possible danger and local youths rush to the scene," Rabbani said.

Bird flu: 2,000 fowls culled

Over 2000 fowls have been culled following detection of bird flu virus at a poultry farm in Islampara area of Chuadanga district town. The chickens were culled at Munshi

Poultry Farm on Tuesday night due to the outbreak of avian influenza at the farm, said district livestock officer Kohinur Islam. The farm owner Hafizur Rahman said he

found some chickens dead a few days ago and informed it to the officer who prescribed some medicines for their treatment.

On Monday, the livestock officer sent

samples from the farm to Dhaka for tests. The laboratory confirmed the detection of bird flu the following morning.

After the report, Deputy Commissioner Delwar Hossain at an urgent meeting asked a team led by the livestock officer to cull the chickens.

A preventative measure was also taken to avert further spread of the virus at the meeting.

The chance of contamination in adjoining farms is very low as all precautionary measures have been taken in this regard said the officer.

Two shaheed minars in utter neglect in Kurigram town

The first and second Shaheed Minars in the district town have remained in utter neglect, even in February, the month commemorating the Language Movement of 1952.

In 1964, a Shaheed Minar (memorial for Language Movement martyrs) was built at a corner of Gahor Park in Kurigram town.

"After the Shaheed Minar, the first in the town, was set up at Gahor Park on February 19 in 1964, police damaged it at night. Then

bricks, sand and cement and reconstructed the memorial the next day. They guarded it during the night and observed the 21st February through placing flowers on the memorial," said Samiul Haque Nantu, who was a high school student in Kurigram during the 1952 Language Movement.

"But Pakistani army demolished it during the Liberation War in 1971.

The memorial was reconstructed in 1972 and locals used to observe 21st February there. Later a Shaheed Minar was conthe local students collected structed at Ghoshpara of Kurigram in 1988 and it got the status as the central Shaheed Minar in the town.

"In 1968, a local political leader constructed the second Shaheed Minar in the town, beside a road near Nasar Uddin Market. Left uncared for years, it has got damaged," Nantu said.

During a recent visit, this correspondent found firewood kept for drying on the premises of the Shaheed Minar at Gahor Park while the memorial near Nasar Uddin market gives a pitiable look as four of its columns were badly damaged.
