60 jailed in India return

Sixty Bangladeshis returned home from India through the Benapole check post yesterday after serving five years in an Indian jail. Benapole immigration OC Kamruzaman said that human traffickers sent them to India promising good jobs in Pakistan five years ago through Jessore border. Later, they were arrested in India by police. A case was filed against them and the Indian court sentenced them to five years imprisonment for crossing the border without valid documents.

All the returnees hailed from Cox's Bazar district. Meanwhile, BGB members held 13 people from Sadipur bordering area while they were going to India illegally yesterday. Of the arrestees, six are men, six women and one child. They hailed from different areas of Narail and Barisal districts. Benapole BGB camp sources said, a team of BGB raided the area and caught them in the morning. However, the traffickers fled the scene sensing presence of the border guards.

Clashing villagers in Magura vandalise 24 houses, torch 2

Twenty-four houses were vandalised and looted and two others came under arson attack during a clash between the residents of two villages under Bogia union of Magura Sadar upazila yesterday. The villagers belonging to Paturia and Bagbaria villages locked in the violent clash in the morning as a youth named Rokonuddin Ahmed Bisawa of Paturia village was killed by Bagbaria villagers on Wednesday night. Locals said the incident was a sequel to a longstanding rivalry between incumbent UP member Tayebur Rahman Biswas of Bagbaria village and former UP member Abdul Karim Biswas of Paturia village. Rokonuddin, son of Abdul Karim Biswas, came under attack allegedly by the supporters of Tayebur Rahman while he was returning home from a local market at around 8:30pm. The attackers hit him with sharp weapons, resulting in his death on the spot. Police and locals said the supporters of Karim Biswas, equipped with lethal weapons, swooped on their rivals, prompting them to retaliate. Twenty-four houses, shops and brick kilns were vandalised and looted while two other houses torched at the two villages during the clash that continued for three and a half hours from 10:00am, they added. Being informed, police led by Assistant Superintendent of Police (ASP) Saheb Ali Pathan and a team of Rab-6 went to the spot and brought the situation under control. While visiting the area in the afternoon, this correspondent found that many villagers had fled their homes, fearing further clash and police harassment. No case was lodged with Sadar Police Station in connection with the incident as of filing of this report at 5:00pm. Contacted, Officer-in-Charge (OC) Zahangir Alam of Sadar PS said police and Rab personnel have been deployed in the area to avert any further clash.

Six get life for murder

A court here yesterday sentenced six people to life-term imprisonment in Jamal Uddin Murder Case of 2007. The convicts are -- Aynal Haque, Abdul Rabbani, Abdus Sobhan, Md. Habibur Rahman *alias* Habi and Fazlul Haque of Bororchar Mridhapara village in Sadar upazila of Mymensingh. Of them, Aynal Haque, Abdul and Rabbani are still absconding. The court also fined Tk. 50 thousand each, in default, to suffer six months more in jail. The court also awarded punishment to nine other accused in the case on different terms. They are Noor Uddin, Annes Ali, Abdul Quadir, Nazrul Islam, Rafiz Uddin, Shafiqul Islam *alias* Shafiq, Samir Uddin, Akkas Ali

alias Ismail and Mizanur Rahman *alias* Mizan of Bororchar Mridhapara village. According to the case story, Jamal Uddin went to cultivate land at his Bororchar Mridhapara village in Sadar upazila around 7:30 am on 2 January, 2007. A gang of rival locals, led by Abdus Sobhan, attacked Jamal with sharp weapons, injuring him critically. He was rushed to Mymensingh Medical College and Hospital where he succumbed to his injuries at 11 am on the same day. A case was lodged with Kotwali police station by Amirul Islam, son of the victim accusing 16 people on the following day. After examining witnesses and evidences, Humayun Kabir, judge of District Special Judge Court, yesterday handed down the punishment.
