DONATIONS FROM ANTI-LIBERATION FORCES

JS body asks cops to refuse

The parliamentary standing committee on the home ministry yesterday asked police not to take any donations from organisations affiliated with the anti-liberation forces, including Jamaat-e-Islami, and from individuals with war crimes records.

The committee came up with the suggestion in an effort to strengthen the call to boycott the business and cultural organisations run by the anti-liberation forces and individuals, meeting sources said.

Police stations usually take donations like vehicles and other things from different organisations.

A policy on receiving donations, which was placed at the meeting, says police could accept donations if anyone wants to assist the force to ensure security of society, said a press release of the parliament secretariat.

The committee however asked police to keep the parliamentary body informed about the donations.

At the meeting, chief of the committee Sayadul Haque said he got information that the detained war crimes suspects were maintaining communications with party leaders through SMSs and asked the prison authorities to strengthen the monitoring system, said meeting sources.

The committee also asked the home ministry to ensure adequate security to bloggers involved with the ongoing Shahbagh mass movement, tighten security around Shahbagh, and take exemplary penal action against the killers of blogger Ahmed Rajib Haidar, said the press release.

Jamaat's Rajshahi chief held with explosives Hartal called in Rajshahi division

Rapid Action Battalion arrested Rajshahi city unit Ameer (chief) of Jamaat-e-Islami Ataur Rahman and seized 20 handmade bombs from his possession in the capital yesterday.

Protesting the arrest, Jamaat called a dawn to dusk hartal in Rajshahi division today.

Lt Col Ziaul Ahsan, director of intelligence wing of Rab, said they arrested Ataur on his arrival in the capital's Kalyanpur from Rajshahi by a bus around 5:15pm.

The Jamaat leader was also carrying 12 books on jihad written by different leaders of Jamaat-e-Islami, he claimed. They originally went there to arrest him for his alleged involvement in Monday's attack on a local Awami League (AL) office in Rajshahi city, he added.

On Monday night, activists of Jamaat-Shibir attacked the AL office at Binodpur, leaving at least five AL men injured.

Our Rajshahi correspondent reports, Ataur Rahman is accused of some 22 cases of murder, violence, arms and explosives related incidents with different stations of Rajshahi Metropolitan Police, said a RMP official.

PARAG ABDUCTION CASE

3 accused sent to jail on surrender before court

A Dhaka court sent three accused in schoolboy Parag Mondol abduction case to jail two hours after they surrendered before the court seeking bail yesterday.

They are Jubo League leader Aminul Haque alias Jewel Mollah, Alfaz Hossain and Abul Kashem.

The court also issued an arrest warrant against Mamun Miah as he was not present at the court during the hearing on the bail petition even though he surrendered before the court along with the three.

Another accused Rizvi Ahmed Anik could not appear before the court yesterday as he is now in custody in another abduction case filed with Keranigonj Police Station.

They surrendered before the court a day after the High Court directed law enforcers to arrest the five accused in the case within 24 hours. On Monday, the HC passed the arrest

order after Judge Md Abdul Majid of

Dhaka District and Sessions Judge's Court on Sunday cancelled their bail following petitions submitted by District Public Prosecutor Khondaker Abdul Mannan. Earlier, Judge Abdul Majid granted bail

to the five accused on different dates in January and February.

Six-year-old Parag Mondol, a student of KG-I of Heed International School, was abducted from Shuvadda Paschim Para in Keraniganj on November 11, last year. He was found three days later in Atibazar area of Keraniganj.

SAGAR-RUNI MURDER Security guard Énam sent to jail

Enam Ahmed alias Humayun Kabir was sent to jail yesterday on completion of his eight-day remand in journalist couple Sagar-Runi murder case.

Dhaka Metropolitan Magistrate Mohammad Mostafizur Rahman passed the order as the case's investigation officer (IO) did not seek further remand.

The court also fixed February 25 for the hearing on a bail petition filed by the accused.

IO Mohammad Zafar Ullah, a senior assistant superintendent of Rab, in his forwarding report to the court said he extracted important information from the accused which is being verified.

So, the accused needs to be detained in jail until completion of the investigation, he said. Earlier on February 10,

Enam was placed on the remand following his arrest by the Rab from Brahmanbaria. He was a security guard

of the building where the killing of journalist couple Sagar Sarowar and Meherun Runi took place on February 11 last year.

Police have so far arrested six more suspects in connection with the incident. The arrestees are Rafiqul Islam, Bakul Miah, Masum Mintu, Sayeed, another security guard of the couple's residence Palash Rudra Paul, and the couple's "family friend" Tanvir Rahman.

Of the suspects, the first four are now in jail in connection with the murder of physician Nitai, while Palash and Tanvir are in Rab custody.

CIRCULATING REPORT ON RAJIB'S BLOGPOSTS AMONG JUDGES

Justice Mizanur's removal sought

Expressing resentment at Justice Mizanur Rahman Bhuiyan, a High Court judge, for distributing a news item on the alleged blogposts of Ahmed Rajib Haidar among other judges, people of different professions yesterday demanded his removal and punishment through the Supreme Judicial Council.

Mizanur on Monday distributed clippings of a February 17 news report of the daily Inqilab among judges, including Chief Justice Md Muzammel Hossain, through two Supreme Court employees. The news report mentions Rajib as a murtad (non-believer).

A blogger and activist of the Shahbagh movement, Rajib was killed near his house in the capital's Pallabi Friday night. In a written statement, Ekattorer

Attorney General Mahbubey Alam demanded the judge's resignation, saying, "If you (Mizanur) quit, you will be saved from multiple disputes, and the judiciary will be saved too."

He said there were some judges at the HC, including Mizanur, who were involved in Jamaat-e Islami in the past.

"Justice Mizanur Rahman Bhuiyan has committed a gross misconduct showing loyalty to the politics of Jamaat-Shibir by his action," said AFM Mesbahuddin, a former president of Supreme Court Bar Association.

Anisul Huq, principal state counsel for the Bangabandhu murder case, said Mizanur lost his eligibility to hold the post of a judge, as he insulted the nation through his action.
