She made the appeal while distributing the "Ekushey Padak 2013" among 13 recipients at Osmani Memorial Auditorium in the capital.

The recipients of Ekushey Padak 2013: MAWadud (posthumous), Prof Ajit Kumar Guha (posthumous), Principal M Quamruzzaman (posthumous) and Tofazzal Hossain for the Language Movement; Enamul Haque Mostafa Shahid for the Liberation War; Nurjahan Murshid (posthumous) and Samson H Chowdhury (posthumous) for social services; Rafiq Azad and Asad Chowdhury for language and literature; Kaderi Kibria, Jamaluddin Hossain, Bijoy Krishna Adhikari (posthumous) and Bangladesh Udichi Shilpi Goshti for art and culture.

Hasina said Ekushey February has become the symbol of Bangalee nationalism, secularism and non-communal spirit, and called upon all to remain conscious in upholding the spirit of immortal Ekushey.

"Those who deny the spirit of the Language Movement and Liberation War are the enemies of immortal Ekushey and independence," she added.

Hasina said with the initiatives of some expatriate Bangladeshis living in Canada and all out support of her government, the Unesco declared Ekushey (21st February) as the International Mother Language Day, which facilitated the rights of mother tongue of all small ethnic groups in 193 UN member countries across the world.

Recalling the invaluable contribution of Father of the Nation Bangabandhu Sheikh Mujibur Rahman in the Language Movement, she said in 1974, Bangabandhu first delivered his speech in the UN General Assembly in Bangla to portray Bangla language and culture to the international community.

Germany grants Tk 52 lakh for restoration

The German government yesterday gave a Tk 52 lakh grant for the restoration and preservation of the culture and heritage of the Buddhist community in Ramu, Cox's Bazar.

On September 29, 2012, Muslim zealots destroyed 18 Buddhist monasteries and pagodas and over 50 houses in Ramu over a faked Facebook page insulting the Quran.

The agreement was signed by German Ambassador Dr Albrecht Conze and Bangladesh Buddhist Samity, Cox's **Bazar President Prof** Parikshit Barua in the capital's German embassy.

The money will be used to rebuild the Jetoban Buddhist temple, restore its library and procure traditional musical instruments.

CHRISTIAN YOUTH MURDER

The High Court yesterday upheld the death sentence of Jama'atul Mujahideen Bangladesh (JMB) leader Salahuddin alias Salehin, who was convicted of killing a Christian youth in Jamalpur 10 years back.

Salahuddin, a Majlish-e-Shura member of the banned Islamist outfit, is now in Dhaka Central Jail's condemned cell, Deputy Attorney General Md Selim told The Daily Star.

Led by Salahuddin, a group of JMB men killed Hridoy Roy of Sonarchar in Jamalpur's Sarishabari upazila on April 23, 2003, as he allegedly converted poor Muslim locals to Christianity, says the case statement.

A murder case was filed with Sarishabari Police Station following the incident without naming any suspects. On August 20, 2007, the Speedy Trial Tribunal-4 of

Dhaka passed a death sentence on Salahuddin after the investigation revealed that JMB men were behind the killing.

The HC bench of Justice Syed Muhammad Dastagir Husain and Justice Md Emdadul Haque Azad upheld that verdict as the charges against Salahuddin were proved beyond doubt.

On January 15, the HC upheld Salahuddin's death sentence in another murder case.

BID TO SAVE LOHAGARA FOREST

HC upholds death HC orders to stop operations penalty of JMB man of 22 brickfields, 20 sawmills

The High Court yesterday directed the authorities to immediately stop the operations of 22 brickfields and 20 sawmills in the reserved forest area of Lohagara upazila in Chittagong in order to save the forest, environment, and biodiversity.

The court declared operation of those brick kilns and sawmills illegal and directed the government to find out if forest area.

there were any other brickfields and sawmills operating illegally in the reserved Delivering verdict on a writ petition, the HC observed that the ministries of environment and forest, and local govern-

ment and rural development (LGRD) should be more cautious in issuing licences and clearance certificates for establishing brickfields and sawmills.

According to the Bela petition, the brickfields and sawmills, which were established violating the Forest Act 1927 and Sawmill Rules 1998, have been destroying the reserved forest and environment in the area.

Advocate Iqbal Kabir Lytton appeared for Bela, while Advocate Md Mostafa stood for the owners of the brickfields and implemented properly to save the envisawmills.

Kader Siddiqui sued in Ctg for calling home minister 'razakar'

A defamation case was filed yesterday with a Chittagong court against Bangladesh Krishak Sramik Janata League (BKSJL) President Kader Siddiqui on charge of terming the home minister "a razakar".

MA Taher, a freedom fighter and also a local leader of ruling Awami League (AL), placed the complaint before Additional Chief Metropolitan Magistrate Md Hasanul Islam, court sources said.

The court took the case into cognisance and ordered assistant commissioner (Kotwali) of Chittagong Metropolitan Police (CMP) to submit a report before the court within March 28, they

Quoting the case's First Information Report (FIR), Tapan Das, a counsel of Taher, said Kader at a party conference in the capital's Institution of Engineers, Bangladesh (IEB) on February 9 said, "It is impossible to complete war criminals' trial keeping a "razakar" home minister in the government".

At the conference, Minister Muhiuddin Khan Alamgir was additional deputy commissioner of Mymensingh during the Liberation War in 1971 and he [Kader] could prove that Alamgir was a "razakar", he said.

The comments have tarnished the image of the home minister as well as MA Taher, as both of them are freedom fighters; and also the image of the government and AL.
