Women at forefront glorify role of Nilphamari

Language Movement in Nilphamari is glorified by participation of a good number of women activists at the front line.

At a period when the society was largely conservative, the women organised processions and meetings, and rendering patriotic songs and poems, inspiring people to join movement to foil conspiracy against our mother language, said local Language Movement veterans.

"In those days, women were mostly confined to houses. Still a good number of female activists, mostly students of Nilphamari Government Girls' High School, took active part in the Language Movement of 1952," recalled advocate Mahbubar Rahman Dulu, 78, a Language Movement veteran.


"The leading female activists in the Language Movement in the district included Foujia Begum, Zakia Sultana, Chhomela, Feroja, Halima, Rabeya, Saleha, Sufia and Bulu. Most of them were students of Nilphamari Government Girls' High School," he said.

On February 21 in 1952, an all out strike was observed in all educational institutions of Nilphamari, in line with the central programme in Dhaka. A big rally was held on the premises of Muslim Hostel of Nilphamari High School. Foujia Begum and Feroja Begum addressed the rally along with male student leaders.

The news of killing of Rafiq,

Salam, Barkat, Jabbar, Shafiq and others on February 21 by Pakistani police in Dhaka reached Nilphamari on the night and thousands of people burst into protest in the town the next day.





Strike in India halts work at Hili land port

Export-import activities through Hili land port in Hakimpur upazila yesterday came to a halt as Indian opposition CPM enforced a two-day long strike, protesting recent economic reform by central government.

However, the loading and unloading continued and the port remained open for immigrants.

The land port will also remain closed on Friday due to weekend holiday, said a port official.

Jamaat's hartal goes largely disregarded in Rajshahi divn

Barring a few incidents of violence in three districts, the daylong hartal enforced by Bangladesh Jamaat-e-Islami passed off largely disregarded in Rajshahi division yesterday, according to our correspondents.

Secondary School Certificate (SSC) examinations were held as per schedule at all centres in the division without any disruption, said Tanvirul Alam, chairman of Rajshahi Education Board.

Jamaat called the hartal in all eight districts of the division protesting arrest of its Rajshahi city ameer Ataur Rahman in Dhaka on Tuesday.

People of Bogra, Natore, Naogaon, Joypurhat and Sirajganj districts rejected the hartal while it ended amid a few stray incidents of violence in Rajshahi, Pabna and Chapainawabganj.

Pickets vandalised two trucks at Kharkhari Bazar at around 8:00am and set fire to tyres in Debishingpara and Binodpur areas of Rajshahi city. Metropolitan Police Commissioner SM Moniruzzaman said police fired 30 tear gas shells and rubber bullets during a clash with Jamaat-Shibir men in the city. Hartal supporters blasted five hand bombs during the clash that continued for ten minutes, the commissioner added.

Police chased Jamaat-Shibir men while they were gathering at C&B intersection in the morning to bring out a procession. At least 12 Jamaat-Shibir men were picked up from Binodpur, Debishingpara and C&B intersection.

Awami League led 14-party alliance also took out processions in the city, rejecting the hartal.

All educational institutions, shops and markets remained open during hartalhours

Minibuses, public and private cars and a large number of CNG-run threewheelers were seen plying the city streets. Rickshaws were also found dominating the thoroughfares. Train service was normal. In Pabna, Jamaat-Shibir men vandalised seven shops at Abdul Hamid and Haji Mohammad roads in the town. Witnesses said the pro-hartal men came to the streets in processions and vandalised the shops. They also vandalised 10 CNG-run autorickshaws and battery-run three easy bikes on the roads.

Jamaat-Shibir men blocked Dasuria-Mirkamari Road in Ishwardi upazila and Jalalpur-Pushpapara in Sadar upazila in the morning. Most of the schools and colleges remained open but vehicles except rickshaws and auto-rickshaws were off the roads.

In Chapainawabganj, Jamaat and Shibir activists took out processions and set fire to tyres on Chapainawabganj-Rajshahi highway at Upar Rajarampur and Swarupnagar in the town. No untoward incident took place in the district headquarters during hartal. The Jamaat call shutdown was by and large peaceful in all upazilas of the district.

PCJSS calls for urgent steps to free party men

Partbattya Chattagram Jana Samhati Samity (PCJSS) yesterday demanded immediate steps to rescue the party men, who were kidnapped allegedly by the members of United People's Democratic Front (UPDF) from Kattholi in Longudu upazila on Saturday.

The leaders of PCJSS submitted a memorandum in this regard to the prime minister through deputy commissioner Md Mostofa Kamal.

PCJSS claimed that the armed men of UPDF abducted 70 leaders and activists when they were going back homes after attending the party's 41st founding anniversary programme in the district town.

Among the victims are Moni Shankar Chakma, secretary of Longudu upazila unit PCJSS, Josho Chakma, secretary of Jubo Samity and its organising secretary Milon Chakma.

Although Longudu police said that at least 13 PCJSS men were freed by the kidnappers, leaders of the party trashed the police claim.

"We are yet to get any information from the family members of the victims about their release," said Sajib Chakma, assistant information secretary of PCJSS.

The party also demanded

a ban on UPDF in hills and immediate arrest and punishment of the kidnappers. Members of joint forces

were raiding different hill areas to rescue the PCJSS men, said Md Rezaul Haque, officer in-charge at Longudu police station.

Meanwhile, Pahari Chhatra Parishad (PCP), a student wing of PCJSS, yesterday formed a human chain and held a rally in the town, demanding proper execution of Chittagong Hill Tracts (CHT) agreement.
