## Ruling party men building market on it

Shibbaria canal near Chaplee Bazar in Kalapara upazila under the district is getting narrowed as ruling party men have filled up land of the canal for construction of a market.

Mostafizur Rahman Bhuiyan, organising secretary of Dalbuganj union unit of Awami League (AL), and his partner Hakim Ali started work for a market construction on Shibbaria canal at Chaplee Bazar over two weeks ago but the local administration is yet to take any action to stop the illegal act.

Five people led by a local Jubo League leader are also filling up a nearby land to construct another market.

Squeezing of the canal will make it difficult for trawlers to enter the water body, causing trouble for fishermen who use it as shelter during natural disasters like cyclones and tidal

the land is khas land." Md Mahbubur Rahman, assistant commissioner (Land) in Kalapara, said, "Nobody informed me of the matter. I will investigate the matter and take step to evict all grabbers from the land, if the allegation is found true."

## Youth beaten to death allegedly by police for illegal toll

A 'drug addict' youth was killed allegedly by policemen for not paying them toll at Mahmudpur village of Sirajganj Sadar upazila on Wednesday night.

Alleging death due to police torture, villagers went on rampage in Shaheed Minar area of the town.

The deceased was identified as Farid Ahmed, 32, son of Rohiz Uddin of the village. Rohiz said that a team of police, led by sub-

inspectors Abdus Salam and Md Selim, raided their home at around 9:00pm and beat his son up mercilessly, leaving him dead on the spot for not paying them illegal toll.

As the death news spread, agitating locals brought out a protest procession in the area and ransacked a few vehicles there, demanding punishment to the accused law enforcers, said Md Ataur Rahman, councillor of ward No1 of the municipality.

He also said that the deceased was a drug peddler.

## 80 Jamaat, Shibir men arrested

Police arrested 80 'leaders and activists' of Jamaat-Shibir in Madhupur upazila yesterday afternoon.

Over 100 Jamaat men led by its upazila unit ameer Burhan Uddin and upazila unit Shibir president Lokman Hossain in two buses went to Madhupur forest in the name of picnic, said Saleh Mohammed Tanvir, superintendent of police.

On secret information, a team, jointly led by ASP Shajahan Mia and officer incharge at Madhupur police station raided the forest and arrested 80 of them while they were holding a secret meeting there.

However, the rest managed to flee. We are verifying the identities of the arrestees, the SP said.

Police also arrested seven Jamaat-Shibir activists from two upazilas in Chapainawabganj on Wednesday night on charge of trying to creating chaos and confusion, reports our correspondent.

The arrestees were identified as Mohammad Mustakin, 21, of Sadar upazila and Alauddin, 24, Rafiqul Islam, 44, Ruhul Amin, 18, Hasan Ali, 18, Monirul Islam, 18, and Mustafizur Rahman, 20, of Gomostapurupazila.
