Two villagers were killed and 20 others injured in a clash as they went to protest obscene dance in the name of jatra (open air opera) in Pirganj upazila early yesterday.

The deceased were identified as Shamsul Islam, 50, son of late Abdus Samad of Parbatipur village and Serajul Islam, 40, of Gurjipara village in the upazila.

Police and locals said Monjur Hossain of Dasharpara village in the same upazila along with his associates arranged obscene dance in the name of jatra at Gurjipara haat (village market) on Saturday night.

At about 12:30am, a group of villagers went to the spot and requested the organisers to stop the obscene dance.

At this, Monjur and his men locked in

At one stage, Monjur Hossain and others locked in a fierce clash with the villagers with sharp weapons, leaving Shamsul Islam dead on the spot and 20 others from both sides injured.

Among the injured, Mokbul Hossain, 60, Mominur, 45, Lalchan, 50, Shahinur, 45, Serajul Islam, 40, and two sons of Samsul Islam were taken to Pirganj upazila health complex.

As the condition of Mokbul, Mominur, Lalchan, Shahinur and Serajul deteriorated, they were referred to Rangpur Medical College Hospital where Serajul succumbed to his injuries yesterday afternoon.

Hasan Shamim Iqbal, officer in-charge of Pirganj police station said that police sent the bodies to Rangpur Medical College Hospital morgue for autopsy.

Police said following bad smell, locals found the body in the septic tank at an under constructed building at the house of Nur-un-Nabi. On information, police recovered the body and sent it to Jessore Medical College and Hospital morgue for autopsy. Shahinur, sub-inspector at Kotwali police station, said they were investigating whether it was an accident or murder. Abdullah went missing on February 20, he said.

Housewife killed for dowry

A housewife was killed allegedly by her husband for dowry at Laxmi Mondap village in Dupchacia upazila Saturday. The deceased was identified as Rodini Begum, 22, daughter of Bablu Mia of the village. Bablu said her daughter married Shahidul Islam of the same village two years ago. After marriage, Shahidul and his parents often tortured Rodini for Tk 2 lakh. Locals said, Shahidul beat Rodini up mercilessly, leaving her dead on the spot following an altercation over the issue early Saturday. A case was filed in this connection, said officer in-charge of Dupchacia police station.

Tortured teenage domestic help groans at hospital

A domestic help, tortured allegedly at her master's house in Dhaka, is now undergoing treatment at Patuakhali General Hospital.

The hapless teenage girl, Sharmin, is a daughter of Mojibur Rahman of Jainkathi village in Sadar upazila.

Family members said Sharmin went to Dhaka with her neighbour Habib, manager of a hotel in Bata Signal area on Elephant Road, eight months ago and since then worked at the residence of the hotel owner.

Days after joining as domestic help, the ber of them.

hotel owner's wife and daughter began to torture her over trivial matters, Sarmin told this correspondent at the hospital.

"The duo confined me to a room of the house for three days from February 19 and beat me up mercilessly", she said.

On February 21, a woman of the neighbouring flat rescued me, she added.

Her father Mojibur later admitted her to the hospital, said Sharmin.

There were several marks of torture on

her body, said the on duty doctor.
