### 50,000 MT wheat import proposal gets govt nod

STAFF CORRESPONDENT

The cabinet committee on purchase yesterday approved the proposal for importing 50,000 tonnes of wheat to meet the country's wheat deficit.

Amira Pure Foods Pvt Ltd, a New Delhi-based company, will supply the wheat at a rate of \$313.65 per tonne.

The committee approved the proposal for installation of 4.50 lakh more electronic meters to provide power connection in the rural areas at a cost of Tk37 crore.

It also okayed the proposal for importing 30,000 tonnes of phosphoric acid for fertiliser production at a rate of \$463.93 per tonne.

Besides, the committee gave the nod for importing 4.50 tonnes of Muriate of Potash fertiliser from the state-owned Belarusian Potash Company under a government-to-government agreement.

Finance Minister AMA Muhith presided over the meeting, held at the Cabine Division.

#### Kuwait executes 3 men convicted of murder

Kuwait executed three men yesterday who had been convicted of murder, the first executions in the Gulf Arab state since 2007, state news agency KUNA reported.

Kuwaiti media said on Sunday that the three were a Pakistani, a Saudi and a stateless man and they would be hanged.

They were executed at the Central Prison, KUNA said, without giving details Authorities had invited journalists from Kuwaiti publications to witness the executions.

The last recorded case of the death penalty being carried out in Kuwait was six years ago when a Pakistani man was executed for drug trafficking, according to

#### 34 opposition men denied bail again

Thirty-four opposition leaders and activists were denied bail for the second time in two cases filed for assaulting police and blasting cocktails near BNP's Nayapaltan office on March 11.

The accused include Opposition Chief Whip Zainul Abdin Farroque, BNP leaders Amanullah Aman, Ruhul Kabir Rizvi and Dr AZM Zahid Hossain and Jatiya Gonotantrik Party chief Shafiul Alam Pradhan.

The cases were filed with Paltan Police Station.

Metropolitan Sessions Judge (in-charge) Md Anisur Rahman rejected the bail petitions. On March 20, two metro-

politan magistrates rejected bail petitions of 148 opposition leaders and activists, including the 34, and placed each of them on eight days' remand. The 148 and nine other leaders and activists of the

BNP-led alliance were detained during a raid on the BNP office on March 11 after cocktails went off at a rally in front of the office. Lawyers of the 34 accused

submitted the bail petitions on March 25 against the rejection order of the two magistrates. A Dhaka court on Sunday

### Shibir chief on 14-day remand

A Dhaka court yesterday placed Islami Chhatra Shibir President Delwar Hossain on 14 days' remand for his alleged involvement in assaulting police and blasting cocktails on Mirpur Road in the capital on February

Metropolitan Magistrate Harun-or-Rashid passed the order when police produced Delwar, 31, with a 20-day remand prayer in two cases filed with Mohammadpur Police Station.

The court also placed two other accused, Mahmud Hassan alias Sumon, 23, and Shoib Sarkar, 23, on a 14-day remand in the same cases.

Police in remand prayers said, Delwar was directly involved in assaulting police and blasting cocktails around 11:30am in front of Care Hospital during a hartal enforced by Jamaat-e-Islami on the day. Therefore, they need to be remanded to find

out important information. Earlier on Sunday, detectives arrested Delwar at his sister's house at Shyamoli in the capital around 4:15pm.

Police sources said Delwar was a charge-sheeted accused in a dozen criminal cases.

Another meeting source said, "The board heavily criticised the stealing of public money."

"The board also wanted to know how much of the stolen money could be recovered and whether any case could be filed to recover the money."

The finance ministry last week sent the letter to Sonali Bank, asking it to submit a comprehensive report on the assets and liabilities of Hall-Mark.

It also sought ways and means of how Sonali Bank could get back the money by resuming operations of some of the factories of the Hall-Mark, which is said to be employing 40,000 workers.
