US made secret deal with Pak: Report

In a secret deal, Pakistan allowed American drone strikes on its soil on the condition that the unmanned aircraft would stay away from its nuclear facilities and the mountain camps where Kashmiri militants were trained for attacks in India, according to a media report.

Under secret negotiations between Pakistani intelligence agency ISI and America's CIA during 2004, the terms of the bargain were set, the New York Times

reported yesterday. "Pakistani intelligence officials insisted that drones fly only in narrow parts of the tribal areas - ensuring that they would not venture where Islamabad did not want the Americans

The "secret deal" over drone strikes was reached after CIA agreed to kill tribal warlord Nek Muhammad, a Pakistani ally of the Afghan Taliban who led a rebellion and was marked by Islamabad as an "enemy of the state,' the NYT reported, citing an excerpt from the book 'The Way of the Knife: The CIA, a Secret Army, and a War at the Ends of the Earth'.

The ISI and CIA also agreed that all drone flights in Pakistan would operate under the American agency's "covert action authority", which meant that the US would never acknowledge the missile strikes and that Pakistan would either take credit for the individual killings or remain silent.

Afghan attacks kill US diplomat, soldiers

A car bomb blast killed five Americans, including three US soldiers and a young diplomat, on Saturday, while an American civilian died in a separate attack in the

The diplomat and other Americans were in a convoy of vehicles in Zabul province when the blast occurred, Secretary of State John Kerry said in a statement.

The soldiers and the diplomat died in the blast along with a civilian employee of the Defense Department and Afghan civilians, Kerry said. His statement gave no overall death toll.

The Washington Post identified the diplomat as Anne Smedinghoff, 25, citing her parents. Smedinghoff was Kerry's embassy guide and aide when he visited Afghanistan last month, the paper said.

Afghan colleagues were on their way to donate books to students in a school in Qalat, the province's capital, when they were struck by this despicable attack, Kerry said in his statement.

In an attack in Afghanistan's east, an American civilian working with the US government was killed during an insurgent attack, the Nato-led International Security Assistance Force said in a statement.

The Taliban claimed responsibility for the Zabul attack in a text message from spokesman Qari Yousuf Ahmadi. He said a car bomb killed seven foreigners and wounded five others, although he later revised the toll to 13 foreigners killed and nine wounded.

The Taliban routinely exaggerates casualty figures.

The killings followed a bloody Taliban assault in the country's west on Wednesday that killed 44 people in a courtroom in Farah province. The United Nations says civilians are being increasingly targeted.

In a statement posted online earlier on Saturday, Ahmadi said the Taliban would continue to target Afghan judges and prosecutors.

The peacekeepers of Manipur

They don't wear blue helmets nor are they uniformed but their attempt to maintain peace in Manipur's most backward district of Tamenglong - riddled with internecine clashes - is somewhat akin to that of a United Nations Peacekeeping Force in a war-torn nation.

Under the banner of Inrilangluang Luh Chujaenj Phum (Women's Peacekeeping Organisation), over 700 women are trying to maintain peace in Tamenglong by just beating iron poles with sticks - creating a loud clanging noise to raise an alarm.

The role of the women's peacekeeping force is to spot

trouble in the district and to alert other team members so that it could be averted.

Monica, 40, is among these women Wielding a stick,

she stands guard near an electric pole. If she senses trouble, she starts beating the pole with the stick to alert another woman who is deployed at a stone's throw. On hearing the sound, she also starts beating the pole. Thus, the chain continues.

These women came together to tackle the problems arising out of sparring Naga groups, extortion attempts, drug smuggling, petty trouble-makers and, finally, the ineffectiveness of the law in tackling these issues. The group was formed last October.

"We were fed up with lawlessness and underground insurgents. Extortion and smuggling of drugs also created problems," said one of the founding members of the group, requesting anonymity. These problems led us to form this group," she added.

She said that a group of 7-8 women are deployed in each of the seven wards in Tamenglong district and they keep a vigil between 4.30 pm and 10.30 pm.

The women in the group say that they want to ensure peace by reforming society by their own methods.

CRIMES AGAINST WOMEN More needs to be done: Manmohan

Prime Minister Manmohan Singh yesterday said his government had moved fast to bring about significant reforms in the laws relating to crimes against women in the aftermath of last year's brutal gang-rape but admitted that more needs to be done.

Speaking at a conference of chief ministers and chief justices of high courts here, the prime minister said the "national outrage" after the Dec 16 gang-rape forced 'urgent introspection" on anti-rape laws and the justice delivery system "but we must not allow ourselves to be overcome by a sense of despair at some of the demonstrated inadequacies of our legal

system". He said the government had "brought about significant amendments in the criminal law to effectively deal with heinous offences against women".

The 23-year-old woman was raped by a gang of five men and a juvenile on board a moving bus in south Delhi.
