Indian Coal Scam Report

BJP demands PM's resignation

The BJP yesterday demanded that Prime Minister Manmohan Singh must resign in the wake of the allegations that the CBI's report on "Coal-gate" was reviewed by the government before it was submitted to the Supreme Court last month. The party also wants Law Minister Ashwani Kumar to be sacked.

The BJP disrupted Parliament once again yesterday over the coal report allegations. It also gave notices for suspension of Question Hour in both Houses.

Congress chief Sonia Gandhi rebuffed the BJP's demand for Manmohan Singh's resignation.

A newspaper report said earlier this month the CBI report submitted last month had been vetted by Kumar and officials in the prime minister's Office. During a meeting with Kumar and CBI officials, several amendments in the report were suggested and some also incorporated, it said.

India's official auditor had last year revealed that the lack of transparency in the allocation of coal blocks to private players resulted in the loss of a whopping Rs.1.85 lakh crore (\$37 billion) to the exchequer as on March 11,

The report does not directly indict the prime minister or his office, but during the time these mining blocks were allotted, the coal portfolio was held by prime minister Manmohan Singh.

Yesterday's hartal virtually halted businesses and hampered academic activities at educational institutions in the city. The presence of vehicles, including buses and CNG-run threewheelers, was thin on the usually-clogged thoroughfares of Dhaka. Private cars were kept off the streets in fear of vandalism while rickshaws ruled the roads.

Morjina Begum, 42, general secretary of ward no-53 unit of Jubo Mohila League, and her daughter Rokeya Hasan Rupali, 18, an HSC examinee of Motijheel Ideal School and College, suffered injuries when six bombs kept in a shopping bag exploded before their residence on Haji Khorshed Ali Road at

Jurain around 2:00pm. The two were rushed to Dhaka Medical College Hospital.

Talking to The Daily Star, Morjina said they noticed a shopping bag there after getting down from a rickshaw. "As I tried to open it, it

exploded with a bang," she said, adding that there were two small bottles and four other substances wrapped in red tape.

In another incident near the local BNP office at Nayabazar, rickshaw-puller Abdur Razzak, 45, sustained severe injuries in his leg when a homemade bomb went off around 1:00pm.

At about the same time, unidentified miscreants blasted another handmade bomb at Tantibazar, leaving Md Shahjahan, aged 40, wounded. He was crossing the area by a rickshaw.

Both Razzak and Shahjahan were admitted to Sir Salimullah Medical College Hospital, said hospital sources.

Besides, pedestrian Sirajul Islam, 50, was injured when a bomb exploded before Fulbaria bus stand in Gulistan around 12:45pm.

Cocktails were blasted in front of the BNP central office at Nayapaltan, in Malibagh, Shantibagh and Rampura. Most of the bombs went off during processions brought out by pro-hartal activists.

A huge contingent of police and Rapid Action Battalion were deployed at

all key points of the capital. Meanwhile, several mobile courts sentenced 11 pickets, including three leaders of Jatiyatabadi Mohila Dal, to different jail terms between three months and one year for vandalism at Khilgaon and

Motijheel.

16th witness testifies

The Pakistani army had killed the three, 16th prosecution witness AKM Mahbubur Rahman, nephew of the victims, told the International Crimes Tribunal-2 yesterday during his testimony in Alim's case.

The 63-year-old businessman said under the leadership of then Convention Muslim League leader Abdul Alim, Peace Committee, an antiliberation body, had been formed in Joypurhat and Panchbibi.

Former Student Union leader Mahbub said the peace committee leaders had formed the Razakar force comprising of madrasa students and non-Bangalees.

"They [Razakars], as the auxiliary force, used to hand over unarmed civilians, pro-liberation people and India-bound refugees to Pakistani army and had committed arson and lootings," said the witness.

"The May 26 of 1971 is a red letter day for us, as on that day the occupation army had attacked our home in Nowda village," he said.

Before the attack, members of the Razakar force and also Peace Committee Ahmed Bihari and Rashid Bihari gathered information about their [Mahbub's] home, said Mahbub, adding that around 11:00am the Pakistani army had come to a nearby home.

Knowing about their presence, Mahbub and his elder brother Bazlar Rahman, like many other Alim at the Peace villagers, had hidden in a nearby place and witnessed the incident. After sometime, Ahmed

and Rashid, who came along with the army, had announced that the army was there to restore peace and that they would form a Peace Committee there. Hearing the announcement, many people including three of the witness' uncles killed -- Yusuf Uddin Sardar, Yunus Uddin Sadar and Ilias Uddin Sadar -- had gone there, said Mahbub.

"In cooperation from the Razakars, the Pakistani army had picked Mahbub's uncles and taken them to an army camp at Balighata union in Panchbibi," said the witness adding that he and his brother had followed them.

When they had informed the family of the capture, Mahbub's father sent one of his nephews Abul Kashem Sardar to look for the detainees. Kashem had talked with three Peace Committee men, who advised him to go to Alim to have the detainees released. "As per their instruc-

tions, my cousin went to Joypurhat and met Abdul Committee office in Shaon Lal Bazlar's Gadighar," said Mahbub, adding, "Alim Shaheb told my cousin that there were allegations against them that all of their family members were either freedom fighters or organisers of Liberation War. The army has picked them and would not release them; rather efforts are on to arrest others."

When Kashem had returned, all of their family members hastily left home and took shelter in a nearby village. Around 6:30pm or 7:30pm, they had heard gunshots from Kali Saha's pond, said Mahbub. "The family understood

that the detainees [three uncles' of the witness] had been killed," said the witness, adding that they had left the country and took refuge in India until the war ended.

On their return, they collected information and identified the killing spot at Kali Saha's pond. They reburied the killed uncles of Mahbub with proper funeral rites exhuming the bodies from a mass grave, said Mahbub in his 64minute deposition. The three-member
