Local freedom fighters have demanded justice for brutal attack, threat and false case against a freedom fighter and his family members at Dohakhula village in Bagherpara upazila under the district.

Abdul Aziz, who bravely fought against Pakistani occupation forces and their collaborators during the Liberation War in 1971, had hoisted the national flag first in Bagherpara on December 8 that year.

But now at an advanced age, he is passing days amid utter insecurity as cohorts of a few alleged Rajakars (collaborators of the Pakistan occupation forces in 1971) injured him and his son, threatened the family and filed a false case against them.

"Recently some local BNP activists and supporters attacked the house of freedom fighter Jalil Uddin at Dohakhula village, following a clash between Chhatra League and Chhatra Dal at Bagherpara Degree College. As they started beating Jalil's grandson Jony, my son Rony protested and the attackers beat him too," Abdul Aziz said.

"Later on April 14, the criminals, also men of a few Rajakars of Dohakhula village, waylaid me when I was returning home. They beat me up indiscriminately with sticks and iron rods. I was rushed to Jessore Medical College Hospital with serious injuries," he said.

The freedom fighter filed

a case in this regard on April 15 with Bagherpara police station but police could not arrest the culprits afterward.

"Meanwhile the accused took bail from the court on April 18. Now they are threatening me and my family members of dire consequences. The antiliberation forces also filed a counter case against my two sons Nazmul Huda Mithu and Famid-bin-Aziz Rony, and relative freedom fighter Abdul Jalil's son Golam Dastagir and grandsons Jony and Joy to harass us," Aziz

Officer in charge of Bagherpara police station Ramprosad Bhakta said, "The accused have taken bail from the court and we are investigating the matter."

Demanding arrest and punishment of the culprits, Mazharul Islam Montu, commander of Jessore district unit of Muktijoddha Sangsad, said, "How sorrowful is it that anti-liberation forces torture a freedom fighter in an independent country."

### Jubo League man shot dead in infighting

A Jubo League man was shot dead by rivals in Puratan Kasba Talikhola area in the town yesterday morning.

The killing was a sequel to an internal feud between the supporters of district Jubo League vice president Mehedi Hasan and joint secretary Moinuddin Mithu over establishing supremacy in the area, locals said.

Police arrested two suspects in connection with the murder. Agitated locals vandalised four houses of the alleged killers at noon.

The deceased was identified as Sarwar Hossain Tulu, 30, son of Abdul Kader Sardar of Police Line Talikhola area in the town, also an aide to Mehedi Hasan.

Mehedi alleged that Moinuddin Mithu and his men were behind the mur-

Tulu's mother identified some youths including the arrestees -- Shapon alias Chinese Shapon and Raju, the OC said.

At noon, agitated locals held a protest procession with the body of the deceased. They vandalised the houses of Moinuddin Mithu, Doublu Tito, Shipon and Kalo Mithu while passing by the area.

Mehedi Hasan told this correspondent that Tulu was a member of Jubo League. The killers are also activists of Jubo League and the murder was done to establish supremacy in the area, he added.

## Once valiant FF Jubo League man looting neighbour's trees

A Jubo League man has continued felling trees on a neighbour's homestead at Uttar Subidkhali village in Mirzaganj upazila under the district since Wednesday.

Ten to twelve labourers employed by Ruhul Kuddus, member of Mirzaganj upazila unit of Jubo League, have already cut down and removed trees worth over Tk 3 lakh from the house, said Jahanara Begum, wife of house owner Mannan Mridha.

Jahanara filed a case with the Judicial Magistrate's Court on Sunday and the court asked the headmaster of Rahman Ishaq Pilot High School in the upazila town to inquire into the matter as police did not receive the case in this regard.

A group of journalists from Patuakhali town visited the spot on Sunday noon and found 10/12 labourers cutting trees in Mannan Mridha's house as per direction of Ruhul Kuddus.

Jahanara Begum said, "My husband, a health department employee, bought the 0.12 acres of land 30 years ago from Nur

Shahidul Islam, executive engineer of WDB-2, said that they sought Tk. 3.5 crore to set up a new dam as the old one was not dependable anymore.

Family members said, Jihan went missing in the morning and after sometime he was

declared him dead. In Pabna, two kids drowned in a pond in Tarabaria village in Sadar upazila on Sunday

afternoon, reports our correspondent. They are Md. Rakib, 3, son of Iqbal Hossain and Taslima, 3, daughter of Sachchu Hossain of the village. They were cousins, locals said.

They said Rakib and Taslima, while playing on the bank of the pond beside their house, fell in it and drowned.

# Little girl 'sold to circus party' a year ago rescued

A 13-year-old girl, allegedly sold off to a circus party by the chief security guard of Barisal Training and Rehabilitation Centre for Socially Disadvantaged Women and Girls (TRCSDWG) under the Social Welfare Department, was rescued on Saturday night.

The authorities concerned closed the accused security guard to Barisal social welfare office and formed a committee to investigate the matter.

Asaduzzaman, manager of the centre, said Pirojpur Sadar Police Station handed over a 10 -year-old girl to them on April 17, 2010. "As the girl went missing from the centre on November 8, 2012, I filed a general diary with Barisal Kotwali Police Station the same day," the manager said.

The girl told journalists yesterday that Jasimuddin, chief security guard of TRCSDWG, sold her to Arun Das, owner of Royal Bengal Circus Party of Gournadi for Tk 20,000, saying that she would lead a better life there.

"Arun Das tortured me both physically and mentally many times. I searched for a way to get rid of the agony and managed to escape from the circus party Saturday morning," the girl

girl boarded a passenger bus from a place in the upazila on Saturday morning and requested the bus conductor to drop her near Bhuterdia bus stop under the upazila. As she narrated her agonising odeal to Shamima Begum, a passenger of the bus, she took the girl to her home at Jahapur under Agorpur union under Babuganj upazila and sought help from local human right activist Shahidul Islam Jewel, who later brought the girl to

Gournadi Press Club. Being informed by local journalists, Barisal social welfare office sent a team and female Ansars led by TRCSDWG Manager Asaduzzaman to Babuganj. The team brought the victim to Barisal at night.

Mahbubul Islam, deputy director of Social Welfare Department, Barisal, said a three-member team comprising Deputy Superintendent Rosy Begum and Administrative officer Humaun Kabir of TRCSDWG and upazila social welfare officer Shahjadi Begum interrogated the victim at the centre on Saturday night.

"We have already closed the security guard Jasim to the district office. Necessary actions will be taken against him on the basis of the investigation report," the deputy director said.
