# 8 shops gutted

Station master of local fire service M Arif Hossain said the fire originated from an electric short circuit at a shop at about 1:45am and soon engulfed the other adjoining shops. The loss caused by the fire could go up to Tk 25 lakh, said the station master.

### Man held with arms

Police arrested a man along with a pistol and two bullets from a bus on Dhaka-Chittagong highway in Haripur area under Daudkandi upazila on Monday. The arrestee is Al Amin, 35, son of Belayet Hossain of Uttar Shahjahanpur in the capital city. Police said they raided a Dhaka-bound bus of Greenline Paribahan from Chittagong at about 5:30pm and arrested Al Amin along with the arms and bullets.

# Youth stabbed to death

A youth was stabbed to death by criminals in the district town yesterday. The deceased was identified as Shariful 28, son of Belayet Ali of Madhugram village in Sadar upazila. Police said a gang swooped on Shariful in front of Jessore Central Jail while he was returning home after appearing before a local court in a dowry case filed against him by his wife Nurjahan, daughter of Badar Uddin of Balia Bhekutia village in the upazila, leaving him seriously injured. He later died at hospital.

# UP chairman does it, halting classes

A union parishad (UP) chairman under Palashbari upazila uses a registered primary school in the union as centre for distributing VGD (Vulnerable Group Development) rice among the ultra poor women at least once a month, suspending classes.

Despite objection by the guardians, Chairman Aminul Islam Rintu of Kishoregari Union Parishad (UP) continues to use Hasan Khor Registered Primary School building as rice distribution centre.

On Monday last, the chairman distributed VGD rice among poor women, suspending classes for the

Locals alleged that they had repeatedly appealed to the upazila nirbahi officer (UNO) and upazila primary education officer to stop VGD rice distribution from the schoolhouse, but no step

has been taken yet.

They demanded that the authorities concerned shift the distribution centre from schoolhouse to another place for the sake of students' education.

"We urged the UP chairman to shift the VGD rice distribution centre to any other suitable place, but he did not pay heed to our request" said Nurun Nabi Mia, headmaster of the school.

The UP chairman compels us to suspend the classes for the day he distributes rice among the ultra poor women, the headmaster added.

The ultra poor women crowd the school compound in the morning and stay there till the end of VGD rice distribution, he further said.

Contacted, UP Chairman Aminul Islam Rintu said the schoolhouse has been selected as a centre for distributing VGD rice to ensure security of the beneficiaries.

# Over 400 Shibir

# Solar irrigation pumps to be installed in northern, southern dists

More than 20 solar irrigation pumps will be installed in the country's northern and southern region under the private sector soon.

According to official sources, Infrastructure Development Company Limited (IDCOL) initiated a project under which private investors will set up 22 solar power run irrigation pumps, each having around eight kilowatt capacity.

The power ministry designed the project as part of the government's plan to increase up to 5 percent electricity generation through solar system by 2015.

The IDCOL, a government financing agency founded with the help of donor agencies, was entrusted with the responsibility of implementing the project due to its long experience in successful implementation of the solar home system project.

The sources said that the government planned to install 1,500 solar-powered irrigation pumps across the country to reduce its dependence on diesel-run irrigation the programme on the basis of management pumps by 2016.

The original plan is to install a total of finance experience. 10,000 solar-powered irrigation pumps across the country to replace all the dieselrun pumps, they said.

"The 22 solar powered pumps are the first batch of the government's such initiative, of which 2-3 have already been installed," said Siddique Zubayer, a consultant of the power ministry on renewable energy affairs.

He informed that under the project, pri-

vate sponsors will have 20 percent equity investment while they will get 40 percent grants and 40 percent concessional loan at lower rate of interest to make the project viable.

"We hope, the farmers will get water from their next irrigation which will start from August-September," he added.

The aim of the project is to supply water to farmers at an affordable cost and replace their present system of drawing water through diesel-run pumps.

Power ministry officials said, the capacity of solar irrigation pumps being used for irrigation purpose is in the range of 5-11 kW. Under the programme, solar irrigation pumps with an average capacity of 8 kW will be installed which will operate at total head of 12-15 metre.

The pump of this size is capable of lifting 500,000 liters of water per day in local solar irradiation condition.

They said, the IDCOL will select some NGOs, MFIs or private entities, known as partner organisations (POs), to implement capacity, financial strength and micro-

The POs will be responsible for selection of areas and target customers. They will install the pumps and supply water to the customers.

The power ministry officials also said that the IDCOL will provide necessary technical, financial and promotional support to the POs for successful implementation of the programme.
