The speakers were addressing a seminar titled, "The role of participation committee in ensuring safe working environment" at Osmani Memorial Auditorium in the capital.

Karmojibi Nari, an initiative of working women in Bangladesh, organised the seminar as a part of a two-day long fair arranged by the Ministry of Labour marking the May Day.

According to the labour law, any busi-

ness establishment with at least 50 work ers must form a participation committee with equal number of representatives from employers and workers.

The functions of a participation committee includes promotion of mutual trust, understanding and cooperation between employer and the workers; ensuring application of labour laws; and improving and maintaining safety, occupational health and working condition.

Mentioning that the concepts of trade unions and participation committees are different, Shipping Minister Shahjahan Khan said garment factory owners should not consider the committees as an alternative to trade unions.

Citing a government investigation report on 156 garment factories, Karmojibi Nari Coordinator Nasreen Ara Begum said around 40 percent of those factories do not have any participation committee.

# Dipu Moni defends labour safety steps

Foreign Minister Dipu Moni defended the government's initiatives to improve labour rights in the country while talking to Aljazeera on Wednesday.

The broadcaster interviewed the minister amid, what is said, "mounting pressure over perceived lax safety standards blamed for last week's deadly building collapse". In the April 24 Rana Plaza disaster, the death toll crossed 400

"There have been widespread accusations that safety regulations are both insufficient and rarely enforced in Bangladesh's US\$20 billion garment industry, as the collapse was only the latest in a string of deadly disasters," reports Aljazeera.

It quotes Dipu Moni as saying, "A 'culture of impunity had prevailed in the country for many decades, making many people - including owners of buildings and factories - feel they did not need to comply with laws and building codes.

"She said that since Prime Minister Sheikh Hasina Wajed's government came into power in 2009, it has been taking 'very stern action' against those who do not comply with laws.

"We have been working on improving labour standards; we have been working on improving safety conditions in workplaces; and we have been doing it in collaboration with the owners of the factories, with labour organisations and with international organisations."

The High Court yesterday granted ad-interim bail for six months to six BNP leaders in different cases filed on charges of vandalising vehicles, attacking police and blasting cocktails in early March.

The leaders are -- Mirza Abbas, Goyeshwar Chandra Roy, Abdullah Al Noman, Amanullah Aman, Rizvi Ahmed and Syed Moazzem Hossain

The HC bench of Justice Salma Masud Chowdhury and Justice Md Jahangir Hossain passed the orders after hearing separate bail petitions filed by the accused leaders on different dates in March and

April. The court also issued separate rules upon the government to explain why the petitioners should not be granted

regular bail in the cases. Mirza Abbas got bail in six cases, Goyeshwar in five, Noman in five, Aman in six, Alal in seven and Rizvi in one case.

Sagir Hossain Leon, a lawyer of the petitioners, told The Daily Star that four leaders other than Aman and Rizvi will now get released from jail following the HC orders.

Aman and Rizvi are accused in other cases, he said.

On March 2 and March 6, police filed the cases against the BNP leaders with Paltan, Ramna and Shahjahanpur Police Stations.

## Govt to establish regulatory authority

The government yesterday decided to establish a regulatory authority to enforce building code across the country.

Nagar Unnyan Committee headed by the public works secretary at a meeting yesterday formed a nine-member committee to find how to ensure enforcement of Bangladesh National Building Code, which is legally mandatory on any building construction.

The newly formed committee would start functioning with specific terms of refer-

ence and submit report within two weeks. Abu Sadeque, head of the committee, said their primary objective would be to make a proposal for a building regulatory authority to enforce the code out of purview

of four development authorities. The four development control authori-

ties, including Rajdhani Unnyan Kartripakkha, Chittagong Development Authority, Khulna Development Authority and Rajshahi Development Authority, are responsible for enforcing the building

code within their respective jurisdiction. Abu Sadeque, also director of Housing and Building Research Institute, said they would suggest forming a provisional committee to oversee compliance with the code

before forming the regulatory authority. The provisional committee would be led by local deputy commissioners, and it will be consisting of engineers of public works department and local government engi-

neering department, he added. He said they would also point out building approval authority entrusted in municipality ordinance conflicting with the provisions of Building Construction Act 1952.
