CHTC calls for full execution US talking labour of peace accord

Appreciating the statements made by the representatives of several states to implement the 1997 CHT Accord at the Universal Periodic Review (UPR) in Geneva, the International CHT Commission (CHTC) again urged the government to implement the accord in

At the second cycle of UPR on April 29, representatives of a number of countries called on Bangladesh to implement the accord in full and create a roadmap with a timeframe for its implementation.

They also called for immediate action to amend the Chittagong Hill Tracts (CHT) Land Dispute Resolution Commission Act 2001 to reflect the accord and to ratify the relevant ILO Convention No 169 and to protect the working on the CHT issues.

Says US State Department official DIPLOMATIC CORRESPONDENT

The US is actively engaged with the highest levels of Bangladesh government, exporters, and buyers on the issues of workers' rights and safe working conditions, a US official said on Wednesday. Asked whether any US companies sourced from gar-

ment factories housed in the building which collapsed near Dhaka on April 24, he said they understood that businesses operating in that building appeared to have links to numerous companies in the US and Europe.

"And so we'll continue to engage with US companies to discuss what role they can play in improving working conditions, including in Bangladesh," Patrick Ventrell, acting deputy spokesperson of the US State Department, told the media in Washington DC.

Ventrell said they had an ongoing dialogue with US buyers. "And so we continue to speak with many US companies that source from Bangladesh."

Asked if the US authorities have identified these companies, the spokesperson said some of these companies were already identifying themselves. "But we discuss these issues broadly with companies that operate in Bangladesh...And we do that at the assistant secretary level and the ambassador level regularly."

Ventrell termed the collapse a "really terrible tragedy" and said, "Our hearts continue to go out to the victims."

RESPONSIBLE FOR SAVAR DEATHS

Gonojagoron Mancha seeks highest penalty

The Gonojagoron Mancha once again roared with the demand for the maximum punishment on Wednesday, but this time it was for those responsible for the deaths of over 400 people and wounding of countless others in the Savar tragedy.

At a condolence meeting at the capital's Shahbagh where hundreds gathered to mourn the deaths, speakers there also demanded workers' right to form trade unions in all factories, particularly in the garments industry. The condolence meeting replaced a scheduled May Dayrally there. The nation observed May Day while

reeling from the shock of the death of workers in the collapse of Rana Plaza that housed five clothing factories.

Gonojagoron Mancha spokesperson must be treated as such."

Imran H Sarker said, "We demand that the state ensure the maximum punishment for all those responsible for the humanitarian disaster." He urged the state and citizens to stand beside the injured and the families of the deceased, and insisted that a comprehensive list of the wounded be prepared for their rehabilitation.

The anti-war criminal campaigners vowed to keep helping the wounded.

Workers' leader Shirin Akhter demanded compensation for the injured alongside the families of the deceased.

Terming the deaths at Savar as "murder", veteran cultural personality Kamal Lohani said the state, along with the factory and building owners, must also be held responsible. "Workers are not an ingredient for production. They are human beings and
