

Talora municipality election today

OUR CORRESPONDENT, Bogra

The first municipality election of newly declared Talora municipality under Dupchachia upazila area will take place today.

Returning officer and upazila nirbahi officer (UNO) of Dupchachia upazila Mamunur Rashid told this correspondent that the election will be held by EVM (Electoral Voting Machine) so that locals can cast their votes in a smooth and fair way.

He said that there are 7 candidates for Mayoral post, 41 for 9 councillor posts and 13 for 3 reserved women seats while two mayoral candidates withdrew their candidatures.

Sources said that the Mayoral candidates in the election include Amirul Islam Bakul (AL-backed), Khandaker Abdul Jalil (BNP-backed) and Nazrul Islam (Jamaat-backed), Aulia

Khanom (BNP-backed) and the rest three are independent candidates.

However main competition will take place between AL and BNP candidates, they said.

BNP and Jamaat backed candidates are now in jail as they are accused in 10 cases in connection with Bogra violence on March 03. BNP backed Aulia Khanom is the wife of BNP backed candidate Khandakar Abdul Jalil, they said.

As many as 12,925 people are expected to cast votes in 36 booths at 9 centers. District Election Officer Monzurul Alam said his office took all steps for holding today's mayoral election peacefully.

Superintendent of Police (SP) of Bogra Mozammel Haque said that the district and police administration have stepped up security measures to avert any unwanted situations during the election.

Man to die, two get life for killing boy

A court in Sirajganj district on Monday sentenced a man to death and life term imprisonment to two others for killing a child after abduction.

Abdul Awal, son of Majid Musalli of Tamai village in Belkuchi upazila, was given capital punishment with a fine of Tk 10,000.

Kamal Hossain, son of late Khorshed of Kurmushi village and Samej Uddin, son of late Shaher Ali of Salenga village of Sadar upazila of Tangail district, were jailed for life. They were also fined Tk 5,000 each, in default, to suffer six months more RI.

According to the case, the three kidnapped Maksudul Haque, 6, son of Sarwar Hossain of Tamai village in Belkuchi upazila from near his house on May 8, 2010.

Later, police recovered the body of the boy from under Amtoli Bridge in Ghatal upazila of Tangail district.

The father of the boy filed a case with Belkuchi police station the next day.

All the three were later arrested by police.

After examining the witnesses and records, Umme Kulsum, Additional District and Sessions Judge, handed down the verdict in presence of the accused.

Wife remanded in expat killing case

A court here on Monday placed a woman on a two-day remand in a case filed for the killing of her expatriate husband.

Police produced Kulsuma Begum, wife of Saudi expatriate Bahar Uddin, 32, before the court of Senior Chief Judicial Magistrate Habibur Rahman Chowdhury with a five-day remand prayer. The court however, granted two days of police remand.

Earlier, Bahar married Kulsuma, a part-time teacher at Dubag Ideal High School, over cell phone while he was in Saudi Arabia.

On April 1, the man returned to Bangladesh to hold a function on marriage ceremony.

On April 10, police recovered the body of Bahar, son of Moynul Islam Moyna of Goylapur village of Bianibazar upazila, from Charia Ghat area of the upazila, two days after he went 'missing'.

The body bore several injury marks, said police.

The victim's father filed a case against nine people including, Kulsuma, in this connection.

Sources said, after the marriage, the couple frequently locked in quarrels as Bahar after found his wife busy on her cell phone when he dialed her from abroad.

Police suspected that Bahar might have been killed by criminals due to his wife's extramarital affair with another man.

Boy rescued two days after abduction

A four-year-old boy, kidnapped by a gang for ransom, was rescued on Monday, two days after his kidnapping.

Police said, Sheuly Akhtar kidnapped Junayed Siddiqui Dinan, 4, son of Jamilul Islam of Boro Songolshi village in Sadar upazila, from in front of his house on Saturday afternoon.

Later, the kidnapper, over cell phone, demanded a ransom of Tk four lakh from the boy's family.

Police said Sheuly, 22, daughter of Moktar Hossain of Chhotodhar village of Atwari upazila of Panchagarh district, kidnapped the boy aided by Indian citizen Osman Molla.

The boy's father the same night filed a case against Sheuly and Osman with Sadar police station in this

connection.

The kidnappers were taking the victim to India.

Being informed by Daudpur BGB camp in Birampur upazila of Dinajpur district, Indian Border Security Force (BSF) early Monday rescued the child and also held a kidnapper when they entered India through Daudpur border in Birampur upazila of Dinajpur district, reports our Dinajpur correspondent.

The BSF handed over Junayed and Sheuly to BGB at a flag meeting between BGB-BSF along Daudpur border on Monday morning.

Osman Molla was handed over to Indian police because of his Indian nationality, said BGB sources.

The child was handed over to his family while Sheuly to Birampur police.

Storm lashes 2 upazilas of Feni, 50 houses damaged

Lightning kills 7 in 3 districts

A severe storm lashed several villages in Sadar and Sonagazi upazilas of Feni district yesterday, reports our correspondent.

Local administration and villagers said, the storm hit the areas at around 9:30am blowing away at least 50 houses, schools and other structures.

It also damaged standing crops and uprooted many trees, they said.

In Netrakona, at least three people were killed and five others injured by lightning at Gatua under Madan upazila yesterday morning, reports our correspondent.

The dead were identified as Abdul Alim, 42, Mojibor Rahaman, 48, and Shahjahan Ali, 55, of Fikna village under Sharishabari upazila of Jamalpur district.

Police said they had come to Madan as farm labourers for harvesting paddy 15 days ago.

Locals said lightning hit them when the eight were working at paddy field at Gatua Haor (water body).

Alim, Mojibor and Shahjahan were killed on the spot and five others were injured.

In Bagerhat, a man and his son were killed in lightning strike in Morrelganj upazila on Monday night.

Md Iliyas Sheikh, 32, and his son Yasin Sheikh, 5, died on the spot when the thunder struck their house at Sonakhali village at around 8:00pm on Monday.

In Jamalpur, a youth was killed by lightning while an elderly man died of heart failure due to violent sound of lightning in Bakshiganj upazila yesterday morning, reports our correspondent.

The deceased were identified as Sanuar Hossain, 25, son of Abdur Rahman of village Shekerchar under Merurchar union and Nurul Islam, 50, of village Ghasirpara under Bogerchar union of the upazila.

Locals and police said Sanuar was killed while harvesting paddy at his field at around 9:00am and Nurul died of heart attack because of the big bang of the lightning.

Two others injured are Mustafizur Rahman, 8, of Uttarbazar area in the upazila town and Mahima Khatun, 40, wife of Abdur Razzak of village Bogerchar under the same upazila. They were admitted to the upazila health complex.
