3 killed in gunfight

At least three people, including a UP chairman, were killed and 25 others injured in a battle for supremacy between two groups of people at Jamirtoli village in Laxmipur Sadar upazila yesterday.

The deceased were identified as Nur Hossain Shamim, 35, Dattapara Union Parishad chairman, his bodyguard Delwar Hossain, 30, and one villager Muslim Uddin, 40. Quoting locals, Altaf

Hossain, officer-in-charge of Laxmipur Sadar Police Station, said there had been a longstanding conflict between Asaduzzaman Babul of Jamirtoli village and UP Chairman Nur Hossain Shamim.

Following the conflict, supporters of the two groups clashed and traded bullets yesterday noon. At one stage, Shamim shot

Muslim Uddin, who is a loyal to Asaduzzaman Babul, dead. Several people received bullets. Later, wounded Shamim

and his bodyguard Delwar took shelter in a house of Jamirtoli village. The locals caught them and beat them to death,

Bullet-hit Lokman, Sohag, Azad, Rakib, Jamal, Kamal, Shahid, Sumon, and Shanto were admitted to Laxmipur Sadar Hospital in a critical condition.

Senior Judicial Magistrate Tajul Islam, meanwhile, placed him on an eight-day remand in two separate cases for possession of an illegal firearm and drugs, filed with the Dhamrai police station on May 6.

Rana was produced before the courts after expiry of his previous 13-day remand in connection with two cases -- one filed for the deaths of 1,127 garment workers, and the other for violation of the building code filed by the Rajdhani Unnayan Kartripakkha.

Detective Branch Inspector Mir Shahin Shah Parvez, investigation officer of the cases, primarily sought a seven-day fresh remand in the death and damage case. DB Inspector

Wahiduzzaman Molla and Sub Inspector Towhidul Alam from Dhamrai, on the other hand, had asked for five and seven days separately to grill the suspect. Rana could not appoint a

lawyer to defend him in court as the Dhaka Bar Association decided earlier not to provide him with any legal support after considering the gravity of the offences. Rab arrested Rana from

Benapole on April 28 -- four days after the collapse.

The police, so far, have arrested 11 others in connection with the disaster.

"As such, it should not be linked to a storm,' Mahindananda Amaraweera, disaster management minister of Sri Lanka, was quoted as saying by Ceylon Today on Tuesday.

The online Colombo Page said the Meteorology Department's announcement came following protests by the Sinhala Buddhist organisation, Ravana Power, over the use of the king's name for the cyclone.

Ven Ittekande Saddhathissa Thero, secretary of Ravana Power, termed the decision to use the name for the cyclone as foolish.

He further said the organisation would not oppose the naming of the cyclone as 'Prabhakaran', after the slain leader of Liberation Tigers of Tamil Eelam (LTTE), the Tamil Tiger terrorist organisation which led a three-decade

war till its defeat in 2009. S R Jayasekara, director in-charge of weather forecasting, however, defended the concept, saying the name was suitable since cyclones rendered a service by taking away heat from the tropical areas and causing rainfall to provide water for cultivation.

Mahasen ruled Sri Lanka from 277 to 304 AD. He pioneered the construction of large irrigation reservoirs in the country.
