

Another injured in Jurain crane fall dies

Another injured person of the freak accident in the capital's Jurain where a crane accidentally fell on onlookers on Sunday night, died early yesterday.

The deceased, Shafiqul Islam, 26, was being shifted from Mitford Hospital to Labaid Hospital, said Shyampur police Sub-inspector Krishna Das.

So far four persons, who were watching the activity of a crane pulling an accident-wrecked truck, died, when the crane was unable to bear the truck's weight, and overturned on the onlookers.

The accident occurred when the hoist and the chains of the crane came loose failing to bear the weight of the goods-laden truck that overturned on the road around 8:00pm, said Officer-in-Charge Abdur Rashid.

12 hurt as BCL, JCD clash at CU

At least 12 Jatiyatabdhi Chhatra Dal (JCD) activists were injured in a clash with Bangladesh Chhatra League (BCL) men in Chittagong University (CU) area yesterday.

The injured, Nurul Huda, Hasan, Junayed Hossain, Newton Dutta, Sharifullah Sabuj, Ali Ahmad Rocky, Salauddin Shahdat Hossain, Mohammad Sohel, Mizan Uddin, Ruhul Amin and Arafatul Alam, were admitted to Chittagong Medical College Hospital and different clinics.

Witnesses said the clash erupted around 2:00pm when BCL men attacked JCD activists who brought out a procession at the university railway station protesting the arrest warrant issued against BNP Senior Vice President Tarique Rahman.

HC issues contempt rule against authorities concerned

The High Court yesterday issued a rule upon the authorities concerned to explain in four weeks why contempt of court proceedings should not be brought against them for not complying with its order to remove illegal structures from Dhamondi playground.

Secretaries to the ministries of housing and public works, cultural affairs, administrators of Dhaka (North and South) City Corporation, chairman of Rajuk, inspector general of police, officer-in-charge of Dhamondi police and president of Sheikh Jamal Dhamondi Club Manzur Kader have been made respondents to the contempt of court rule.

The court issued the rule following a petition jointly filed by Bangladesh Paribesh Andolon and Institute of Architects, Bangladesh.

Petitioners' lawyer Raisul Islam said the HC on March 15, 2011 had directed the respondents to demolish the illegal structures from Dhamondi playground within 15 days, but they did not execute the order.

Man dies after falling from rooftop

A man died after falling from the roof of his house on Abul Hasnat road in the capital's Bangshal area.

The victim is Mohammad Selim, 48.

Deceased's wife Rasheda Begum said the rooftop of their five-storey building became slippery following recent rainfall. Selim slipped and fell on a tinshed house while he was trying to catch one of their pigeons.

An unnatural death case was filed with Bangshal Police Station.

Biman to lease four more aircraft

Biman Bangladesh Airlines has almost finalised arrangements to lease four wide-body aircraft to join its eight-aircraft fleet before Hajj, at the beginning of September, Biman Managing Director Kevin J Steele said yesterday.

Steele, also the Biman chief executive officer, also highlighted his two-year strategic plan, which the prime minister recently approved, to see profits in fiscal year 2014-15. Biman last made a profit, Tk 5.91 crore, on fiscal year 2007-08.

The strategy includes doubling the fleet to 16 aircraft in two years, bringing massive improvements in punctuality and customer services, and selecting strategic partners and undertaking several joint ventures in ground handling and other areas.

It also includes starting domestic flights from November, from Dhaka to Cox's Bazar, Rajshahi, Jessor, and Saidpur and morning and evening flights from Dhaka to Sylhet and Chittagong.

He said 56.2 percent of Biman flights, from May 1 to 25, departed on time, the best performance in the last two years.

Youth shot dead in capital

A youth was killed as unidentified assailants shot him on Bagdasha Lane in the old part of the capital early yesterday.

The deceased was Faisal Hossain, 25.

Police recovered the body and sent it to Sir Salimullah Medical College morgue.

The body bore three bullet injuries, morgue sources said.

The victim's family filed a murder case with Bangshal Police Station accusing two men - Quaiyum and his friend Jhantu.

Abdul Quddus Fakir, officer-in-charge of the police station, said no arrest had been made as yet in connection with the murder.

MOLESTING WOMAN IN FRONT OF COPS Court orders arrest of cop, four others

A Dhaka court yesterday issued arrest warrants against an assistant commissioner of police and four others in a case filed against them for molesting a 41-year-old woman in April this year.

The accused are Mohammad Minhajul Islam, assistant commissioner of Demra zone, Md Sabbir Hassan Khan Milon, managing director of Trinity Real Estate Ltd, Mamunur Rashid and Md Azizur Rahman, directors of the real estate company, and Md Aminur Rahman Amin. Judge SM Rezanur Rahman of the Third Tribunal for Prevention of Women and Children Repression of Dhaka issued the order.

The court directed the officer-in-charge of Ramna Police Station to submit a report to it by June 9 after making the arrests.

In her complaint, the woman told the court that on February 22, 2010 she entered into an agreement with Trinity Real Estate Ltd and bought a flat.

On April 7, Minhajul along with four to five assailants went over to her flat claiming that he bought the same flat and told them to vacate it. Minhaj's accomplices ransacked the flat. Moreover, they dragged the complainant's husband to another room at gunpoint and forced him to sign on a white paper.

The complainant also accused Milon and Rashid of violating her in presence of the police official.


