# Marooned inside DND

Lack of pumps, blocked drainage, encroachment extend inundation

Since the spell of torrential rain a few days ago, tens of thousands of people have been marooned within the Dhaka-Narayanganj-Demra (DND) embankment area due to a clogged drainage system.

Even though four days have gone by since the rain stopped, most houses and establishments there are still under knee- to waist-deep water as channels to drain the water to a nearby river are blocked at several places.

Locals blame unplanned houses and buildings in the wetlands, illegal encroachment of low-lying areas, insufficient water pumps to remove water and lack of regular cleaning of the drainage canals for the situation.

The authorities concerned, however, said they did not have adequate pumps to handle so much water.

While visiting the DND area, this correspondent found the canals clogged by overgrown grass, water hyacinth and garbage. At places these had become dense enough to stand on.

All roads, schools, mosques and other establishments in the area are now under knee-deep water. The streets are under water too and rickshaws and auto-rickshaws cannot ply anymore. People use boats for movement.

The residents of Wapda (Water and Power Development

## Trial to be held in absentia

The International Crimes Tribunal-2 yesterday decided to hold the trial of "Al-Badr leaders" Chowdhury Mueen-Uddin and Ashrafuzzaman Khan in absentia.

The two are accused of being involved in the killing of bright minds of the country at the fag end of the Liberation War.

The three-member tribunal led by Justice Obaidul Hassan with members Justice Md Mozibur Rahman

Miah and Judge Md Shahinur Islam decided to go for trial in absentia, as its attempts to have the accused in court had failed.

The court on May 2 issued arrest warrant for them and later asked them to show up at court through newspaper ads.

Chowdhury Mueen-Uddin and Ashrafuzzaman Khan are living in London and New York. They were, according to post-liberation newspaper reports, two of the most wanted

criminals accused of killing the bright minds of the country.

Yesterday, the tribunal also appointed two Supreme Court lawyers -- Abdus Shukur Khan and Salma Hai Tuny -- to defend the fugitives.

Mueen-Uddin and Ashrafuzzaman's case would be the second case to be tried in absentia of the accused. The trial of expelled Jamaat-e-Islami member Abul Kalam Azad, AKA Bachchu Razakar, was also

## BB to create fund for small investors

The central bank yesterday decided to set up a refinancing fund to compensate small investors hit hard by the stockmarket crash.

The fund will be made with the government's profits from Bangladesh Bank in the current fiscal year, a senior official said, referring to an outcome of a meeting of BB board.

BB has estimated that its profit by the end of this fiscal year will rise to Tk 4,000 crore, up from Tk 2,500 crore in the previous fiscal year.

The size of the fund has not been finalised yet though the finance ministry asked the banking regulator to make a fund to the tune of Tk 1,266 crore.

## HC clears way for Mahmudur's trial

The High Court yesterday cleared the way for continuing the trial of a corruption case against daily Amar Desh's detained acting editor Mahmudur Rahman.

It did so by vacating its earlier order that had stayed the case proceedings.

On June 13, 2010, the Anti-Corruption Commission filed the case against him with the capital's Gulshan Police Station for not turning in wealth information.

Earlier on April 19 that year, the ACC issued a notice asking him to submit his wealth statement within seven days.

Following a petition by Mahmudur, the HC passed the stay order on September 28, 2010, and also issued a rule upon the ACC to explain why the case proceedings should not be quashed.
