Demand for Arrears, Passports

Bangladeshis end demo in KSA

Around 2,000 Bangladeshi workers, who demonstrated demanding that their passports be released and arrears be paid in Jeddah of Saudi Arabia on Monday, joined their work after interventions of Bangladesh Consulate yesterday. Mokammel Hossain, labour counselor at

the consulate in Jeddah, said they had talked to the workers and authorities of the company, Initial Saudi Group.

"There were some labour problems. We intervened, and all of them joined work today morning," he said.

Most of the workers have been working as cleaners in the Kingdom for six years. But their company has not renewed their residency permits (igamas) in the last three to five years, nor allowed them to transfer their jobs to other companies, Shapan Sayed Ali, a protesting worker told the Arab News on Monday. Fearing that they would be repatriated

back their passports. Earlier on May 10, the government of Saudi Arabia announced amnesty, which allowed irregular foreign workers to legalise their status

without paying arrears, they wanted to get

or return home without getting penalised. Bangladesh Consulate's Mokammel said the workers were trying to change jobs aimed at getting higher-salary jobs, taking advan-

tage of the amnesty, which will end on July 3. "Actually, 1,200 of the workers have valid residency permits, and the company was renewing residency permits of the rest slowly. We asked the company to renew residency permits fast, and they agreed," he

Municipalities lack decision making capacity: Experts serious structural faults, he added.

Adequate capacity building within the Savar municipality could have prevented the Rana Plaza tragedy, former adviser to a caretaker government Dr Hossain Zillur Rahman said at a conference yesterday. He said capacity building was inclusive

of resource implementation for human resources development. Insufficient policies that cripple the local government institutions from making important urban planning decisions are another reason, he added. Zillur said even abundant resources

could fail to be effective if the necessary policies were not in place allowing utilisation of funds to enhance the decisionmaking capability of the micro-governance bodies. Rana Plaza is an example of the Savar

municipality's impaired decision-making capacity, where it only had the right to assess the layout plan but not the building's construction, said Shamim al Reza, secretary general of the Municipal Association of Bangladesh. As a result, the building had

The nine-storey Rana Plaza crumbled on

April 24, killing 1,129 people. The conference titled "National Budget

and Local Government" alleged that financial constraints had contributed to poor human resources within the municipality, which led to the neglect of necessary monitoring activities. The experts said while the size of Annual

Development Programme rose from Tk 55,000 crore to Tk 65,000 crore this fiscal year, the local government's claim on the money dropped to 2.01 percent from 2.44 percent in the previous year. Dr Rahman demanded that in cases where the implementation was executed by

the local government bodies, the resources should be given to them as well instead of passing them through the bureaucracy. Dr Amirul Islam, professor at Jahangirnagar University, stated that the

bureaucracy was the biggest bottleneck in the smooth flow of resources. The conference was organised by the

Municipal Association of Bangladesh in the capital's Cirdap auditorium.

She stated that she had heard about the




