

Stone lifting from Teesta threatens irrigation, dyke projects

Illegal stone lifting from the Teesta in the upstream of the Teesta Barrage threatens the country's largest irrigation project at Daliya village in Hatibandha upazila of Salmonirhat district and an under construction dyke on Bangladesh-India border at Char Tepa Khoribari village in Dimla upazila of Nilphamari district.

A group of locals in collusion with a section of Water Development Board (WDB) officials have continued the callous act for a month, locals said.

At least 50 dredgers are engaged to do the work round the clock but there is no action from the WDB authorities, police or upazila administrations of Hatibandha and Dimla upazilas, they said.

On May 23, a team of Border Guard Bangladesh led by Rangpur Sector Commander Col Niyamul Islam Fatemi seized six dredger machines beside the under construction dyke at Char Tepa Khoribari village of Dimla upazila.

"An organised gang illegally lift stones with dredgers from the river. The machines create sound pollution in the area. But the local people can't protest it as the gang has connections with the ruling party leaders and government officials," said Azizul Islam, 42, a schoolteacher at Daliya village.

"Illegal stone lifting beside the under construction dyke on Bangladesh-India border in Dimla upazila also affects my union [Sanyazan] and two other unions of Hatibandha upazila," said Mohammad Enayetullah, chairman of Sanyazan union parishad (UP).

"If the illegal stone lifting continues, the under construction dyke is likely to collapse during the rainy season and it will bring untold sufferings to several thousand families in these unions. Locals complained to the authorities of Water Development Board at Daliya but no action has been taken yet," he added.

Jamal Uddin Bulu, chairman of Goddimari UP of Hatibandha upazila, said, "The WDB authority at Daliya can take legal action with the help of the upazila administration and the police anytime but it is not being done due to unknown reasons. Illegal stone lifting poses serious threat to Teesta Barrage and the under construction dyke and leaves several thousand people in my union vulnera-

ble to erosion and flooding by the Teesta River."

Contacted, Mahbubur Rahman, executive engineer of WDB at Daliya, said they have already stopped illegal stone lifting from the Teesta River beside the under construction dyke.

"A group of people backed by the ruling party leaders are lifting stone from different places near the Teesta Barrage. WDB officials cannot fully stop illegal stone lifting from the river without the help of local administration and the police," he added.

ASI closed for bribery

Youth gets life for murder

A court in Joypurhat district yesterday sentenced a youth to life term imprisonment for murdering his friend. The convict is Touhidul Islam Sohel, 19, son of Shahin Master of Shantinagar in Sadar upazila. The court also fined Sohel Tk 20,000, in default, to suffer more two years in jail. Additional District and Session Judge AKM Shahid Iqbal Ahmed handed down the verdict in a crowded courtroom. Other two accused in the case were acquitted of the charges. According to the prosecution, Shadhan Kumar Das, 19, son of Ruma Das of Shantinagar village, was killed on 8 November, 2009 following an altercation over a mobile phone. A murder case was filed accusing three people including Sohel.

Elderly woman abducted

An elderly woman was abducted from Ananda Nagar village in Shailkupa upazila yesterday. Identified as Lipi Begum, 54, she was mother-in-law of Rafikul Islam, general secretary of 56 NO ward BNP and vice president of Bangabazar Market Committee in Dhaka. Rafikul was murdered in the capital on January 5 this year. Officer in-charge Anwar Hossain of Shailkupa police station said, a gang of 4/5 in a microbus picked up Lipi when she was going to Ananda Nagar Bazar from Sheikhpura at 12:30pm.

Toxic mangoes destroyed

A mobile court in a drive here yesterday destroyed formalin mixed fruits including mangoes and grapes. The court, led by executive magistrate Md Mobarak Hossain, also fined the fruit traders Tk 29,800. The magistrate said, they raided Bahadurbari and Dinajpur Fruit markets in the town and seized about 435 kgs and 36kgs formalin-mixed mango and grapes. Later, those were destroyed, said the magistrate.

Youth stabbed to death

A youth man was stabbed to death by district town on Wednesday afternoon. The deceased was identified as Mintu Hossain, 33, son of Abdul Hamid of Poilapnur area of the town. Police sources said Mintu had a longstanding dispute with a local group over toll collection at Poilapnur tempo (human hauler) stand. A gang of 4-5 swooped on Mintu in front of the tempo stand around 6:30pm and stabbed him indiscriminately, leaving him critically injured. He was rushed to Pabna Medical College Hospital where doctors declared him dead.

Settlers enforce blockade in 3 hill dists

Parbatya Bangalee Chhatra Parishad (PBCP) enforced a daylong roads and waterways blockade in three hill districts yesterday, demanding cancellation of CHT Land Commission Act amendment proposal passed by the cabinet on Monday.

The leaders of PBCP, a platform of Bangalee settlers, announced the blockade programme through a press conference on Tuesday.

In Khagrachhari, the PBCP activists blocked the roads by burning tyres at Shapla Chhattar, municipality bus stand and some other points in the town. Inter-district and local buses were off the roads during the programme.

A chase and counter-chase between police and pickets took place in Shapla Chhattar area at around 8:30am. Police picked up PBCP member Masum Rana from the spot.

Police Superintendent Sheikh Mizanur Rahman told this correspondent that PBCP-enforced blockade in the district ended peacefully.

BSF picks up cattle trader

Members of Indian Border Security Force (BSF) picked up a Bangladeshi cattle trader from Madenipur border in Jibannagar upazila on Wednesday.

The victim was identified as Rezaul, 30, son of Tahajol Vangri of Hariharanagar village.

Major Mehedi Hasan, deputy commander of Chuadanga-6 Battalion BGB, said a BSF team from Putkali border picked up Rezaul when he along with four other cattle traders entered the Indian territory through Madenipur border in the morning to bring cattle.

However, other cattle traders managed to flee.

After the incident, at a flag meeting at zero point in the afternoon, BSF informed BGB that Rezaul was handed over to Kristagaya police of India on charge of intrusion.

3 defeated candidates finally file writ

Three candidates defeated in the by-election for the mayoral post of Magura municipality have jointly filed a writ petition with the High Court (HC) division of the Supreme Court, challenging the election results.

The candidates are Awami League (AL) backed Khurshid Haidar Tutul, BNP backed Dr Mahabubul Haque Siddiquee and Jatiya Party (JP) backed advocate Hasan Seraj Suja.

In the petition filed on May 27, the candidates rejected the gazette notification issued by the Election Commission on May 16, declaring Iqbal Akhtar Khan as mayor of Magura municipality.

The petitioners also stated that 19 presiding officers (POs) out of the 31

were appointed from Magura Government Huseyn Shahid Suhrawardy College in a bid to influence the election.

The presiding officers forced the polling agents to remain out of the booths for about 15 minutes before counting ballots, they alleged.

On May 11, the defeated candidates held a joint press conference where they formally rejected the election results, alleging manipulation.

Court again turns down Pintu's petition for bail


A Tangail court yesterday again rejected the bail petition of BNP central leader and former deputy minister Abdus Salam Pintu in an extortion case.

He was produced in the court of Senior Judicial Magistrate Sheuly Rani Das, who rejected the bail petition and sent him to jail. The same court on April 25 rejected Pintu's bail prayer in the case and sent him to jail.

Local AL worker Zahidul Islam Bhuiyan alias Lebu filed the case against Pintu and 10 others with Bhuapur Police Station on October 13 last year.

In the case statement, the complainant stated that a gang of 10 on the instruction of Abdus Salam Pintu stormed into his house on October 1, 2001 and demanded Tk 3 lakh from his wife Flora Begum.

Of the 10 other accused, eight were earlier granted bail by the High Court while the rest two are now staying abroad, police said.

As she refused to oblige, the gang vandalised the house and took away money and other valuables, the complainant added.

Pintu, one of the accused in the case for grenade attack on Awami League (AL) rally in the city on August 21, 2004, was brought to Tangail from Dhaka Central Jail in a prison van on Wednesday night.


A mobile court here yesterday sentenced a youth to three months imprisonment for harassing a schoolgirl sexually.

Upazila nirbahi officer (UNO) in Bhuapur Mohammad Helaluzzaman Sarker, delivered the verdict against Mohammad Mamun, 25, son of Abu Bakar of Pach Tikri village in Ghatai upazila.

Abu Obaida, officer in-charge (investigation) at Bhuapur police station, said Mamun abused a student of Bhuapur Pilot Girls High School physically on a lonely road when she was returning home from a coaching center at around 9:00am.

Police detained Mamun and produced him before the UNO after the girl and her mother lodged a complaint against him over the incident.

Later the mobile court, headed by the UNO, handed down the punishment.
