# Woes of sharecroppers

They irrigate the crop fields bearing almost all costs but get half of the produce


A large number of sharecroppers in the district lead hard-pressed life as they have to give half of the produces to the landowners and bear most of the cultivation costs, especially irrigation.

As per agreement, 50 percent of the crop produced by a sharecropper has to be handed over to the landowner. Besides, sharecroppers have to bear almost all the costs to produce crops, especially paddy.

In some cases, the owner shares half of the cost of seeds and fertilisers but the responsibility of irrigating the land always remains with the sharecropper.

"We the sharecroppers can keep only a small portion of our produce after paying the shares of the landowners and meeting the demands of the irrigation service providers. Often meet family requirements, including food," said Ashraf Ali of Kakina village of Kaliganj upazila.

"I produced 53 maunds of boro paddy from three bighas of land that I rented from a landowner in the village. After harvesting it last week, I gave half of the amount to the land owner," said Nishi Kanta Ray, 55, at Durakuti village in Lalmonirhat Sadar.



we have to do other jobs to Sharecropper Ahmed Ali of Haratal village in Lalmonirhat Sadar upazila. He is frustrated as he has to give half of the harvested boro paddy to the landowner.

> "I as well as three other members of my family work hard on rented farmlands to save the cost of employing labourers," he added.

"The amount of crop that remains after paying the share of landowner seems too insufficient as I have to spend a good amount of money to hire the shallow machines for irrigation and

buy inputs and other materials including pesticides," said Ahmed Ali, 55, a sharecropper at Harati village in Lalmonirhat Sadar upazila.

With hardly any scope to get bank loans, sharecroppers are often compelled to borrow from moneylenders at exorbitant interest rates and it eventually adds to Agriculture Extension in their woes, said Rajoni Lalmonirhat.

# Land grabbers force out family of day labourer

Land grabbers took away a piece of land of a day labourer at Rajnagar village in Baufal upazila on Wednesday.

Claiming the ownership of the land, a group led by Alauddin Shikder, 40, Russel, 20, and Shahid, 28, vandalised the house of day labourer Sattar Matabbar on the land and forced him and his family members to leave the area.

Locals said Alauddin and his accomplices illegally occupied 0.59 acres of land belonging to Sattar Matabbar on Wednesday morning and then erected a structure on it (land).

Sattar, who along with his family took shelter at a slum in the district town on Wednesday, filed a complaint with the superintendent of police (SP) the following day. He also lodged a case with the Speedy Trial Tribunal of Patuakhali the same day, accusing Alauddin and eight others.

Talking to this correspondent yesterday, Sattar said he bought the land

from a villager on January 11, 1966 and had been living in a tin-shed house on the land since 1995.

"Recently, Alauddin, Russel and Shahid claimed the ownership of the land and asked meto leave it," he said.

On receiving the complaint, the SP asked the officer in-charge of Baufal police station to take necessary action after proper

Contacted, Alauddin said they are the real owners of the land. But he refused to show any document in this regard.



### Two housewives murdered

Two housewives were murdered, one of them for dowry, in Jessore and Panchagarh districts on Friday.

A housewife was murdered allegedly by her husband for dowry in Jhikorgachha upazila of Jessore district, reports our Benapole correspondent.

The deceased was identified as Halima Khatun, 25, a master's final year student at Jessore MM College and wife of Akimul of Nayra village in the upazila.

Police said, Halima, daughter of Liakat Ali of Putkhali village in Benapole, was married off to Akimul eight months ago.

Liakat Ali alleged that Akimul had been putting pressure on their family to pay him Tk15 lakh he (Akimul) had demanded earlier as dowry.

Later Liakat give Akimul Tk2 lakh as dowry. But as he failed to give the rest of the money

Akimul strangled his daughter, he said. Being informed, police recovered the body. Akimul went into hiding after the killing.

In Panchagarh, a mother of two children was found dead in a bamboo cluster at Sikarpur Chochpara village under Boda upazila on Friday, reports our Thakurgaon correspondent.

The deceased was identified as Anufa, 35, wife of Dhajiruddin of the same village. Police and locals said, after taking meal at

about 11:00pm on Thursday Anufa went to bed with her husband and children in their room.

Finding their mother absent in the room at about 6:00am, the children awakened their father. At one stage of searching, Anufa was

found dead in a bamboo cluster near their house. Police detained husband Dhajiruddin for

interrogation in connection with the murder.

Officer in-charge of Boda police station Md. Asraful Islam told this correspondent that the housewife was murdered after torture as several injury marks were found in her neck, face and other parts of the body.
