BSF picks up Rab informer

Indian Border Security Force (BSF) on Saturday picked up a member of Bangladesh's Rapid Action Battalion (Rab) from an Indian village near Brahmanpara upazila of Comilla, an Indian newspaper reported yesterday.

A court in Sonamura of Seepahijala district, West Tripura charged the arrestee, Mohammad Milon Hussain, with violating the Indian Passport Act and sent him to judicial custody for two weeks.

Contacted, Rab chief Mohammad Mukhlesur Rahman denied Milon being a member of the elite force. He claimed the arrestee to be an informer of Rab.

According to The Hindu report, Milon intruded into the village of Rahimpur in India with a mission to search for a consignment of Phensedyl, a contraband drug smuggled into Bangladesh in large quantities.

Timir Das, additional superintendent of police in Seepahijala, India, told The Hindu, "The villagers caught one Rab man while the rest fled across the border." He said caught with his official identity card, Milon had

informed the BSF and police that his team had been headed by a senior Rab officer, Mohammad Kamruzzaman. Timir Das also claimed to The Hindu that Milon like his

fellow soldiers had been armed, but he threw the weapon towards his fleeing colleagues when he was caught. Against this backdrop, Border Guard Bangladesh and BSF

had held a flag meeting where BGB refused to confirm the identity of Milon and did not offer to bring him back, said The Hindu report. A BGB official seeking anonymity said although Milon was

not a Rab member, BGB personnel had still held the flag meeting. However, the meeting could not have Milon released.

The zoo authority planned to keep the rare birds for visitors to see.



Dhaka's biggest graveyard by Dec

Mirpur Martyred

Dhaka is going to have its biggest graveyard at Rayerbazar ready by December this year to meet growing demand for burial plots in the capital.

Dhaka North City Corporation (DNCC) took up the project in 2011 to accommodate around 80,500 burial plots, said a DNCC official. Bangladesh Army's 14

Independent Engineering Brigade has been implementing the Tk 505.60 crore scheme covering over 96.23 The Dhaka deputy com-

missioner's office has already acquired 77.39 acres and handed over to the DNCC last year, said an official at the DC's office.

The city currently has six official graveyards. Of them,

Jurain and Azimpur graveyards fall under the Dhaka South City Corporation (DSCC).

The four under the **DNCC** are Mirpur Martyred Intellectuals graveyard, Banani graveyard and one each at sectors 4 and 12 in Uttara. But these burial grounds cannot meet rising demand for burial plots in the city.

On an average, around 100 bodies are buried in Azimpur graveyard each day, some 35 to 40 in Jurain, around 30 in Mirpur and two to three in Banani, said city corporation offi-

About 20 bodies are buried in two graveyards at Uttara in a month.

On February 7, the tribunal asked Azad and Jamaat acting secretary general Rafiqul Islam Khan and the party's Dhaka city unit assistant secretary general Selim Uddin to appear before it and explain as to why contempt of court proceedings should not be initiated against them for their comments about the ongoing trials and the tribunal at a rally on February 4.

They never explained nor appeared before the court, which led the tribunal to issue arrest warrants.

Police arrested and produced Selim, but twice, on April 10 and again on April 21, told the court that the other two were on the run.

However, on May 4, Azad addressed a rally of the 18-party opposition alliance in the capital in the presence of hundreds of law enforcers and yesterday he showed up in parliament. When asked about

police not being able to find Azad despite his being in the public domain, Inspector General of Police Hassan Mahmood Khandker on May 4 told The Daily Star, "I'll have to tell you after checking it out. Officer-in-Charge

Habibur Rahman of Moheshkhali Police Station in Cox's Bazar said police were unable to find Azad in Moheshkhali, the place he was elected lawmaker from. He expressed surprised

at the fact that Azad was in parliament. He said since Azad did not return to Moheshkhali they could not arrest him.

The tribunal is likely to deliver the verdict in the contempt of court proceedings against the three Jamaat leaders on June 9. If Azad and the other two are found guilty, they could be imprisoned for up to one year and fined Tk 5,000 each.

Turkish Protest

PM blames social media, opposition

Thousands of protesters have controlled Istanbul's main square once more after two days of violent clashes with rampaging riot police, as Turkey's prime minister vowed to press on with the controversial redevelopment that provoked the clashes.

Calling the protesters an "extremist fringe", Recep Tayyip Erdogan blamed the opposition Republican People's party for provoking the protests.

"We think that the main opposition party, which is making resistance calls on every street, is provoking these protests," Erdogan said on Turkish television, as an estimated 10,000 demonstrators streamed into the area waving flags and calling on the government to resign.

"There is now a menace which is called Twitter,' Erdogan said. "The best examples of lies can be found there. To me, social media is the worst menace to soci-

Protesters again clashed with riot police into the early hours of Monday, Reuters reported.

In the western port of Izmir, protesters threw fire

bombs at the offices of the ruling AK party and television footage showed part of the building ablaze.

Bus shelters, paving stones and street signs were ripped up by protesters to make barricades that littered a major avenue in Istanbul where some of the heaviest clashes took place on Sunday night, Reuters said.
