An alleged robber was killed as police opened fire on his gang on Sreepur-Mawna road at Bakultala in Sreepur upazila of Gazipur early yesterday.

Identity of the deceased could not be known.

Sreepur police said around 15 people were trying to commit robbery by blocking the road.

When patrol police, in a rented microbus, rushed to the spot, the gang attacked them with sharp weapons, injuring Assistant Subinspector Sabuj Mia, 35.

Later, police opened fire on the miscreants killing one of them instantly.

However, the other robbers managed to flee the scene.

Police recovered a sharp weapon and a cellphone set from the spot.

The body was sent to Gazipur Sadar Hospital morgue for autopsy.

Haab to agitate for third carrier

Hajj Agencies Association of Bangladesh (Haab) yesterday threatened to wage tougher agitations if the government does not meet its demands by June 10. The demands include allowing a third carrier and

cancelling the newly introduced quota system for carrying hajj pilgrims. At a press conference in the capital's Jatiya Press Club,

Haab President Mohammad Ibrahim Bahar demanded that previous rules for carrying hajj pilgrims be reinstated. According to previous rules, each agency was entitled to

send a minimum of 50 and a maximum of 400 pilgrims. But the government has fixed 150 as the minimum limit for an agency this year, he said. Between 2001 and 2012, a total of 404 agencies got per-

missions to send pilgrims. But the government has given licences to 800 more agencies this year, Bahar said. Some of the agencies will incur a huge loss as they will

not be able to manage 150 pilgrims, he added.

Pointing out some mismanagements of carrying hajj pilgrims by Biman Bangladesh Airlines and Saudi Arabian Airlines, the Haab president said, "If a third carrier is not introduced, the pilgrims will go through the same uncertainty they faced last year."

A total of 1,27,198 pilgrims will go for this year's hajj. Biman will carry 50 percent of the pilgrim, while the Saudi Arabian Airlines will carry the rest. But Saudi Arabia Airlines can carry maximum 40,000 passengers in a hajj season. So, there will be a flight crisis if the government does not engage a third airline to carry the pilgrims this year, Bahar said.

Hefza Khana teacher canes 12-yr-old boy unconscious

A 12-year-old student was clobbered with canes by his teacher at a Hefza Khana in Sitakunda upazila yesterday until the boy lost his consciousness. Locals rescued Yusuf

Khan Sagar and rushed him to a local pharmacy. There were long, swelling bumps and bruises all over his back and arms. The boy was punished on suspicion that he stole the mobile phone of his instructor (hujur) Abdur Rahim. Police arrested Rahim of

the Hefza Khana, an institution where students memorise the holy Quran, situated in Sonaichhari union of the upazila.

Samiul Alam, officer-incharge of Sitakunda Police Station, said Rahim kept lashing Yusuf with around 10-12 canes until the boy could endure anymore and passed out.

Locals beat up Rahim heavily before handing him

over to police. A case was filed in this

connection.



Prosecution witness's statements contradictory

Quader Mollah's lawyer tells SC on 8th day of hearing on his appeal

Prosecution witness Shafiuddin Mollah's statements before the International Crimes Tribunal-2 regarding Abdul Quader Mollah's involvement in killing villagers of Alubdi village are contradictory, Abdur Razzaq, a lawyer for Mollah, told the Supreme Court yesterday.

Razzaq was placing arguments on the eighth day of the Appellate Division's hearing on convicted Jamaat-e-Islami leader Quader Mollah's appeal seeking acquittal in the war crimes case.

On April 24, 1971, Pakistan occupation forces and non-Bangalees led by Quader Mollah attacked unarmed villagers of Alubdi and killed 344 people, according to a charge, which was proved before the tribunal.

Razzaq told the SC that Shafiuddin stated before the ICT-2 that he (Shafiuuddin) was hiding under a bush from where he saw Quader Mollah talking to Pakistani army officers and firing on villagers.

"Shafiuddin said he could not hear anything from where he was but he also said Quader Mollah was speaking Urdu -these statements are contradictory," Razzaq argued.

Razzaq further said some parts of Shafiuddin's state-

ments are not corroborated by the investigation officer. The ICT-2 on February 5 awarded life term imprisonment to Mollah. The Appellate Division fixed today for

A Dhaka court yesterday fixed June 24 for hearing on charge framing against 60 accused in killing of six students at Aminbazar in July 2011.

Judge (in-charge) Runa Nahid Akhter of the Second Additional District and Sessions Judge's Court set the date and directed jail authorities to produce those who are in custody before it on that day.

Of the accused, 31 including Abdul Malek, the prime accused, are now on bail while 24 are on the run and five in jail custody.

Rapid Action Battalion on January 13 this year pressed charges over the killing against 60 people.

In the early hours on

July 17, 2011, a gang killed the youths near Aminbazar bridge on the outskirts of the capital, took the bodies more than half a kilometre away at Keblarchar on the advice of police and called villagers, saying robbers had been caught. The mob started blud-

geoning the six, without knowing the ill-fated youths had already gone beyond all pain and this was how the murder became known as an incident of mob beating.

Bangladesh foreign policy absolutely independent

Says Dipu Moni refuting US view

Foreign Minister Dipu Moni yesterday categorically said Bangladesh's foreign policy belongs to Bangladesh exclusively and it is not influenced by anybody.

Disagreeing with the US State Department's view that Bangladesh's foreign and domestic policies are heavily influenced by the region's major powers, particularly India, she said, "Our foreign policy belongs to us exclusively and is run to protect the interest of the people and the state."

Dipu Moni made the remarks in response to a question about the US State Department, which in its 2012 country report on terrorism on May 30 said Bangladesh's foreign policy is heavily influenced by India. The foreign minister said Bangladesh-USA bilateral ties

are "extremely good, effective, cordial and with full confidence" despite misleading campaign by some quarters. She said Bangladesh is working closely with the United




