The Election Commission Secretariat has been allocated public funds from the Government of the People's Republic of Bangladesh (GoB) toward the cost of Revenue Budget, and it intends to apply part of the proceeds of these funds to payments under the contract for the provision of consultancy services for the project by a Consulting Firm (National).

The services include:

Setup and maintenance of data connectivity through wireless modem between Election Commission Secretariat (ECS) and all of its field offices like Upazila, Zila and Regional offices by establishing a secured VPN. All the field offices are now connecting to the ECS network through wireless network using VPN and CDMA modem. The total number of wireless data connectivity is 600.

The experience, resources and delivery capacity required are: The firm must have experience of network installation/establishment and maintenance of at least 300 field offices all over Bangladesh.

The Election Commission Secretariat now invites eligible applicants to indicate their interest in providing the services. Interested consultants are invited to provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar operating conditions, availability of appropriate professional qualification and experience among staff, etc.). Applicants may associate with other applicants to enhance their qualifications, and though not mandatory, association with foreign firms is not encouraged in this instance.

A consultant will be selected using the Quality and Cost Based Selection (QCBS) procurement method in accordance with the Public Procurement Regulations-2003 and Public Procurement Procedures issued by the GoB. It is expected that data connectivity through wireless modem between Election Commission Secretariat and all of its field offices like Upazila, Zila and Regional offices by establishing a secured VPN will be commenced on August/2013 at all Upazila, Zila of Bangladesh and shall be completed on July/2014.
