GHORAGHAT UPAZILA IN DINAJPUR

Torching of houses of indigenous man triggers protest

Criminals torched the houses of an indigenous family in Ghoraghat upazila early yesterday, triggering panic and resentment among the community.

The indigenous people of the area yesterday brought out a procession and submitted a memorandum to Deputy Commissioner through Ghoraghat UNO, demanding probe and justice.

According to the locals, an unidentified gang attacked the houses of Nicolas Murmu at Bagjapara, a village of indigenous people, at around 2.00am and set them afire.

In the memorandum, the community people alleged that on June 6, around 200 Bangalee settlers, led by Azizar Rahman of Bhelain village in the upazila, attacked a slum of indigenous people at Dighipara village. They indiscriminately beat up the residents including women and children and looted their houses.

The attackers also took away 40 cattle, 60 goats, 5 rickshaws and a bicycle worth Tk 11,43,000, it said.

The same day they attacked a church at Bulakipur village, assaulted several people and hurled filthy words towards the priests of the church.

Protesting the atrocities of the settlers, the indigenous people at Balukipur brought out a protest procession in the upazila. Later they went to Ghoraghat UNO office complex and submitted a memorandum to DC.

Contacted, indigenous leader Bijoy Toppo said that the community people have been passing their days in panic and anxiety due to repeated attacks.

"We want a solution to this continuous repression on the indigenous community" he added.

Despite repeated attempts, this correspondent could not contact Azizar Rahman for his comments as he was not receiving any phone call.

Earlier on Thursday, one Morshed Ali Prodhan was murdered over collecting mango from a disputed orchard at Roghunathpur village in Ghoraghat upazila.

Later, a murder case was filed with the local police station, accusing Nicolas Murmu. Police arrested Nicolas and sent him to

jail, said OC of Ghoraghat PS.

Heavy Rain in Hills Across Border

Flash flood hits over 40 villages in Lalmonirhat

Several thousand people of 40 villages in five upazilas have been marooned as heavy rain in hills across the border in the last two days triggered flash flood.

The flood-hit people have taken shelter on government roads and WDB

The worst affected villages are Kurul, Mogholhat, Kulaghat, Bowalmari, Rajpur, Kalmati, Khuniya Gachh, Gokunda, Milon Bazar, Teesta, Etapota in Sadar upazila, Bongerbari, Sarkerbari, Dahagram, Sree Rampur, Bawra in Patgram upazila, Goddimari, Dowani, Sindurna, Dawabari, Paruliya, said.

Patikapara under Hatibandha upazila, Bhotmari, Char Kakina, Rudreshewar, Jamirbari, Shoalmari villages in Kaliganj upazila and Kadomtola, Balapara, Char Gobordhan, Balurbandh villagers took shelter on

'Robber' beaten to death, eyes of two others gouged out

A suspected robber was beaten to death while eyes of two others were gouged out by mob at Paschim Mithakhali village in Mathbaria upazila on Saturday night. The deceased was identi-

fied as Mostafa Gharami, 45, of Badura village in the upazila.

According to Mathbaria police, a gang of robbers numbering 10-12 entered the house of Shah Alam Hawladar in Mithakhali village and looted valuables at gun point at about 9:00pm on Saturday.

As the family members raised a hue and cry, neighbours chased the gang and caught three of them --Mostafa, Noman Gazi and Shahjahan Farazi -- while other members of the gang managed to flee the scene firing gunshots at the people.

Angry villagers beat up the three 'robbers' mercilessly and gouged out eyes of Noman and Shahjahan.

Mostafa succumbed to his injuries at hospital yesterday morning.

Land grabber remains defiant

A local Awami League leader, who grabbed the playground of Langurbeel Government Primary School in Teknaf upazila on Wednesday night, did not remove the barbed wire fences erected around the ground as of yesterday despite a directive given by a magis-

Over 100 people, led by local Awami League leader and former Teknaf Sadar Union Parishad (UP) Chairman Jafar Alam, illegally occupied the playground and erected barber wire fences around it.

As Assistant Commissioner (land) Selina Kazi, also an executive magistrate, went to the spot to recover the playground on Saturday, Jafar and his men put up a strong resistance to the drive. In the face of resistance, the magistrate launched the drive and demolished a house built by the grabber on the play-

First day of hartal in CHT passes off peacefully

The first day of 72-hour hartal enforced by three organisations in Rangamati, Khagrachhari and Bandarban districts passed off peacefully yesterday.

Parbatya Somo Odhikar Andolon (SOA), Parbatya Bangalee Chhatra Oikya Parisahd (PBCOP) and Parbatya Jubo Front (PJF) jointly called the hartal, demanding cancellation of draft amendments to Chittagong Hill Tracts (CHT) Land Dispute Resolution Commission Act.

The cabinet on May 27 amendments to the law, aiming at resolving the longstanding land disputes in CHT.

The three organisations of Bangalee settlers enforced a daylong hartal and roads and waterways blockade in the three hill districts on Dev. May 30 and June 2 on the same issue.

In Rangamati, vehicles were off the roads and business establishment remained shut in the town during hartal hours. Settlers brought out a procession in the morn-spondent.

ing and paraded the mair streets. No untoward incident was reported from any part of the district, according to our correspondent. Our Khagrachhari corre-

spondent reported that the first day of 72-hour shutdown ended in the district without any incident. Bus services to and from the district headquarters remained stopped. A few three wheelers were seen plying the roads during hartal hours.

In Bandarban, police arrested five pro-hartal activists while they were approved in principle the burning tyres in the town, said Mohammed Imtiaz Ahmed, officer-in-charge of Sadar Police Station.

The arrestees are Mohammad Suman, Mohammad Jasim Uddin, Mohammad Obaidullah Nur Amin Tufan, and Jifu

Afroza Haq Rina, the minister's wife, said, "I was busy with house-chores in an inner room. Hearing the repeated loud bangs, I came to the front of the room and saw two motorbikes pass by quickly along the road next to our building."

She said no one was hurt, and nothing in the room was damaged.

Other witnesses said that at Bannakandi village in the explosions left marks and residue on the glass and the walls where they were hurled at.

Inu alleged Jamaat-Shibir men to be behind the attack and told reporters, "The consecutive attacks on the houses of ministers, 14 party leaders and innocent people are to foil the war crimes trial. But despite their repeated attacks, we will try the war criminals."
