LEGALITY OF ASHIYAN CITY PROJECT

CJ forms 3-member HC bench

Chief Justice Md Muzammel Hossain has formed a three-member High Court bench to decide the legality of activities of Ashiyan City housing project.

The activities of Ashiyan City, which had a conditional and partial approval from the housing ministry to develop land in the capital's Holan and Ashkona areas, are now remaining halted following an earlier HC order. On Thursday, the chief justice constituted

ABM Mahmudul Huq for disposing of a writ petition through holding its final hearing. Two other judges of the bench are Justice Quazi Reza-Ul Hoque and Justice ABM Altaf Hossain, Supreme Court sources said. In December last year, some eminent rights activists filed the writ petition with the HC saying that Ashiyan City authorities

the company had Rajuk permission for development on only 43 acres.

The CJ's decision came after some rights activists submitted an application to him (CJ) on May 29 this year, apprehending that they will not get justice from the two-judge

HC bench led by Justice Quazi Reza-Ul Hoque in the case.

Now, the three-member bench will fix a date for hearing the matter, SC sources said. Earlier, the HC bench of Justice Hoque and Justice ABM Altaf Hossain was holding final hearing on the petition in line with a SC order.

In the application submitted by Chief Executive of Bangladesh Environment Lawyers Association (Bela) Syeda Rizwana Hasan on behalf of the petitioners, they prayed to the CJ that he pass an order transferring the writ petition from the HC bench led by Justice Quazi Reza-Ul Hoque to another bench for disposal.

On June 4, the HC bench led by Justice Hoque adjourned the hearing of the writ petition.

Earlier on January 2, following the same writ petition, the HC ordered Rajuk to stop the activities of Ashiyan City, and its site had been filling and constructing structures clearance certificate, issued by the on around 230 acres of land even though Department of Environment, and the renewal of the certificate.

It also issued a rule upon the authorities concerned of the government and Ashiyan City to explain as to why the issuance of the environmental certificate and its renewal should not be declared illegal.

'Magurchhara Day' Observed Foreign oil, gas exploration firms lack efficiency: Prof Anu

Foreign oil and gas exploration companies lack efficiency and are destroying Magurchhara, said National Committee to Protect Oil, Gas, Mineral Resources, Power and Ports Member Secretary Prof Anu Muhammad.

The power, energy and mineral resources ministry is acting as a "foreign agent". "Now our Bay of Bengal has been handed over to them (the exploration companies). Both the Awami League and BNP speak in the same tone," he told a citizens' meeting. The committee's Moulvibazar unit organised the meeting in Moulvibazar Town Club on Thursday on the eve of the 16th "Magurchhara Day".

On June 14, 1997, a massive explosion and a subsequent massive blaze tore apart the Magurchhara gas field in Moulvibazar's Kamalganj upazila while US energy company Occidental was drilling a well there.

Reports of two committees formed during the then Awami League government estimated the damage to forest resources Tk 9,858 crore, 29 tea gardens Tk 46.07 crore, the railway Tk 21 crore, Jalalabad Gas Company Tk 43 lakh and the electricity department Tk 4.35 crore.

Indigenous Khasia people lost betel leaf plantations worth Tk 18 lakh while about 96 acres of Lawachhara Reserve Forest was completely burnt. The inferno also destroyed a teak grove raised between 1944 and 1950, bamboo shacks created between 1993 and 1995, and a strip of plantation established in 1994. Though Occidental was widely blamed for the devastation, compensation still remains a far reach. Afterwards, operations of the gas field changed hands twice, to Unocal and then to Chevron.




