Parliament yesterday passed the Child Bill,

The bill has provisions of various punitive measures including maximum five years' jail or Tk 100,000 as fine for violence against children.

The existing law on children was enacted in 1974 while Bangladesh ratified the UN Child Rights Charter in 1990.

The law defines "child" as up to 18 years of age.

Other punitive measures provided for in the law are maximum five years' jail or Tk 100,000 as fine for forcing children into begging and leading them to go astray, and maximum three years' jail or Tk 100,000 lakh as fine for supplying arms or drugs

to children.

The bill also said that if any person forced a child to carry firearms or illegal or banned items that person will be treated as a criminal. The punishment for this offence will be not more than three years of imprisonment or Tk 100,000 fine or both.

It also mentioned that i any person engaged any child in acts of terrorism that person will be punished under the Anti-Terrorism Act, 2009.

Under the new law, Child Welfare Boards will be constituted both at national and local level and there will be child desks in every police station under the supervision of a sub-inspector.

SC fines BGP for not paying due bill

The Supreme Court yesterday fined Bangladesh Government Press (BGP) Tk 2 lakh for not paying a bill of Tk 66.95 lakh to a private firm which supplied machinery to the BGP in 2005.

A four member-bench of the Appellate Division of SC headed by Justice Nazmun Ara Sultana also upheld a High Court verdict in this regard. In February 2010, the HC directed the BGP authorities

to pay the due money with 15 percent bank interest to the firm -- Messer's Friendship Business Corporation (MFBC) - in 60 days from June 6, 2010. It also ordered the BGP authorities to pay Tk 10 lakh

more to MFBC for delaying to pay the due bill for over five years, MFBC's lawyer SM Rezaul Karim told The Daily Star. In 2005, MFBC Owner Akter Hossain had supplied

some machineries worth of Tk 76.95 lakh to the BGP, he Akter submitted a bill of Tk 76.95 lakh to the BGP in

2008. But the BGP paid only Tk 10 lakh, he added.

In March 2011, the government submitted the appeal to the SC seeking cancellation of the HC verdict.

After holding hearing, the apex court yesterday dismissed the government's appeal.

Deputy Attorney General Razik Al Jalil said it can be known after getting the written copy of SC order, when and how the BGP has to pay the money to MFBC.

Year-long campaign to stop child marriage launched

A year-long campaign titled "Bride Not before 18" to stop child marriage in the country was launched by National Human Rights Commission (NHRC) and World Vision Bangladesh (WVB) yesterday.

A signed memorandum of understanding (MoU) on the issue was exchanged between NHRC and WVB at the launching ceremony at a hotel in the capital. It is estimated that 66 percent of girls in Bangladesh are


married off before the age of 18 and 32 percent before the age of 15, the MoU stated. The campaign will engage young people at advocacy

level to stop child marriage and increase advocacy on child rights issues, said speakers. Child marriage is not only a curse; it is also a crime and a

violation of human rights, said Sultana Kamal, executive director of Ain O Salish Kendra. The Child Marriage Restraint Act, 1929 is one of the

weakest legislations of the country. It should be amended soon, said Kazi Reazul Hoque, a High Court judge and member of NHRC.

Child marriage is a big issue in many Asian and African countries. It is a cultural practice, so we scheduled the campaign in a way that can involve different communities, said WVB National Director Jan de Waal.
