The Supreme Court yesterday cleared the way for the country's institutions, except Notre Dame College, to admit students in class XI for the current academic year based on their Secondary School Certificate (SSC) exam marks.

SCHOOLS CHARGING EXTRA ADMISSION FEES HC seeks report on govt's punitive measures

The High Court yesterday directed the government to submit a report before it by July 13 on action taken against 47 private schools which are charging extra fees for admission from students.

The HC order came following hearing of a rule over legality of the extra fees and charges in the form of donations in violation of government guidelines.

On January 9, 2012, the HC ordered the authorities concerned to investigate allegations of imposition of extra fees and charges and submit to it a report on steps taken to stop this practice and punish violators.

School teacher held over attempted rape

A teacher of a Laxmi Bazar school in the capital was arrested yesterday following an attempted rape case filed against him by a girl student of the school who passed SSC exams this year.

Officer-in-Charge (OC) Rafigul Islam of Sutrapur Police Station said Basudev Kumar Roy, 38, a resident of Kazi Abdur Rauf Road in Sutrapur who has a wife and a child, was arrested from the school.

As per the case statement, Basudev, finding the girl, in class ten at that time, alone, had tried to rape her on May 27, 2012 when she went to his residence for private tuition.

The girl's family, fearing social stigma, remained silent. But a relative of hers verbally informed the school of the incident a few days ago, said the girl's mother.

The school authorities summoned Basudev yesterday noon. Basudev, in the morning, threatened the family and coerced the girl to write a statement that the allegation was not true, said the OC.

The girl's parents informed the matter to the school, which in turn informed police. Basudev, however, denied the allegation.

Amended anti-terror act to gag freedom of expression

The International Federation for Human Rights (FIDH) and its member organisation in Bangladesh, Odhikar, have expressed deep concern about the recently passed Anti-Terrorism (Amendment) Bill 2013, saying it would limit the freedom of expression.

In a joint statement published on the FIDH website on June 14, the organisations said the amendments which would allow the courts to accept videos, still photographs and audio clips used in Facebook, twitter, Skype, and other social media for trial cases widened the scope of sanctions

FIDH and Odhikar also criticised the definition of "terrorism" and retention of "death penalty" as the maximum punishment for financing "terrorist" activities. By retaining a vague definition and reducing terrorism to merely a crime punishable by death, the amendment bill makes the act even more vulnerable to the worst kind of abuses, they said.

Adilur Rahman Khan, secretary of Odhikar, said the amended bill, passed on June 11, would be more repressive.

Unicef, Save the Children hail passage of child bill

The United Nations Children's Fund (Unicef) and Save the Children have welcomed the passing of the Child Bill 2013 by Bangladesh's parliament, and said the new law was based on the UN Convention on the Rights of the Child (CRC).

The passing of the bill is a great milestone for children in Bangladesh, Unicef Representative in Dhaka Pascal Villeneuve said in a statement. "The law now recognises that a child is defined as any person below the age of 18 years old, providing a universal and internationally recognised definition for a

child." The CRC is the first legally binding international instrument, which spells out the basic human rights that children everywhere have, according to the Unicef website.

Villeneuve said, "For the first time, the law has a provision for child victims and witnesses cementing legal instruments for their protection, including compensation for victims....the law reinforces the importance of the juvenile justice system meaning that children accused of petty crime...will no longer be unnecessarily detained."

"The confirmation that everyone under the age of 18 years is legally a child must stimulate action to ensure that existing laws on child labour and child marriage are strictly adhered to," said Save the Children Country Director Michael McGrath.

The bill was passed on Sunday.
