15 hurt in AL infighting

At least 15 people were injured in a clash between the activists of Awami League and Krishak League at Badamtala Bazar in Sadar upazila yesterday. Of the injured, Anwar Hossain, Nasir Uddin, Rezaul Islam, Shamsul Alam, Jalil Mollah, Siddique Hossain, Naser Ali and Ruhul Amin and Akter Hossain were rushed to Jhenaidah Sadar Hospital while the rest given first aid. Sub-inspector, in-charge of Gobinda Adhikary Hatgopalpur police outpost, said there was a longstanding conflict between Harisankarpur union unit AL secretary Sanar Uddin and the union unit Krishak League president Jahangir Hossain over taking control of a local weekly market. As a sequel to the conflict, the supporters of Sanar and Jahangir attacked each other with lethal weapons, leaving at least 15 from both sides injured following an altercation over the issue yesterday afternoon, said the SI.

Two kids drown

Two kids drowned in a pond in Kalapara upazila town on Tuesday noon. They were identified as Rubaiyat, 5, son of Jalal Jomaddar of Bainbunia village and his cousin Raihan, 4, son of Kawsar Pada of the area. Family sources said, the duo while playing fell in a pond beside their house. Later, the bodies were recovered from the pond. Meanwhile, police recovered the body of a schoolboy from Dumki upazila on Tuesday evening. The deceased was identified as Robiul Islam, 13, son of Naser Fakir of Chargorabdi village.

Jamaat leader held

Police arrested a local Jamaat leader in Ullapara upazila town of Sirajganj district yesterday on charge of attacking police during hartal on June 10 this year. The arrestee is Md Abu Muttalib, 40, son of Abu Sama of Islampur village and ameer of Durganagar union unit Jamaat. On secret information, police arrested Muttalib from the area at 12:30pm, said officer in-charge of Ullapara police station Md Habibul Islam.

Five robbers jailed

A court here on Tuesday sentenced five people to 17 years imprisonment each for committing robbery. The convicts are Nazrul Islam, 35, son of Khoki Mondal of Joyrampur village, Naharul Islam, 40, son of Shamshuddin of Poranpur village, Tojajjel, 43, son of Inuddin of Poranpur, Shohidul, 38, son of Darshona Belepura and Firoz Ali, 45, son of Mongal Ali of Kukiya Chadpur village in Damurhuda upazila. The court also fined them Tk 20,000, in default, to suffer two years more in jail. Nazir Ahammad, additional district and session judge, handed down the verdict in presence of Tojajjel and shohidul in the crowded court. According to the prosecution, on November, 2003, the convicts looted cash, gold ornaments and other valuables from the house of one Mojibar Rahman of Poranpur village. Later, a case was filed against 12 people with Damurhuda police station in connection with the robbery.

DINAJPUR EDUCATION BOARD
Master roll staff demand job regularisation

The master roll employees of Dinajpur Education Board started indefinite work abstention yesterday, demanding regularisation of their jobs.

They gathered in front of the office gate at 9:00am and staged a demonstration to press the demand. Board sources said around 109 employees have been working at different sections on master roll basis since 2007.

As the authorities were dilly-dallying to appoint them permanently in their respective posts, they filed a writ petition with the High Court in October last year. Later, the court asked the board authorities to regularise their jobs on humanitarian grounds.

Following the High Court order, the board authorities started appointment process on April 24

this year. They prepared a list of 85 employees out of 109, saying that the rest 24 master roll employees had crossed the age limit.

Challenging the decision, the deprived employees filed a writ with the High Court that ordered the board authorities to postpone the appointment process.

On June 18, the board authorities held a meeting with Chairman Md Alauddin Mia in the chair. The meeting decided not to regularise job of any master roll employee.

Hearing the news, the master roll employees staged a demonstration on the board office premises and decided to start work abstention indefinitely from Wednesday.

Contacted, Dinajpur Education Board Chairman Alauddin Mia said he followed the court instructions.

Ban on visiting some tourist spots for safety

The administration here on Tuesday imposed a temporary ban on visiting Remarki and Tindu unions of Thanchi upazila of the district by tourists during monsoon for safety reasons.

The ban will remain effective in the areas from June 19 to September 30.

At a meeting, the local administration observed that different tourist areas in the upazila, including Chhoto Madak and Bara Madak points, Nafakum and Remarki canal and large stones of Tindu may pose high risks for visitors.

During this time of the year, massive hill collapse also take place there due to strong stream in the Sangu River.

On June 9, an intern doctor of Dhaka Medical College, identified as Minul Islam Shimul, died after falling into the turbulent water Nafakum waterfall.

Extortionists halt Lalmonirhat
Teesta dyke construction

Construction work of the embankment of Teesta's left bank at Gokunda union parishad in Sadar upazila remained halted since Sunday due to obstruction by local extortionists.

The extortionists stopped the construction work as the contractor refused to pay money.

Expressing frustration over the incident, villagers said the dyke's construction work has been halted just before its completion

shortly.

They said thousands of people living at Gokunda union are hit by erosion by the Teesta and become homeless every year.

The villagers expressed the fear that if the construction work on the dyke cannot be completed immediately, flooding during this monsoon will cause immense sufferings to them.

Besides, several thousands people might be marooned during the flood-

ing, they added.

Sources at Lalmonirhat Water Development Board (WDB) said the construction work of the two-km long embankment, involving Tk 23 crore began in Pangatary area of Gokunda union, last year.

The project work is scheduled to complete by June this year. But the fate of the project now hangs in the balance, the villagers alleged.

Police said they were not aware about the matter.

'Missing' BCL leader rescued

BCL Islamic University (IU) unit leader Saiful Islam, who went missing from Dhaka on January 22 this year, was rescued from Goalongo ferry terminal area in Rajbari district yesterday.

Abul Bashar, officer-in-charge (OC) of Goalongo Police Station, said Saiful, president of BCL Bangabandhu Hall unit, was found lying in a semi-conscious state in the terminal area at around 12:30pm.

As he introduced himself to locals, they informed the police, who went to the spot and rescued him.

On information, a police team from

Kushtia rushed to Rajbari and brought Saiful to the district headquarters. He is now undergoing treatment at Kushtia General Hospital.

Saiful went to Dhaka on January 21 to meet the BCL central leaders. He went missing on way to Kazipara in Mirpur from Farmgate area at around 9:15pm on January 22.

Saad Ahmed, elder brother of Saiful, and Shishir Islam Babu, BCL organising secretary of Bangabandhu Hall unit, filed two separate general diaries with Sher-e-Bangla Nagar Police Station in Dhaka and Islamic University Police Station in Kushtia on January 23.

72-HOUR HARTAL BY CHT SETTLERS
Day two passes off peacefully

The second day 72-hour hartal enforced by Parbatya Bangalee Chhatra Parishad (PBCP) and Parbatya Gono Parishad (PGP), protesting the approval to the CHT Land Commission (Amendment) Bill by the cabinet, passed off peacefully in the three hill districts yesterday.

In Rangamati, pickets agitated in several areas including Banrupa, Kathaltoli, Reserve Bazar and Tabalchhari. They burnt tyres on the roads, triggering action by the law enforcers.

Movement of buses and other vehicles was thin and most of the shops in the town remained shut.

In Bandarban, local PBCP relaxed the hartal for yesterday from 2.00pm due to the weekly *haat*, or make-shift market in the town.

The district town was peaceful and vehicular movement was normal in the morning.

Most shops also remained open while long distance buses operated in the morning.


In Khagrachhari, no picketing or violent incident

was reported during the hartal hours.

All modes of vehicles except CNG-run autorickshaws and rickshaws remained off the roads. No long-route buses were seen.

The 72-hour hartal decision was taken at a joint meeting of the two organisations of Bangalee settlers on Sunday night.

Earlier, Parbatya Chattagram Samoadhikar Andolon, also enforced a 3-day strike in Rangamati, Bandarban and Khagrachhari districts from June 9 to 11 on the same ground.

Man, woman killed by sons over land

A man and a woman were killed allegedly by their sons over land disputes in Tangail and Lalmonirhat districts yesterday and the day before.

An elderly man was strangled allegedly by his son at Baro Basalia village in Sadar upazila of Tangail yesterday.

The deceased was identified as Ebadat Ali, 75, of the village. He was father of four sons, reports our correspondent.

Police and locals said Ebadat recently gave his younger son some money after selling a piece of land.

Ebadat's second son Tomez Ali, 45, could not accept it easily and locked in quarrel with his father over the matter yesterday morning.

At one stage of altercation, Tomez killed his father and fled the scene.

In Lalmonirhat, a woman was stabbed to death allegedly by her stepsons over a piece of disputed land at Tepur Bazar village in Kaliganj upazila on Tuesday night, reports our correspondent.

The deceased was identified as Rahima Begum, 52, second wife of Moziz Uddin of the areas.

According to police, two stepsons Somor, Hafizur and their wives attacked Rahima, who was childless, with sharp weapons, leaving her critically injured when she demanded two bighas of land from her husband.

Rahima was rushed to Rangpur Medical College and Hospital where she died after sometime, said deceased's brother Zohurul Islam, also the plaintiff of the case.
