

'Approval of land bill violation of accord'

Govt kept us in dark, says Larma

The Chairman of Chittagong Hill Tracts (CHT) Regional Council, Jyotinrindra Bodhipriya Larma, has said approval of the CHT Land Dispute Resolution Commission (Amendment) Bill by the cabinet is a clear violation of the peace accord.

As per Article 53 of the deal, the government must inform and invite the authorities of the regional council to any ministerial and inter-ministerial meeting relating to taking such crucial and important decisions, he said while addressing a press conference here yesterday.

Unfortunately, the government did not inform us about the issue. It has ultimately been proved that the

Only 10 of the 13 recommendations have been included in the amendment bill placed in the parliament on June 16, Santu said, urging the government to include the remaining three proposals in the bill.

Until or unless the amendment bill is passed in accordance with the recommendations of CHTRC, a resolution of land disputes in the hills will not be possible, he said.

Parbatya Chattagram Jana Sanghati Samity (PCJSS) yesterday sent a memorandum to the prime minister, demanding inclusion of the three proposals that were excluded from the CHT land commission amendment bill.

CHT hartal called off 18 hrs early

The 72-hours hartal in the three hill districts of Chittagong was called off 18-hours ahead of the scheduled time yesterday.

The programme enforced by Parbatya Bangalee Chhatra Parishad and Parbatya Nagarik Parishad from last Tuesday morning protesting the approval to the CHT Land Commission (Amendment) Bill by the cabinet, ended at 12:00pm.

President of Parbatya Nagarik Parishad Alkas Al Mamun said, they decided to call off the strike as they would submit a memorandum to the Parliament Speaker and the Parliamentary Committee on Land Ministry in the afternoon asking them not to pass the bill in JS.

However, the hartal passed off peacefully in Khagrachhari, Rangamati and Bandarban districts yesterday.

In Khagrachhari, the

organisations relaxed the strike in the district town because of the weekly bazaar yesterday.

Life returned to normal, shops and markets remained open while auto-rickshaws and manual rickshaws, were seen plying from the morning.

However, the long route vehicles started operation from 03:00pm as the pro-hartal activists were active in different areas of Rangamati and Matiranga upazilas.

In Rangamati, the hartal passed off almost peacefully although pickets burned tyres at Banarupur, Reserve Bazar and Bhadvadi areas of the district town.

Most shops kept their shutters down during the hartal hours while a few vehicles including auto-rickshaws, motorcycles were seen on the streets.

In Bandarban, life in the district was almost normal during the hartal hours as shops, markets remained opened and all kinds of vehicles plied normally.

JSD leader arrested

Police arrested a leader of Jatiya Samajtantrik Dal (JSD) on charge of assaulting an official of Water Development Board on Wednesday night.

Chief Judicial Magistrate court in Kushtia sent joint secretary of district JSD Zillur Rahman of Haripur in Sadar upazila, also a contractor, to jail on the same night.

Police said, they arrested Zillur after the assaulted person filed a case against him.

According to the case filed by sub-assistant engineer Abdul Gafur, the JSD leader along with some of his aides went to WDB quarter adjacent to the office in Thanapara area in the town at about 5:30:pm on Wednesday.

Zillur wanted to know about a tender while the engineer asked him to come to office on next day.

This angered Zillur. He along with his men beat up the engineer. Later other staffs who were residing at the quarter rescued Gafur.


Growers, buyers both happy at mango markets

expected this season, said Abul Kalam Azad, deputy director of the Department of Agriculture Extension in Chapainawabganj.

Last year 1.68 lakh tonnes of mangoes was produced from 17 lakh 82 thousand trees on 23,281 hectares of land in the district, he said.

From the last week of May, three major mango markets in district -- Puraton Bazar in Chapainawabganj town, Rohnpur Bazar in Comostapur upazila and Kansat in Shibganj upazila see setting up of a good number of wholesale shops for procuring and selling of the fruit.

Kansat, about 345 kilometres away from capital, is



the largest mango market in the country.

During a visit on Tuesday, this correspondent saw wholesalers busy striking deals with buyers who came from Dhaka, Chittagong, Sylhet and other areas of the country to purchase truck-

loads of mangoes.

"Mango varieties like khirshapat, langra and different kinds of gutis sell very well. Hundreds of three-wheelers, rickshaw vans and cycles carrying mangoes from gardens arrive at the bazaar. The popular fruit is sold out in a short time," said Mojibur Rahman, owner of an arat (wholesale shop) at Kansat Bazar that now sees buyers from across the country.

"Chapainawabganj mangoes are tasty and lots of varieties are available here. Everyday I purchase at least one truckload of mangoes from Kansat and send it to the capital for sale," said Mofiz Uddin, buyer from Hazaribagh in the capital to

buy mangoes.

"For over a week, I have been buying around 100 maunds of mangoes daily to send it to my district," Komar Ali, a buyer from Sirajganj, said.

Traditionally producing around 250 varieties of high quality tasty mangoes, Chapainawabganj district greatly contributes to the country's agricultural economy, said Abdul Wahed, president of Chapainawabganj Chamber of Commerce and Industry.

The mango business worth around Tk 1,000 crore creates job opportunities for a large number of people in the district, he said.

A large number of people are employed for nursing of mango trees, harvesting the fruit and packing and transporting it to different areas of the country during the summer and early rainy season every year.

3 Bangladeshis shot by BSF in 2 dists

Three Bangladeshis were shot and injured by Indian Border Security Force (BSF) at different border points in Thakurgaon and Lalmanirhat districts yesterday.

Two men were seriously injured as BSF opened fire on them on Beurjhari border in Baliajangi upazila of Thakurgaon early yesterday, reports our correspondent.

The injured are Daimul Haque, 35, son of Karim Uddin and Poshirul, 25, son of Mahtab Ali of Ziabar Moralhat village.

Border Guard Bangladesh (BGB) sources said a team of BSF shot a group of Bangladeshi nationals, leaving Daimul and Poshirul seriously injured while they were crossing the border area at 1:30am.

They were admitted to Rangpur Medical College and Hospital, said com-

manding officer of Thakurgaon 30 BGB Battalion Lt Col Abu Bakar.

In Lalmanirhat, a Bangladeshi cattle trader was shot by BSF on Burimari border in Patgram upazila early yesterday, reports our correspondent.

Liton Islam Shamim, 22, son of Khamir Uddin of Mughlibari village, sustained bullet injuries in his leg and back. He was admitted to Rangpur Medical College and Hospital in critical condition.

BGB sources said a team of BSF men opened fire on a group of cattle traders, who tried to enter the border area to bring their cattle, leaving Shamim seriously injured.

Commander of 15 BGB Battalion Burimari camp Subedar Khademul Islam said they have already sent a letter to BSF, protesting the incident.

Farmers switching to okra in Batiaghata

Cultivation of okra (ladies finger), locally called dherosh, is becoming popular among the farmers in 28 villages under Batiaghata upazila of the district.

They are farming the green vegetable extensively to what they say to recoup the losses from boro paddy.

Farmers said they failed to get expected profit from boro paddy due to its low price.

Earlier, they suffered a huge loss in shrimp cultivation as the fish was affected by virus, following cyclonic storms Sidr and Aila.

Besides, production of aman paddy also did not come as expected due to excessive rain in the district.

As a result, to recover from the losses, they are now opting for okra cultivation.

Bid to grab college land triggers protest

Teachers and students of Pabna Government Women's College formed a human chain on the campus yesterday, protesting a bid to grab the land in front of the honours building by a local influential man.

Campus sources said businessman Md Aslam Hossain of Gopalpur area under Pabna municipality recently claimed the ownership of seven kathas of land in front of the building.

Challenging his claim, the college authorities filed a case with Joint District Judge's Court-1 on June 18. The date of hearing on the case is yet to be fixed.

Contacted, Prof Abdul Mannan, principal of the

college, said Md Aslam Hossain of Gopalpur area adjacent to the campus produced false documents before the surveyors during land survey in 2012 and seven kathas of college land was recorded in his name.

As Aslam stacked bricks and sand on the land yesterday morning to build a concrete structure there, teaches, students and the employees of the college formed a human chain in front of the building from one Abdul Wahab of the area in Batiaghata.

Refuting allegations of the college authorities, Aslam said he had bought seven kathas of land in front of the building from one Abdul Wahab of the area in Batiaghata.

They demanded that the government take immediate steps to foil the move of Aslam to grab the land. The college authorities also filed a general diary (GD) with

local police station against Aslam yesterday.

As per registered deed, the college authorities brought 16.61 kathas of land from a Hindu family in 1970 and built a three-storey building on 9.68 kathas in 1990, said Prof Md Shafiqul Islam, vice principal of the college.

The charge sheeted are Jamaat town unit assistant secretary Abdul Hakim, Shahabuddin, Ahsan Shakil, Nasim, Atiqur, Ashraful, Yeasin, Faruque, Al-Amin, Raki, Sufian, Belal, Hedayetullah, Imran, Abedur Shohel, Mohtasir Billah, Hasan, Ruhul and Rafiqul.

On June 9, district Jamaat-Shibir men brought out a procession in the town, protesting conviction of their three

central leaders by International Crimes Tribunal (ICT). They also blasted 20 cocktails in Sutrapur area.

On information, police rushed in, fired at least 63 rubber bullets to disperse the protesters. Attacked by the Jamaat men, at least five policemen, including two officials, were injured.

The law enforcers then arrested 16 Jamaat-Shibir men, said sub-inspector of Sadar police station Kala Chand.
