

Hasina not Khaleda will be held for graft if CG comes

Says Rafiqul Islam Mia

Prime Minister Sheikh Hasina would be arrested for her corruption if a caretaker government comes to power, not the opposition chief Khaleda Zia, said BNP Standing Committee Member Rafiqul Islam Mia yesterday.

She [Hasina] was involved in the Hallmark scam, Padma bridge and share market corruptions, he alleged.

"Why Khaleda will be arrested. She was not involved in any corruption. Prime Minister Sheikh Hasina will be accused of corruption and face trial," he claimed.

The BNP leader made the remarks at a discussion organised by Sammito Chhatra Forum, a pro-BNP platform, at Jatiya Press Club in the capital.

Earlier on Friday, Hasina urged Khaleda not to advocate for a non-party caretaker government saying that such government might want to stay in power forever sending them [Khaleda and Hasina] to jail.

Mentioning the recent results of four city corporations polls, Rafiqul said people gave their mandate to the BNP's demand for a caretaker government.

DCC fixes prices of red meat ahead of Ramadan

Dhaka North City Corporation (DNCC) and Dhaka South City Corporation (DSCC) yesterday fixed the prices of red meat ahead of Ramadan.

The authorities fixed the price of per kg local beef at Tk 275, foreign beef at Tk 260, mutton (khashi) at Tk 450, mutton (bokri) at Tk 390, lamb at Tk 390 and buffalo meat at Tk 260.

The prices were decided at a views-exchange meeting between the authorities of the two city corporations and meat traders of the capital at Nagar Bhaban.

The new prices would be effective from the first of Ramadan till the 26th of the Muslim holy month of fasting.

Only the price of mutton (khashi) has been increased by Tk 25 from last year's Ramadan prices; the prices of the other types of meat remain the same.

The meat traders assured the authorities of following the price chart and demanded that they [authorities] improve the slaughter-houses in the capital.

They also requested the authorities not to harass meat traders through mobile courts.

Rabiul Alam, secretary general of Bangladesh Meat Traders Association and Shamim Ahmed, general secretary of Dhaka Metropolitan Meat Traders Association, among others, addressed the meeting.

The meeting was presided over by Mohammad Nozmul Islam, administrator of DSCC.

New budget promotes gender-responsiveness

The 2013-14 budget promotes greater gender-related expenditure for the advancement of women's rights, speakers said at a post-budget discussion yesterday.

"This year the allocation has increased to 27.68 percent from 26.26 percent last year," said Sharmind Neelormi, associate professor of the economics department at Jahangirnagar University.

This follows the trend of the past decade of increasing allocation for gender-responsive projects in the development allocation, she told the discussion, organised by Bangladesh Mahila Parishad (BMP) in the capital's Cirdap auditorium.

Neelormi said the "gender budget" had also been incorporated into 15 more ministries this year, raising the total number of ministries executing gender-related projects to 40.

Almost half of the newly employed persons in the last decade are females, said the speakers.

"Women's participation in agriculture has seen a considerable increase, especially more noticeable at times when the men go abroad as migrant labourers," said MM Akash, professor of economics at Dhaka University.

The rise has been close to 103 percent, added Neelormi. BMP Chairperson Ayesha Khanam also spoke on the occasion.

Ctg nursing students start sit-in over 6-point demand

Students of Chittagong Nursing College yesterday started an indefinite sit-in programme before the college administrative building in the city to press home their six-point demand.

The demands are: introduction of six month-one year long internship after their courses are completed, monthly stipend of Tk 3,000, introduction of nurses' quota in BCS examination and formulation of specific policy for appointing the current students, introduction of masters' course, inclusion of apron in the uniform, and turning the Directorate of Nursing Services (DNS) into a full-fledged directorate.

Students alleged that the DNS director did not fulfil any of their demands, though on May 14, he assured them to do so within a month. They would continue the programme until their demands are met.

Students of Bangladesh Basic Graduate Student Nurses' Association and six other colleges of the country are observing similar programmes on their campuses.
