The UK, which is planning to run a pilot project from November, requiring financial bonds from selected visitors, yesterday said Bangladesh was being considered a pilot country, and no final decision had been made.

Any scheme would only affect a small number of the

highest risk visitors, said a statement of the British High Commission in Dhaka yesterday. Responding to reports that the UK government plans to trial the use of immigration bonds, the statement said, "The

UK government has already announced its intention to trial the use of financial bonds as a way of tackling abuse in the immigration system.

"The details of the policy are still being finalised Bangladesh is being considered as a pilot country but no final decision has been made."

Giving a background, the statement said other countries applied similar schemes to mitigate the risk of visitors overstaying their visa. For example, Australia and New Zealand set financial bonds at between 5,000 and 15,000 Australian dollars and 5,000 and 10,000 New Zealand dollars, it added.


