Transplanted jute yields double, sees successful farming

Jute cultivation through seedling transplantation is gaining popularity in Gobindaganj upazila under the district as the process gives twice the yield compared to usual seed sowing method.

"Just out of curiosity, I transplanted jute seedlings that I had uprooted from a thickly growing jute field. Surprisingly, the yield was much better than usual sowing method," said Delwar Hossain of Chaigharia village, who introduced the process of transplanting jute seedlings two years ago.

seedlings, no further weeding is required till harvest, whereas the usual process needs at least three times weeding that adds to the labour cost, he said.

Seeing the success, farmers who had earlier given up jute cultivation due to its lower prices, started showing renewed interest in its cultivation and the transplantation process has already spread in Bochadaha, Poontair, Jagodishpur, Jibonpur and Ulipur villages in Gobindaganj upazila and also a few places of Saghata upazila.

Many farmers have already started jute farming through seedling transplantation this season.

Just after the harvest of early variety of boro crops, they are preparing muddy fields with the help of either rainwater or small amount of irrigation for transplanting 15-20 days old tosha variety of jute plants, said the growers, adding that it would require spaying of urea fertiliser only once.

"After harvesting boro crop on my 0.24-decimal plot last year, I transplanted seedlings of tosha and got ten maunds of jute fibre, whereas earlier I got only four to five maunds," said Delwar.

ATTACK ON POLICE STATION

Six Jhalakathi BNP men remanded

Six of the 19 BNP men, accused in a case for attack on Rajapur Police station in the district on June 22, were placed on a twoday remand yesterday.

Police produced them in the Court of Senior Judicial

Magistrate Md Shahidul Islam, seeking a three-day remand for the six accused. After a hearing, the magistrate

granted two days' remand. Following a clash with cops, BNP men attacked Rajapur Police Station and vandalised its windows and a motorbike on June 22. The clash ensued as police intercepted a BNP procession at Rajapur Jail Road at around 6:00pm on the day.

Rivals torch 10 houses in Ashuganj

Rivals burnt down ten houses at Araishida village under Ashuganj upazila in the district yesterday.

As a sequel to a previous murder, a large group of people led by Salim and Jahir of the same area armed with lethal weapons attacked the houses of Abdul Hai and his brothers, said Upazila Nirbahi Officer (UNO) Muhammad Ismail Hossain.

They damaged and set fire to ten houses there.

On information, fire fighters from Ashuganj and a large team of policemen

headed by Ashuganj UNO Muhammad Ismail Hossain rushed to the spot, doused the fire and brought the situation under control.

Four unruly people have been arrested from the spot and police have been deployed in the area to avert further trouble, said Gulam Farook, officer in charge of Ashuganj Police Station.

Meanwhile, locals in a view exchange meeting held at the auditorium of Nasirnagar upazila under the district yesterday vowed to uproot smuggling and drug abuse and work for maintaining law and order in the area.

Transport workers yesterday threatened an indefinite strike in Rajshahi division from July 1 if their 10-pont demand was not met by June 30.

Kamal Hossain Robi, secretary of the regional committee of Bangladesh Sarak Paribahan Sramik Federation, said this at a press conference held at Bogra Press Club yesterday.

The demands of the transport workers include immediate issuance of

Under Section 31 (1) of the Local Government (Municipality) Act 2009, Md Khalilur Rahman, deputy secretary of LGRD ministry, issued the suspension orders to the mayor and the councillors on Wednesday.

The deputy commissioner's office received the suspension orders yesterday.

Mayor Abdul Matin was also asked to hand over the charge to the panel mayor- 2 within three days of issuance of the letter. On November 11 last year, police pressed

charges against the six in the case and Court of the Additional Chief Judicial Magistrate accepted it on February 28 this year. Mayor Abdul Matin, the councillors and
