Limon indicted

Jhalakathi court frames charges against him in arms case filed by Rab; his family's case against Rab hardly makes progress

A Jhalakathi court framed charges against Limon Hossain in an arms case yesterday, a week after the country's human rights chief requested, in odd fashion, the teenager to withdraw his case against Rab personnel who shot and maimed him two years ago.

The indictment comes amid a huge outcry from rights bodies over the government's failure to protect the college boy, whose left leg had to be

amputated after the shooting. "The government has turned repressive and the National Human Rights Commission could not maintain its independence," said Adilur Rahman Khan, secretary of the rights organisation Odhikar. Eminent jurist Shahdeen Malik

described the indictment as a "sad day for our criminal justice system". He noted: "Cases like these erode people's confidence both in the law enforce-

ment agencies and the judiciary." On March 23, 2011, a Rab team shot

Limon, then 16, in the left leg, taking him for a top criminal named Morshed near his Jhalakathi home at Jamaddarhat in Rajapur upazila.

The elite force then picked him up and filed two cases against him -- one for possessing arms and the other for obstructing law enforcers -- on the same day.

On April 10 that year, Limon's mother filed a case against six Rab officials for shooting and maining her son.

While the case against the Rab men is moving at a snail's pace, Additional District Judge Kiron Chandra Halder yesterday pressed charges against Limon.

The court also rejected Limon's prayer seeking acquittal in the arms case against him and members of Morshed gang.

The court will start taking witnesses' depositions on August 26.

Limon, who now uses an artificial leg, in his reaction said: "I have been denied justice."

Govt moves for RECLAIMING GSP

The government yesterday decided to quickly review the Bangladesh Labour (Amendment) Act, 2013 and pass it in the current parliament session.

The move comes as a last-ditch effort to regain the GSP (Generalised System of Preferences), a trade privilege that the US suspended for Bangladesh last week citing "serious shortcomings" in safety and labour standards.

Cabinet okays draft law with provision for food courts, 14-yr jail for food adulteration

The cabinet yesterday approved in principle the draft of the Food Safety Act, 2013 with a provision of up to 14 years' imprisonment for food adulterators.

The draft law also sought to form a unified authority -- Bangladesh Food Safety Authority (BFSA) -- to fight food adulteration and take care of other food-related concerns of consumers. It proposed forming as many food courts as deemed required to try the adulterators.

Once passed by parliament, the law will

replace the ages-old Pure Food Ordinance, 1959 and the current multi-pronged, multiministry controlled mechanisms of food safety issues, Food Minister Muhammad

Abdur Razzaque told The Daily Star. The BFSA, noted the minister, would be moulded in the shape of the US Food and Drug Administration and this should give the people of Bangladesh some relief from the menace of rampant food adulteration.

The five-decade old law, which is still in effect, has provisions for a paltry fine of Tk5,000 or jail terms for two to three
