Housewife murdered

A housewife was killed allegedly by her husband at Kamar Jogdoil village in Nachole upazila yesterday morning. The deceased was identified as Emali Begum, 40, wife of Sharif Uddin of the village. Sayed Iqbal, officer in-charge of Nachole Police Station, said Sharif hit Emali with a spade, leaving her dead on the spot following an altercation over family feud. On information, police recovered her body and sent it to the hospital morgue for autopsy. A murder case filed accusing Sharif, said the OC.

Man commits 'suicide'

A man allegedly committed suicide following a family feud at Surikhola village in Chandina upazila early yesterday. Deceased Sohel Ahmed, 30, was son of Ahom Ali of Chatadda village. Family source said Sohel killed himself life by taking poison at his in-laws house at 3:00am. On information, police recovered the body and sent it to Comilla Medical College and Hospital morgue for autopsy, said Golam Morshed, officer in-charge of Chandina Police Station.

Fisherman's body recovered

The body of a fisherman, who went missing in a boat capsized on Saturday, was recovered from Monkhali area beside Teknaf sea beach on Tuesday. The deceased was identified as Monir Ahmed, 18, son of Mohammad Sayed of Lenguir Beel. Monir went missing on the day after an engine boat carrying him and six other fishermen sank in the Bay. However, others managed to swim ashore, said locals. Meanwhile, another fishing boat sank near Saint Martin early Tuesday. The fishermen, however, managed to swim ashore.

Two electrocuted

Two people were electrocuted in Jhenidah and Gaibandha districts yesterday. The dead are Nazrul Islam, 33, son of late Monir Uddin of Tilla village under Kaliganj upazila of Jhenidah and Sujon Mia, 12, of collegepara in Sadullapur upazila of Gaibandha, reports our correspondent. Family members said Nazrul came in contact with a live electric wire at kitchen at their house and died on the spot. Locals said Suja Mia was playing with his friends in an under construction house in collegepara area. At one stage, he went to the rooftop of the house and came in touch with an overhead power line. He was shocked and fell to the ground. Locals took him to the hospital where the doctors declared him dead.

Kid drowns in canal

A kid drowned in a canal at Gazirpara village under Bakshiganj upazila on Tuesday evening. The dead is Mishi, 5, daughter of Mister Ali of the village. Mishi fell into Katakhal canal near their house and drowned while she was playing beside it, said local UP Chairman Mizanur Rahman Lebu.

**JAMUNA EROSION TAKES SERIOUS TURN IN SIRAJGANJ
Over 300 families made homeless in a week**

Erosion by the River Jamuna rendered over 300 families homeless in four upazilas of Sirajganj district in the last one week.
The worst affected upazilas are Sadar, Kazipur and Enayetpur, said an official of Water Development Board (WDB) in the district.
The erosion-hit people have taken shelter on roads and the embankments of the Water Development Board (WDB).
Sadar Upazila Parishad Charman Md Golam Kibria said Jamuna devoured over 100 houses

and 1000 bighas of croplands in Shimla, Bahuka, Baligugri, Pashthakur villages in the upazila during the period.
Jamuna continues to erode homesteads and cropland in the upazila. The river had engulfed a portion of Sirajganj town protection dyke at Bahuka point two months ago.
Sirajganj WDB Executive Engineer Babul Chandra Sheel said the authorities have already taken an initiative to reconstruct 2.5 kilometres embankment.
The river has already devoured at least 150 houses in Kochgram, Betil Char, Chadpur, Baokhola

and Ghotabari villages under Enayetpur upazila, said locals.
Enayetpur Upazila Parishad Chairman Mozammel Haque said the flood protection embankment is under threat as erosion by the Jamuna has taken a serious turn in the area.
Around 50 houses and a vast tract of cropland had gone into the river in Shimla area under Kazipur upazila in a week, he said.
WDB has dumped sand bags at the vulnerable points in the upazila to stop onslaught of the river, said Executive Engineer Babul Chandra Sheel.

Indefinite transport strike begins in Khagrachhari

Owners, workers press 5-pt demand

Vehicular movement came to a halt on all roads in Khagrachhari as transport owners and workers enforced an indefinite strike in the district yesterday.
District Paribahan Malik-Sramik Samannoy Parishad called the strike to realise their five-point demand.
The demands include compensation for the ten vehicles that were torched and vandalised by Democratic Youth Forum during its road blockade programme on Sunday,

steps to stop illegal toll collection from buses and other vehicles by regional political parties, ban on plying of unregistered three wheelers on roads, repair of the all deplorable roads and ensure security of transport workers.
Buses, trucks and passenger-carrying jeeps went off the roads in the district, causing immense suffering to the commuters. Only motorcycles, rickshaws and battery-run three wheelers were seen plying the roads.
The leaders of the

parishad announced the programme at a meeting held in the district town on Sunday. No untoward incident was reported from anywhere in the district yesterday.
KM Ismail Hossion, member secretary of the organisation, told this correspondent that they would continue their strike until the demands were met.
Contacted, Deputy Commissioner (DC) Masud Karim said he has invited the leaders of Paribahan Malik-Sramik Samannoy Parishad to a meeting to resolve the issues.

CLASH OVER RAID IN KURIGRAM

Two villagers bullet-hit, five BGB men hurt

Seven people including five members of Border Guard Bangladesh (BGB) were injured in a clash between the law enforcers and villagers in Berakuti border in Phulbari upazila under the district Tuesday night.
According to BGB sources, a BGB team led by Nayek Subedar Mafizul of Anantapur BOP camp under Kashipur Company raided Bablu Mia's house of Berakuthi border at around 9:30pm on Tuesday following allegations of keeping drug and Indian spice at his house.
Following a heated exchange between some villagers including Bablu's family members and BGB men, a clash occurred between them and BGB fired bullets.

Anjuma Begum, 32, and Tauhidul Islam, 35, of Bablu's family received bullets from the BGB firing and they disappeared from the area in fear of being arrested, locals said.
Stabbed during the clash, Abdus Samad, lance nayek of BGB, was admitted to Kurigram Sadar Hospital, said a BGB press release signed by Public Relations Officer Muhammad Mohsin Reza.
"The unruly villagers, who injured BGB men, also broke an SMG of BGB. To check the situation, BGB fired four rounds of bullets. Two villagers received

bullets that time," said Subeder Roy Mohan, company commander of BGB at Kashipur.
Injured BGB lance nayek Abdus Samad was hospitalised while nayek subedars Abdul Aziz and Abdul Latif and sepoy Rashed Alam and Satinur Rahman, who received minor injuries during the clash, took first aid, he said.
Commanding Officer of 45 BGB Battalion in Kurigram Lt Col Ziaul Haque Khaled said, "The incident of firing happened as unruly people attacked BGB members and broke their arm during the raid."
