A court yesterday sentenced Ali Ahsan Mohammad Mojaheed to death for his role in crimes against humanity, including the mass extermination of intellectuals towards the end of the Liberation War in 1971.

International Crimes Tribunal-2 found the 65-year-old Jamaat-e-Islami secretary general guilty of murders, persecutions and detentions of unarmed people.

Mojaheed had led a "death squad", named Al-Badr, that worked as an auxiliary force for the Pakistani army.

In a verdict that sheds light on the nation's struggle for freedom from Pakistan, three judges of the tribunal said Mojaheed held superior responsibility in abetting, planning and facilitating the mass killings of the "best sons and daughters of the soil".

The former minister was guilty in five of the seven charges piled against him. He was sentenced to death in three of them, imprisoned for life in one and sentenced to five years in prison in another.

No escape

Tribunal says superior responsibilty for Al-Badr crimes goes to Al-Badr leader

Convicted war criminal Ali Ahsan Mohammad Mojaheed held a superior position in the Al-Badr force and had effective control over the members of the killing squad, an auxiliary force of the Pakistan occupation army during the 1971 Liberation War.

The judges of International Crimes Tribunal-2 talked elaborately about Al-Badr in the verdict against Mojaheed, who was a top leader of the organisation that orchestrated the killing of intellectuals to cripple the Bangalee nation.

"Mujahid [Mojaheed], who was in a superior position (President) of ICS [Islami Chhatra Sangha, student wing of Jamaat-e-Islami] which transformed into Al-Badr, was aware of the consequence of his act and conduct that substantially encouraged, endorsed, approved, provided moral support to the Al-Badr men in committing the intellectuals' killing," the judgment said.

The Jamaat's student wing was reborn with a new name "Islami Chhatra Shibir" at the Dhaka University mosque in 1977.

Sensing imminent defeat, the Pakistan occupation forces and their local collaborators, especially Al-Badr, picked up many eminent personalities, including academics, doctors, engineers, journalists and teachers, from their homes in Dhaka, and killed them on the eve of the nation's victory on December 16, 1971.

The bodies of the nation's brightest brains were dumped at Rayerbazar, Mirpur and several other killing grounds in the city.

The martyred intellectuals include journalist Serajuddin Hossain, Syed Najmul Haque, ANM Golam Mostafa, Nizam Uddin Ahmed, Selina Parvin, Shahidullah Kaiser, Dhaka University professors Giasuddin Ahmed, Sirajul Haque Khan, Dr Abul Khayer, Dr Faizul Mohiuddin, Rashidul Hasan, Anwar Pasha, Santosh Chandra Bhattacharyya, Munier Chowdhury and Mofazzal Haidar Choudhury, physicians Mohammad Martuza, Alim

Brother of martyred Rumi happy as verdict covers massacre of intellectuals





6 days of waste Jamaat's 4-day hartal links weekend

STAR REPORT

This week has seen only one working day as the Jamaat-e-Islami has called four countrywide hartals in a row from Monday, protesting the war crimes trial and the recent verdicts. It means most of the nation's activities will be on hold for another two days of weekend.

Today's hartal is to protest a death sentence to Jamaat Secretary General Ali Ahsan Mohammad Mojaheed. The International Crimes Tribunal delivered the verdict yesterday, two days after it handed down 90 years' imprisonment on former Jamaat chief Ghulam Azam.

The first of the four countrywide daylong

hartals was enforced on Monday in protest at the trial of Ghulam Azam and the following shutdowns came with the delivery of the verdicts.

Yesterday's hartal was marked by com-

paratively less violence. The Jamaat, branded by the tribunal as a criminal organisation for its anti-liberation role, has made a record of enforcing hartals on four consecutive days in the Awami League government's four and a half years'
