JCD man murdered in Comilla

Barura police said Mamunur Rashid, 22, was stabbed in his abdomen and chest allegedly by Jubo League activist Bablu Hossain Bappi over previous enmity. Police sent the body to Comilla Medical College

morgue for an autopsy. M Shah Alam, former president of Chhatra Dal upazila unit, said Bappi killed him as Mamun refused to give him extortion money. A murder case was filed.

2 smugglers held with 10 gold bars

Homage to Humayun at Nuhash Palli



(1948-2012)

People from all walks of life paid tributes to Humayun Ahmed and offered prayers at his grave at Nuhash Palli in Gazipur on the author's first anniversary of death yesterday. Meher Afroz Shaon, widow of Humayun,

visited the grave with her father Mohammad Ali, mother Tahura Ali, two sons Nishad and Ninit, two sisters Sinjan and Senjuti, and several publishers. After offering munajat at 3:00pm, Shaon said,

"He [Humayun] used to not observe sorrowful occasions. So, I'm not organising any programme on his death anniversary."

Every year, Humayun held a milad at Nuhash Palli and another at Shaheed Smriti Bidyapith in Netrakona on the occasion of his father's death

Fayzur Rahman Ahmed, she added. Shaon, however, said 450 kids from the orphan-

ages around Nuhash Palli were invited, who recited the Quran for Humayun's departed soul. No other family members, including

Humayun's mother Ayesha Fayz, did visit Nuhash Palli yesterday. Shaon said she had requested Ayesha to visit the grave.

A best-selling writer, celebrated filmmaker and television drama director, Humayun died of colon cancer in a New York hospital on July 19 last year. He was 64.

He was born in Netrakona in 1948 and educated at Dhaka University. He later joined the university as a lecturer of chemistry before becoming a fulltime writer.

SC SHORT VERDICT ON FATWA

Full text not released in 2-yr

About 26 months into announcing the short verdict on the legality of fatwa or Islamic religious edict, the Supreme Court is yet to release its full text, which is expected to give guidelines to stop abuses of fatwa and misinterpretations of the religion.

The Appellate Division of the SC declared fatwa legal in "religious matters" on May 12, 2011, but it categorically said fatwa could not be used to punish anyone.

Fatwa cannot be issued to violate or affect the rights or reputation or dignity of any person which are covered by the law of the land, it said in the short verdict. "No punishment, including physical violence and/or mental torture in any form, can be imposed or inflicted on anybody in pursuance of fatwa."

After hearing two separate appeals, the apex court ruled that only "properly educated persons" might issue fatwa but not force anyone to accept it.

Belayet said the ministry of religious affairs could issue a circular or the parliament could pass a bill to this effect if the full text was available.

Attorney General Mahbubey Alam told The Daily Star that the SC was taking time to release the full verdict as it involved some important issues. He, however, did not specify those issues.

responsible for the fatwa incident. Media reports say Mahfuzul Haque, a union parishad member o Nayduaria, with his supporters at a village arbitration accused Asma of "adultery" and declared that she would be buried chest-deep in the ground

and stoned as punishment. The arbitration was held on October 2 last year after Asma sued Mahfuzul and his aides in July the same year for sexually harassing her. The arbitration verdict, however, was not eventually executed.

PM to open 53MW power plant in B'baria today
