Rival AL men beat up MP-aspirant Halim

20 hurt, cars set afire in Faridpur

At least 20 people, including three local journalists, were injured as the alleged supporters of Syeda Sajeda Chowdhury, deputy leader of the parliament and the ruling Awami League presidium member attacked Awami League MP-aspirant Major (retd) ATM Halim and his men in Madrasha Gotti area under Saltha upazila of the district yester-

They also vandalised at least 10-12 cars and set fire to two microbuses of Halim's motorcade.

Halim, Nazrul Islam Pintu, nephew of Halim, his bodyguard Jahangir Hossain, Faridpur correspondent of the daily Ittefaq Tarikul Islam Himel, Quamruzzaman Shohel and Hasanuzzaman, district correspondents of ATN News and Samakal are among the injured.

Injured Halim and his nephew Pintu, who received bullet injury, were rushed to CMH in Dhaka. Bodyguard Jahangir was admitted to Faridpur Medical College Hospital while the rest tookfirstaid.

Witness and locals said the incident took place when the supporters Sajeda Chowdhury attacked the motorcade of Halim, an MP aspirant from Faridpur-2 constituency (Saltha -NagarKanda) on his way to home at Bhollovdi under Nagarkanda upazila around 11:00am to attend a programme on his father's death anniversary.

Mohammad Limon, younger brother of Halim, told The Daily Star that Delwar Hossain and Rezaur Rahman Choyon, president and organising secretary of Saltha upazila unit of Awami League, and Jubo

128 drug peddlers held

JSD leader murdered in Barisal, two held

Syed Humaun Kabir, Banaripara upazila organising secretary of Jatiya Samajtantrik Dal (JSD), was beaten to death by a gang led by local Awami League leader Abdus Salam near Chakhar bus stand on Friday.

Locals said there was a longstanding dispute between Kabir and Salam over control of Solia-Bakpur union in the upazila and both had an altercation over the issue in front of Chakhar Palli Bidyut office in the morning.

As a sequel to the incident, Salam, vice president of AL Solia-Bakpur union unit, and his men swooped on Salam in front of Chowkidar Bari on Guachitra- Chakhar Road at

The attackers took Kabir to an abandoned house near Agrani Bank Chakhar branch and beat him up mercilessly, leaving him critically injured.

Hearing the news, a Inspector Sanjib Chandra Shil and Assistant Sub Inspector Abdul Hye of Banaripara Police Station rushed to the spot, rescued Kabir and took him to the upazila health complex.

As Kabir's condition deteriorated at night, doctors referred him to Barisal Sher-e-Bangla Medical College Hospital (SBMCH) where he died soon after admission.

Syed Tarikul Islam, brother of Kabir, lodged a case with Banaripara Police station the same night, accusing Abdus Salam and 12 others. Police arrested Salam and his associate Md Jasim soon after filing of the

In the case statement Tarikul alleged that Salam and his men killed Kabir as he protested his (Salam) criminal activities like grabbing of land near Chakhar Government College, illegal collection from transports and felling of roadside trees.

Jubo League leader beaten to death

Bangladesh (BGB) Lt. Colonel Abu Basir told this correspondent over cell phone that local people saw a floating body in the river and informed BGB men at Joydharbhanga camp. Informed by BGB, police

went to the spot and recovered the body and sent it to Panchagarh Sadar Hospital for autopsy. The CO also informed

that the youth was absent from his house for three days and he allegedly was involved with cattle smuggling. He might have drowned in the river while crossing the border during a chase by BSF. An injury mark was

found on his face and BGB sent a protest note to BSF immediately, he said.

A company commander level flag meeting was held in the afternoon where the BSF denied torturing or killing the youth.

Man killed, 28 injured in two clashes

A youth was killed and 13 others were injured in a clash over a piece of disputed land at Velajan Thakthakia village in Thakurgaon Sadar upazila yesterday over a disputed land. The deceased was identi-

fied as Bijoy Ram, 22, son of Dinaram of the area, reports our correspondent.

Police and locals said Dinaram and his cousin Boijjoram was a longlasting conflict over the land.

The clash took place at 8:30am when Boijjoram police team led by Sub and his followers resisted Dinaram and his brothers who started to plant aman saplings on the land.

At least 14 from both sides were injured during the clash. Of them, Bijoy Ram died on way to the Rangpur Medical College and Hospital.

In Chuadanga, at least 15 people were injured in a clash between two rival groups at Kolabari village in Damurhuda upazila on Friday, reports a correspondent.

Police said there was a longstanding feud between between one Nur Box and Piru Mondal over the land.

As a sequel to the conflict, the supporters of the rivals attacked each other with lethal weapons, leaving 15 from both sides injured on Friday morning.

Two cases were filed with Damurhuda police station in this connection.
