Pay workers' wages, bonus by Aug 6

Govt asks RMG makers

The government yesterday asked the readymade garment factory owners to pay their workers' wages of July with festival bonus within August 6, ahead of the Eidul-Fitr.

The three-day-long public holiday on the occasion of Eid-ul-Fitr, the biggest religious festival of Muslims, might begin from August 8.

"Garment owners must pay their workers' wages for the month of July and the festival bonus within August 6," said Home Minister Muhiuddin Khan Alamgir.

He said this after a meeting with the leaders of Bangladesh Garment Manufacturers and Exporters Association (BGMEA) and Bangladesh Knitwear Manufacturers and Exporters Association at his secretariat office in the capital.

However, Atiqul Islam, president of BGMEA, apparel sector's apex trade body, said, "We will try to pay the garment workers' wages and [the festival] bonus by August 6 or 7."

A source at the meeting said no garment factory owner would be allowed to attended the meeting.

shut down his factory, and terminate any workers before the Eid to ensure the workers' rights.

The government had decided to keep branches of the banks in the industrial areas open on August 6 for smooth payment to the workers, the minister added.

August 6 is a national holiday for the holy Shab-e-Qadr, a night of blessings.

Another source at the meeting said it had also decided to make a recommendation to the cabinet for extending one day Eid holiday starting from August 7 instead of August 8 to ease traffic jams due to the homebound people during the Eid festival.

In this regard, Deputy Attorney General Bishwojit Roy told the court that his office had not got any reports from the government or the BGMEA, and none of them had contacted his office.

BGMEA President Atiqul Islam told The Daily Star that his office had sent a compensation report to their lawyer Abdul Mannan around one month back to submit it before the HC.

The Daily Star correspondent could not reach Abdul Mannan for his comments despite repeated attempts yesterday.

Senior Secretary to the home ministry CQK Mustaq Ahmed also could not be reached despite repeated attempts over the phone.

International Bangladesh in October 2012 revealed more shocking findings. Ninety-seven percent of the 149 sitting MPs surveyed by the TIB were involved in "negative activities," including being involved in or supportive of criminal activities, misuse of government funds and influencing government decisions.

And 70 percent of them were engaged in "criminal activities" like killing, land and river grabbing, extortion, tender manipulation and cheating. Many MPs even used their position to boost their income.

All these unruly and controversial activities have contributed largely to an overshadowing of many successes of the government. These also demonstrate how the AL and the government-led by it have miserably failed to uphold the rule of law, which is a pre-requisite for good governance.

Witness seeks review

Hours after International Crimes Tribunal-2 disposed of a contempt of court rule, Jahir Uddin Jalal, respondent of the rule, yesterday sought review of the order.

The tribunal on May 28 asked Jalal, a prosecution witness in Ali Ahsan Mohammad Mojaheed's case, to reply why contempt of court proceedings should not be initiated against him for allegedly assaulting a counsel of Mojaheed.

Following a petition filed by Munshi Ahsan Kabir, who was allegedly assaulted by Jalal on May 26, the tribunal issued a show cause notice and asked Jalal to give his explanation.

Submitting his explanation on June 30, Jalal denied his alleged assault on the counsel and said the allegation brought by Mojaheed's lawyer "could be a strategic plan to discredit him in some way".

Jalal also said he was ready to face any enquiry or investigation in this regard.

Kabir's lawyer Tajul Islam yesterday said apart from assaulting his client, Jalal had earlier verbally attacked another counsel of Mojaheed outside the courtroom and he sought action against Jalal.
