Govt plans reform in city polls

Mayors to be elected through indirect polls

The government has initiated to annul direct election to the mayor and chairman posts in the local government levels.

According to the move, elected councillors and members will elect a mayor or chairman from among themselves.

Local Government and Rural Development and Cooperatives Minister Syed Ashraful Islam disclosed the plan at a meeting with deputy commissioners (DCs) yesterday, on the second day of the DC conference being held in the cabinet division of Bangladesh Secretariat.

Ashraf told the DCs that a national dialogue would be initiated before introducing the system, meeting sources told The Daily Star.

As per the current rules, city corporation mayors and upazila chairmen are elected through direct voting.

Ashraf said mayors and chairmen used to get elected through indirect voting before the country's liberation. In 1973, the then government introduced direct election system for mayors and chairman by nullifying the previous method because the councillors and elected members used to get teamed up and sell their votes to influential people, who wanted to be in the helm of the local government institutions.

The LGRD minister pointed out that the mayors and chairmen should be elected as the prime minister is elected in the parliamentary system of democracy. Currently the mayors and chairmen are elected like the presidential form of system where the president is elected through direct voting of people.

He said two different systems cannot go along in a country. Elections to local government institutions would be held following the parliamentary form of system [indirect voting] if his party Awami League-led alliance assumed power in the next election, said Ashraf.

He also told the meeting that the level of the local government institution would also be reduced to strengthen the body organisationally and financially so that there was a powerful decentralised government system in the country, added sources.

In the meeting, the DCs alleged that the elected local government representatives in many cases did not follow the laws and created divisions among themselves over carrying out their duties. Their tasks should be defined and fixed to avert any feuds and factions in the

Attacks on cops kill 9 in Iraq

Militants attacked a police station in north Iraq yesterday with mortar rounds and automatic weapons, killing nine police, while six people died in other violence, security officers and doctors

The violence comes a day after an al-Qaeda front group claimed brazen assaults on two prisons in Iraq that killed more than 40 people, among them 20 security forces members, and saw hundreds of inmates, with the shortage of these including senior militants, escape.

In a separate incident, gunmen killed a soldier in Mosul itself, while armed men killed a man in Baquba, a city north of Baghdad.
