Rony challenges denial of bail

Awami League lawmaker Golam Maula Rony yesterday challenged the legality of his bail rejection order that was passed by Chief Metropolitan Magistrate's Court of Dhaka in an attempted murder case.

The court on July 25 rejected the bail petition and sent him to jail in the case filed for beating up Independent TV reporter Imtiaz Momin and cameraperson Mohsin Mukul at his Topkhana Road office on July 20.

Metropolitan Sessions Judge's Court yesterday fixed August 13 for hearing on the bail petition after Rony's lawyer submitted it against the rejection order.

Rony obtained ad interim bail on July 21 and it was cancelled on July 24 following an appeal by Yusuf Ali, assistant manager of the TV channel. He was arrested on July 24.

PM defends son's remarks on polls

Prime Minister Sheikh Hasina yesterday defended her son Sajeeb Wazed Joy's comment that Awami League will come to power again.

"Joy said one thing; he said that on the basis of a survey and a poll," she said while distributing financial aid cheques to 158 journalists at her office from the Journalists' Assistance

Recently, Joy in an Iftar party said he had information that Awami League will win in the next general election and will form the government again.

Hasina said a survey showed that Awami Leaguel is leading in the "opinion poll" and people still have their faith and confidence in the party. "As per the survey, Awami League will secure good result in the next (general) election and will be in power next." She said when Joy commented that as per the survey and

the poll, he got the picture that Awami League will do good in the next election and will come to power again, some vested quarters tampered with his statement. "The vested quarter is now saying that Awami League is

hatching conspiracy to come to power again." The prime minister also wondered about the people smelling conspiracy behind Joy's remarks. "From whom we are hearing about the conspiracy. These people are habituated to

hatching conspiracy and that's why they are telling abut the conspiracy," she said. She alleged that these people are used to vote rigging, vote engineering, stuffing of ballot boxes, capturing polling

booths by hooligans, and using law enforcement agencies'

people and members of the armed forces, administration and media. Hasina said, "Those who are used to hatching conspiracies will see conspiracies everywhere. They will think at their level; they can not think any better than that. This is the ground reality." In this regard, she mentioned that she had the fourth

magistrate. The statement was taken from former National Security Intelligence (NSI) director Wing Commander Shahab Uddin in a court on June 15, 2009, said Advocate Hamdur Rahman defence lawyer of Shahab Uddin.

The IO, Moniruzzaman Chowdhury, an additional superintendent of police of Criminal Investigation Department, was being cross examined by Hamdur before Chittagong Metropolitan Special Tribunal-1.Moniruzzaman also denied submitting the charge sheet under the influence of higher authorities. Kamrul Islam Sajjad, defence lawyer of former DGFI director Brig Gen (retd) Rezzakul Haider Chowdhury, also cross examined the IO.

A four-member Jamaat delegation placed the demand at a

rights," Jamaat Central Working Committee member Syed Abdullah Taher told journalists after the meeting. "If any law is required in this regard, the parliament will

formulate and pass the law," he said, adding that if the EC proactively steps in to formulate the law, it will prove that the EC is acting as per instruction of a particular quarter.

It will make the next general election uncertain and a situation may arrive which may halt holding of a fair election, he observed. Election Commissioner Shah Nawaz informed journalists

on Wednesday that persons convicted by the International Crimes Tribunals or found guilty under Bangladesh Collaborators Order, 1972 would be excluded. The International Crimes Tribunal (ICT) 1 and 2, dealing

with war crimes cases, so far delivered verdicts in six cases. ICT-1 sentenced former Jamaat chief Ghulam Azam to 90 years while leader Delawar Hossain Sayedee was given death penalty. ICT-2 awarded Jamaat Secretary General Ali Ahsan

Mohammad Mojaheed, Assistant Secretary General Muhammad Kamaruzzaman and expelled leader Abul Kalam Azad death sentence and another Assistant Secretary General Abdul Quader Mollah life sentence. Criticising another move of the EC to amend the electoral

code of conduct, Taher also said the EC included some provisions that serve the purpose of the government. As per a provision of the draft amendment, if the general

election is held under a partisan government, the ruling party chief and its 20 leaders (picked by the party chief) would enjoy the privilege to lead electioneering across the country.

Talking to reporters separately, the CEC said, "We asked them (Jamaat) to specify and explain the laws and their demands elaborately." Over the allegations, he said, "Our aim is to create a level-playing field for all, not to keep any party out of the election."






