Robbers kill 2 guards, loot Tk 10 lakh in Bogra town

Robbers hacked to death two security guards of the branch office of medicine distribution company Zuellig Pharma on Ishahaq Lane at Sutrapur in Bogra town and looted Tk 10 lakh from there early yesterday. The deceased are Tajul Islam, 26, son of Afzal Hossain of Amtoli Porapara village in Shukhanpukur area under Gabtoli upazila of Bogra district, and Rassel Mia, 25, son of Antaj Ali of Purbo Gobindapur village of Gaibandha Sadar upazila. "Informed by a security guard, who had duty at the office from the morning, I

rushed to the office and saw the blood stained bodies of the two guards. The pocket gate of the office was found open and the accounts room was ransacked. I informed the police and the high officials of district, Detective Branch and Criminal Investigation Department of police and Rapid Action Battalion-12 visited the spot," said Masudul Hasan, branch manager of the company. Tarique Aziz, accounts officer of the branch, said around Tk 10 lakh was looted after breaking the vault, locker and file cabinets of the accounts room. The dead bodies, which bore marks of serious stab-

bing in the chest, were sent to Shaheed Ziaur Rahman Medical College Hospital morgue for autopsy, police said. Contacted, Superintendent of Police of Bogra Mozammel Haque said, "Perhaps people related to the office conducted the robbery by using sedative drinks to make the night guards unconscious before killing them. The police and CID have collected evidence of the incident, including the video footage of CC camera. We are hopeful to find clues to the murder and arrest the criminals with the help of modern technology."

Youth electrocuted

A youth was electrocuted at Kalikapur village in Hizla upazila yesterday morning. The dead was identified as Russell Shikdar, 26, of the village and a lineman of local cable television network. Police and locals said Russell came in contact with an electric pole while he was working on cable TV line. He died on the spot. The body was sent to the hospital morgue for autopsy.

Student commits 'suicide'

A college student allegedly committed suicide over love affairs in the district town on Monday night. The deceased was identified as Md Sabbir Hossain, 17, a first year student of Pirojpur Government Suhrawardhi College and son of Md Jakir Hossain of CI Para in the town. Family sources said Sabbir took his life by hanging himself from a beam of his room. Sabbir had a relation with a girl which his family could not accept easily, said the sources.

Man killed by son

A man was killed allegedly by his son at Pachpir village in Kulaura upazila yesterday morning. Police arrested Mongal Kharia, 24, son of Budhua Kharia, 50, of the village, in connection with the incident. Police and locals said Mongal attacked Budhua with a sharp weapon, leaving him dead on the spot following a family feud. A case was filed accusing Mongal in connection with the killing, said Md Hassanujjam, office in-charge of Kulaura Police Station.

Smuggled goods seized

Members of Border Guard Bangladesh (BGB) in separate drives seized smuggled goods worth Tk 1 lakh in different areas of the district yesterday morning. The areas are Bowarabazar, Bibirbazar, Chouddagram, Amangoda and Kotokbazar. The goods include 40 bottles of whisky, 177 kg grapes and 297 cocktails. Sources said a team of BGB 10 raided the areas and seized the items. However, the smugglers managed to flee, sensing the presence of the border guards.

2 hurt in bomb attack

Two night guards of Bashbaria Technical School and College in Gangni upazila were injured in bombs attack by robbers early yesterday. The injured are Sohul Uddin, 22, and Rubel Hossain, 36, of Bashbaria area. Masudul Hasan, officer in-charge of Gangni Police Station, said a gang of 10/12 entered the school and tried to break open the door of the office room at 3:30am. Sensing the presence of the robbers, the duo cried for help. The gang then blasted two bombs, leaving the night guards seriously injured and fled the scene. They were admitted to Meherpur General Hospital, said the OC.

Man held with arms

Members of Rapid Action Battalion (Rab) arrested a man along with a 9MM pistol, two magazines and nine bullets at Tatura village in Gabtoli upazila early yesterday. The arrestee is Jahangir Alam, 43, son of late Montejar Rahman Pramanik of the village. On secret information, a team of Rab-12 raided the house of Jahangir and arrested him along with the arms and bullets, said Ali Ahmad Hashmi, officer in-charge of Gabtoli Police Station.

Idols of Durga damaged

Criminals damaged idols of Hindu goddess Durga of a temple at Harta in Uzirpur upazila early yesterday. Sunil Biswas, secretary of Harta Radha Govinda Mandir, said they found a hand of Durga idol broken and hairs torn of the temple and its electrical bulbs damaged in the morning. A case was filed in this connection, said Anwar Hossain, officer in-charge of Uzirpur Police Station. Police were raiding different areas to arrest the gang.

Illegal pharmacy sealed

The district administration in a drive sealed an illegal medicine pharmacy at Jessore Medical College and Hospital yesterday. Four brokers were also arrested in front of the hospital. Mehedi Pharmacy was sealed on charge of fraudulence and taking extra money in selling of drugs from the hapless patients, said Shamimul Islam, executive magistrate, who led the drive. Owner of the pharmacy Mehedi Hasan and his father Aminur Islam went into hiding after the incident, said the magistrate.

4 hurt in truck-train collision

At least four people were injured as a Dhaka-bound commuter train collided with a cement-laden truck at Kewatkhali level crossing in the town yesterday afternoon. The accident took place when the truck and the train collided on the level crossing around 5:00pm, injuring four passengers of the train, said locals. The injured were rushed to Mymensingh Medical College and Hospital. The train communication on Dhaka-Mymensingh route remained suspended for about four hours since the accident, said Mymensingh Station superintendent Abu Taher.

Housewife tortured for dowry

A housewife has been tortured and injured allegedly by her husband for dowry in Morelganj upazila of Bagerhat district. Victim Sheuli, 18, daughter of Amjed Sheikh of Zilbunia village, was admitted to Pirojpur Sadar Hospital. Amjed yesterday said Sheuli married Yasin Khan of Boro Jamua village in the upazila, over seven months ago. After the marriage, Yasin and his family members often tortured Sheuli for Tk 50,000. On Tuesday, Yasin beat her up mercilessly, leaving her seriously injured following an altercation over the issue.

4 shrimp enclosure owners 'buy freedom' in Satkhira

For shrimp enclosure owners, abducted from Golakhali area of Shyamnagar upazila on Monday night, were released early yesterday on payment of ransom. The four-Debabrata Mondol 25, Kartik Gayen 50, Pranab Biswas, 32, and Jitandra Mondol, 54--were kidnapped by the members of Ameer-Hazrat gang. All of them from Bhelkhali village of the upazila. Later, the Kidnappers demanded Tk 2.8 Lakh from

victims' family members. Otherwise, they threatened to kill the shrimp enclosure owners. Relatives confirmed the release of the four, who returned home early yesterday. Officer-in-Charge (OC) Aslam Khan of Shymnagar Police Station said on receiving information, they took the four to the police station for interrogation. "We have already arrested five, including two Indian national, for their alleged involvement in kidnapping the four" the OC said.
