

Rules flouted to clear 30 murder cases; committee sits Aug 20 to review 'politically-motivated' cases along with 200 more

The national committee for reviewing and recommending withdrawal of "politically motivated" lawsuits has taken up 30 murder cases, mostly against Awami League men, for review at its next meeting without following due procedures.

WITH TODAY'S ISSUE

lawsuits, have been selected for the committee's consideration, mostly without recommendations from district committees

headed by deputy commissioners, said sources in the inter-ministerial review body.

According to the rules, it is mandatory that district committees first select the "politically motivated" cases and then forward them to the home ministry for placing them before the national committee.

But many of the cases have been selected The murder cases, with nearly 170 other for the committee's review even without the cases referred to it. knowledge of district committees, said district officials.

The national committee headed by State

Minister for Law Quamrul Islam has been reviewing "politically motivated" cases since 2009.

The committee's next meeting, which may also be its last, is scheduled for August 20. At its previous 30 meetings, the committee had recommended withdrawing as many as 7,177 cases against a total of 11,200

Cheers for 'murderers' EC chooses to lose a few more teeth

The Election Commission (EC) has planned to weaken further its power over political parties by allowing them to have associate bodies again and bypass grassroots recommendations for nominating candidates for parliamentary polls.

In its electoral reform proposals, recently sent to the law ministry, the EC has recommended political parties be allowed to have associate bodies of students, like in universities, and even professionals and employees of state-owned entities, like teachers and doctors.

It has also proposed that political parties would not have to nominate parliamentary polls candidates according to the recommendations of their grassroots units. This provision was introduced in 2008 to instil

democratic practice in the parties and stop nomination trading, as before that people with money and no political background could easily obtain party tickets. In 2010, the Awami League-led government

moved to re-empower the party parliamentary boards to pick any candidate, including those the grassroots' have not chosen. But if the provision is withdrawn by amending the Representation of the People Order (RPO),

money will rule the nomination game. The parliamentary boards of parties will be free to choose. Now, violation of the above-mentioned rules could result in the cancellation of a party's registra-

tion with the EC. "But after the scrapping of the punitive provi-



sions, the Election Commission will have nothing to do if the political parties did not follow the rule for considering grassroots panels," former chief election commissioner ATM Shamsul Huda told The Daily Star yesterday.

He had led the EC when the sweeping electoral reforms were made in 2008.

Brig Gen (retd) M Sakhawat Hussein, who was an election commissioner in the Huda-led EC, said if the provision was made ineffective, the culture of "nomination trading" would "definitely" return.

According to Huda and Sakhawat, the aim of the

provision was to ensure democratic practice within political parties by empowering the grassroots Contacted over the phone, election commis-

City billboards hijacked by AL

Advertisers at a loss as govt moves to sing its own song

The real estate firm had a huge billboard at Shahbagh touting its apartments. It would not miss anybody's notice. The day before yesterday, as a company director was passing by, he discovered his advertisement had been replaced by a digital canvass, describing successes of the government in the last four and a half years.

The baffled director called his advertisement agency, a top firm in the capital. The agency was surprised too. It did not know anything about the government's "success" billboard.

Nobody bothered to tell the agency or the realtor that

their billboard was going to be replaced. The ruling Awami League has suddenly gone on an aggressive campaign, flooding the city with such billboards highlighting various achievements of the government.

In the process, it has not cared to take permission of the advertisement agencies or the advertisers. It just grabbed the billboards wherever it chose to. It is an illegal act, but since it is in power, the party did not feel that it was illegal.

The agencies and the advertisers are too intimidated to challenge the AL.
